GMD 91/19 Minutes of Glenties Municipal District Meetings

On the proposal of Cllr. McGarvey, seconded by Cllr. Molloy, the minutes of the meeting of Glenties Municipal District Committee held on (i) 8^{th} of October 2019 and

(ii) 25th of October 2019 (Budget) were confirmed.

GMD 92/19 Workshops

The Committee noted the reports from Workshops held on 2nd October, 4th October and 8th October 2019.

COMMUNITY DEVELOPMENT

GMD 93/19 Errigal Stakeholders Group

The Community Development Administrative Officer informed Members that a meeting of this group will be held at the month end with the Consultant, to discuss an implementation process for the new Errigal Integrated Management Plan.

GMD 94/19 <u>Public Participation Network (PPN)</u>

The Community Development Administrative Officer updated Members on the ongoing work and functioning of the PPN, with 54 representatives on 22 different Committees and structures.

GMD 95/19 Rannóg na Gaeilge

The Committee welcomed ongoing promotion of the Irish Language through Gaelfit activities and Irish Language classes (TEG).

GMD 96/19 <u>Intergenerational Project</u>

Members noted (i) the launch of the YOURS Project (Youth & Old, Understanding, Remembering and Sharing) on the 9th of October in the County Museum and (ii) ongoing activities of the Intergenerational chair.

GMD 97/19 <u>Donegal Youth Council</u>

The Committee welcomed the extensive report issued with the agenda and presented by the Community Development Administrative Officer regarding the attendance of the Youth Council at four recent meetings and their representation on various Committees and Working Groups.

Cllr. McGarvey commended the variety of activities and the excellent representation by Youth Councillors.

Cllr. Ó Fearraigh praised the Youth Council for their contribution to the success of the Annual Road Show to promote road safety.

GMD 98/19 IPB Pride of Place 2019

The Committee noted that Falcarragh Parish Development and Destination Dungloe Development Group were among four Donegal recipients of local Pride of Place Awards and that they will now go forward to the National Pride of Place Awards in Kilkenny on the 30th November.

GMD 99/19 Project Officer

Cllr. Gallagher requested the assignment of a Project Officer to the Economic Development Section in the Dungloe Public Services Centre and hoped that this issue will be addressed in the forthcoming budget.

GMD 100/19 Playgrounds

Cllr. Mac Giolla Easbuig requested the Council to takeover playgrounds that are not currently controlled by the Local Authority. The Community Development Administrative Officer informed the Committee that lands need to be transferred to Council ownership and the necessity for weekly inspections and annual maintenance of facilities to acquire insurance cover.

GMD 101/19 <u>Development Fund Initiative</u>

The Community Development Administrative Officer updated the Committee regarding the status of the 2020 DFI Scheme.

Cllr. Ó Fearraigh recommended that a Workshop be convened to outline the operation of the scheme particularly for new Members of the Council, and also stressed the necessity to streamline the restrictive nature of the process of drawing down monies.

Cllr. Gallagher recommended that difficulties regarding the operation of the DFI Scheme be referred to Liam Ward, Director with responsibility for the relevant SPC.

GMD 102/19 Staff

In response to respective queries from Cllr. Gallagher and Cllr. Mac Giolla Easbuig, the Community Development Manager advised that he was unaware of the status of the engineering vacancy in relation to the Greenway Project and that the Gaeltacht Tourism Officer was working under the management of the Economic Development Division.

ENVIRONMENT

GMD 103/19 <u>Donegal Mens Shed Showcase</u>

The Committee commended the success of the Showcase event held in Castlefinn on the 23rd of October as part of 'Reuse' month.

GMD 104/19 National Reuse Month October

The Committee welcomed the report issued with the agenda from the Waste Awareness Officer regarding the success of the campaign to donate unwanted bicycles for the benefit of African secondary school students.

Members also noted the success of the fashion upcycling event in Dungloe and Cllr. Gallagher attended and commended the basic bike maintenance workshop held in Dungloe.

GMD 105/19 WEEE Collections

The Committee welcomed the report issued with the agenda from the Waste Awareness Officer regarding the collection of 8000kg of electronic and electrical waste in Falcarragh on the 5^{th} of October.

GMD 106/19 <u>Illegal Dumping</u>

Cllr. Mac Giolla Easbuig requested a report from the Council on actions undertaken to tackle illegal dumping on Arranmore and at the Glen (An Gleann) in Gaoth Dobhair near the Pobalscoil. The Director of the Environment Service undertook to obtain a report on this matter and informed Members that the Council are obliged to retain a record of all environment complaints submitted.

GMD 107/19 Recycling Centres

Cllr. Mac Giolla Easbuig and Cllr. Gallagher expressed disappointment at the intention of the Council to continue with the current privatisation model for the operation of recycling centres.

Cllr. Mac Giolla Easbuig requested an end to the privatisation of recycling services and the abandonment of ongoing neo-liberalist policies resulting in the outsourcing of public services.

Cllr. Gallagher requested the location of recycling facilities outside the Dungloe facility to accommodate the public at all times and to provide additional centres throughout Donegal.

The Director of the Environment Service informed Members (i) of the inability of the Council to provide a recycling service and the staffing restrictions imposed at Departmental level, (ii) of the ability of the Council to obtain value for money via the tendering process (iii) that he will take cognisance of the current limitations of service provision during tendering and (iv) that he will update Members on contract amendments at the next meeting.

Cllr. Molloy requested the Council to expedite the provision of recycling bins in Leitirmacaward and the Environment Director undertook to update the Councillors on identification of a site suitable for locals and the Council.

GMD 108/19 Port Arthur Access

Members welcomed the report in relation to the proposed selection of a preferred bidder to advance access improvement works.

GMD 109/19 Carrickfinn Car Park

The Committee commended the completion of Car Park improvement works at Carrickfinn Beach and the protection of dunes.

GMD 110/19 Beach Mapping

Cllr. Gallagher requested the advancement of the excellent work carried out by Daragh McDonough in relation to a Beach Mapping application in the County and recommended the scheduling of a Public Workshop at which locals could inform officials in respect of colloquial place names for certain locations.

GMD 111/19 Coastal Flooding and Erosion Risk Management

Members discussed the report issued with the agenda and presented by the Environment Director regarding the appointment of a consultant to conduct the Inishfree Bay and Gweebarra Bay Coastal Flooding and Erosion Risk Management Study.

In response to a request from Cllr. Mac Giolla Easbuig to include the Magheragallen coastal area in this study, the Environment Director undertook to liaise with relevant officials.

Cllr. Ó Fearraigh requested an update on the Magheroarty coastal protection pilot study and requested the inclusion of the Cotteen area along with Magheragallen in the proposed study.

GMD 112/19 <u>Magheroarty Rescue</u>

Cllr. Mac Giolla Easbuig asked for an update on a previous request from the Committee to host a civic reception in Lifford to recognise the heroic acts of bravery by rescue personnel involved in the emergency response to difficulties experienced by 15 staff and students in the waters off Magheroarty Beach during August.

GMD 113/19 Braade Beach

Cllr. Mac Giolla Easbuig requested that the outcome of the investigation into suspected pollution at Braade Beach be made public.

GMD 114/19 Drumnatinney Beach

Cllr. McClafferty welcomed the report presented by the Environment Director in relation to the repair of the Car Park surface and proposals for development of an outdoor shower and rinse tap. Cllr. McClafferty also requested the installation of defibrillators at busier beaches, the provision of public conveniences at Drumnatinney and Kilahooley beaches and additional wheelchair friendly access to more beaches throughout the County.

GMD 115/19 Arranmore Public Convenience

The Committee welcomed the report from the Coastal Officer regarding selection of a preferred bidder to advance necessary upgrading of this Island facility.

GMD 116/19 Irish Water

Cllr. Gallagher (i) expressed frustration due to continuing problems arising at Waste Water treatment facilities and the inability of Irish Water to engage in meaningful consultation with local communities, (ii) requested that Irish Water be itemised on the Agenda of all future meetings, (iii) asked for certainty in relation to retention of Water Service staff locally, (iv) requested that the Council revisit the Service Level Agreement in the context of the Budgetary process.

Cllr. Gallagher highlighted ongoing issues with water connections, sewage connections and capital schemes resulting in a negative impact on both the public and businesses.

The Environment Director acknowledged the concerns of the Committee in relation to Irish Water and undertook to seek the attendance of Irish Water officials at a Municipal District meeting.

Members were also informed of major investment and infrastructural developments by Irish Water across the Municipal District.

Cllr. Mac Giolla Easbuig informed the meeting of the necessity for major sewage investment in Annagry Parish.

GMD 117/19 <u>Dog Fouling</u>

In response to expressed by Cllr. McClafferty regarding the extent of dog fouling, the Environment Director agreed to circulate a response at the next Municipal District meeting.

PLANNING SERVICES

GMD 118/19 <u>Development Applications</u>

The Committee noted the report presented by the Senior Planner regarding statistics for the year to 31st October 2019.

GMD 119/19 Enforcement

Members noted the status of enforcement cases progressing in the Glenties Municipal District.

GMD 120/19 Planning Clinics

Members welcomed the scheduling of planning clinics on the 20th November and 11th December 2019.

GMD 121/19 <u>Central Planning Unit</u>

The Committee noted the report issued with the agenda and presented by the Senior Planner regarding ongoing work programmes within the Central Planning Unit.

GMD 122/19 Rural Regeneration and Development Fund

The Committee welcomed the recent announcement of funding in excess of $\ensuremath{\in} 3$ million for the delivery of improved infrastructure at Burtonport Harbour along with shorefront amenities on Arranmore to enhance the relationship between the Island and mainland.

Cllr. Gallagher requested the scheduling of a Public meeting in Dungloe in the context of the proposed rural regeneration plan for the town and also recommended that Road Design prioritise a traffic management plan for Dungloe. Cllr. Gallagher also asked that a meeting with Members be convened to discuss this regeneration project.

GMD 123/19 Annagry Parochial House

Cllr. Mac Giolla Easbuig asked to be updated in relation to the status of an application to demolish this property.

GMD 124/19 County Development Plan

Cllr. McClafferty asked the Planning Service to exhaust all possibilities prior to issuing refusals in respect of applications from indigenous members of local communities seeking to build on family lands.

The Senior Planner informed Members that any permission granted along the N56 have been successfully appealed by An Bord Pleanala on the grounds of intensification of use of existing access and that agents have been notified in this regard to facilitate the provision of informed advisory services to their clients. Cllr. Gallagher stressed the necessity for a review of rural housing policies within the County Development Plan.

GMD 125/19 Planning Staff

Cllr. Gallagher and Cllr. Ó Fearraigh requested the Planning Service to decentralise to provide an enhanced service to Members, applicants and the general public.

The Senior Planner informed the Committee of ongoing recruitment and the expectation that a planner will be in attendance at all future Municipal District meetings.

ROADS & TRANSPORTATION

GMD 126/19 Roadworks Programme

The Roads Manager updated the Committee on the status of the 2019 Roadworks Programme which is due to be completed at the end of November. Members were advised of ongoing preparatory works on Arranmore in respect of the recently announced An Roinn Island grant allocation.

GMD 127/19 Workshop

The Committee agreed to convene a Workshop at 10 a.m. on the 16th of January 2020 to determine the level of service to be provided in 2020.

GMD 128/19 Bridge Maintenance

Cllr. Molloy highlighted the necessity to repair dangerous bridges at Ballyiriston and Straboy.

Cllr. McClafferty hoghlighted (1) the state of the Faymore Bridge at Creeslough and Carrick-na-Nee bridge at Moyra, Falcarragh, (2) necessity to raise manholes on Falcarragh Main Street, (3) excess surface water outside Falcarragh National School.

In response to a recommendation from Cllr. Gallagher to expedite safety works at the 3 bridges on the R252 between Meenaroy and Glenswilly, the Roads Manager advised that these works are being prioritised by the Letterkenny Municipal District via applications for funding.

GMD 129/19 Road Safety

Cllr. Molloy informed the Committee of road safety issues on the Wood Road, Ardara, and the necessity to upgrade the access to Narin Pier in light of a major rowing event scheduled in 2020 at this location.

Cllr. Ó Fearraigh requested an update in relation to serious accidents in Fintown and Bunbeg.

Cllr. McGarvey highlighted ongoing safety concerns at the Gweedore/Carnmore Road Junction in Dungloe and requested the Council to also explore the possibility of widening the Carnmore Road/Main Street Junction in light of the sale of an adjoining property.

Cllr. McGarvey outlined the necessity for Public Lighting across from the Viking Hotel on the road to Cruit.

Cllr. Mac Giolla Easbuig outlined poor vision lines at (i) Loch na nDeoran, (ii) Kincasslagh/Cruit Junction, (iii) the necessity to widen Mines Road and (iv) the road to Bunbeg Pier.

The Roads Manager undertook to relay road safety issues to the Road Safety Engineer.

GMD 130/19 Gritting Programme

On the proposal of Cllr. Molloy, seconded by Cllr. Mac Giolla Easbuig, the Committee recommended that a Workshop be held to discuss the gritting programme. Cllr. Mac Giolla Easbuig requested the provision of salt for back roads in the Corveen, Carrick, Glassagh and Loop road near Gweedore Station.

The Roads Manager updated the Committee regarding (i) the willingness of the Roads Service to liaise with locals and to provide salt along the Gweedore Coast Road and (ii) scheduling of a Countywide Workshop on the Winter Maintenance Service.

GMD 131/19 Traffic Management Plan

In response to a query from Cllr. Gallagher regarding the importance of a traffic management plan for Dungloe, the Roads Manager advised that Road Design intend to have a report for the January workshop.

GMD 132/19 Road Maintenance

Cllr. Mac Giolla Easbuig highlighted drainage concerns near Dr. Brogan's house in Carrick and at Tully Bridge, Dungloe.

GMD 133/19 <u>Pedestrian Crossing, Carnmore Road, Dungloe</u>

Cllr. Mac Giolla Easbuig stressed the necessity for a pedestrian crossing at Chapel Lane. Cllr. Gallagher requested the provision of red tar and lining in the absence of funding from TII.

GMD 134/19 <u>Cycle Lane - N56</u>

In response to a query from Cllr. Gallagher, the Roads Manager advised that the NRDO are aware of the necessity to upgrade the cycle lane.

GMD 135/19 Gola Island

Cllr. Mac Giolla Easbuig expressed disappointment at the inability of the Council to provide 5 drainage pipes on Gola to complement the voluntary work carried out to repair the roadway on the Island. The Roads Manager

outlined the ineligibility of funding to be spent on non county roads but stated that an application to An Roinn will be made to fund the necessary works.

GMD 136/19 Lay Byes

In response to a query from Cllr. McClafferty to provide additional lay byes on the Horn Head Road, the Roads Manager stated that land would be required along with approval of National Parks & Wildlife Service due to the status of this location as a Special Area of Conservation.

Cllr. Gallagher requested additional lay byes and prioritisation of the Falmore, Meenacross Tubberkeen road for investment over the next 5 years.

HOUSING AND CORPORATE

GMD 137/19 **Grants**

The Committee discussed the reports issued with the agenda in relation to the status of grant schemes as at the 5^{th} of November 2019.

Cllr. Gallagher commended the operation of the Housing Aid for Older People Grant Scheme but outlined the need for revision of both the Housing Adaptation and Mobility Aids grant schemes.

GMD 138/19 <u>Casual Vacancies</u>

The Committee welcomed the report presented by the Housing Manager in relation to the current status of 14 no. casual vacancies as at the 5^{th} of November 2019.

GMD 139/19 Tenant Purchase (Incremental) Scheme

The Committee discussed the detailed report issued with the agenda and presented by the Housing Manager in relation to applications received since inception to the 5^{th} of November 2019.

Cllr. Molloy highlighted the restrictive criteria pertaining to the scheme in its current format which was acknowledged by the Housing Manager, who advised that a report is with the Housing Minister following a national review.

GMD 140/19 Clós Naomh Conaill

The Housing Manager updated the Committee in relation to the tender validation process to appoint a Contractor to carry out a 120 meter storm drain replacement in this location.

GMD 141/19 Capital Programme

Cllr. Gallagher requested the attendance of Housing Capital officials to update Members on their proposals to address housing need in the Municipal District.

In response to a query from Cllr. Mac Giolla Easbuig, the Housing Manager clarified that the Council have not entered negotiations with a Developer who has approached the Council with houses for sale in the Annagry area.

GMD 142/19 Housing Maintenance

In response to a query from Cllr. McGarvey regarding the adequacy of the maintenance budget, the Housing Manager clarified that emergency and essential repairs are currently being prioritised with a carry-over of routine works to the New Year. Cllr. Mac Giolla Easbuig requested the Housing Service to address surface water outside houses on the Cois Cuain Estate, Cotteen.

GMD 143/19 HAP Scheme

In response to a suggestion from Cllr. McClafferty that certain landlords are not providing accommodation to HAP recipients, the Housing Manager advised that landlords cannot discriminate against prospective tenants in receipt of Housing Assistance payments. The Housing Manager further advised that the Residential Tenancy

Board have a statutory responsibility to assist tenants via a dispute resolution process.

GMD 144/19 Housing (Standards for Rented Houses) Regulations

Cllr. Gallagher recommended that the Council initiate a complete audit of deficiencies in Council Housing stock in light of Council activity in the imposition of minimum standards on private landlords. The Housing Manager clarified that (i) the Housing Authority has a statutory responsibility to ensure that landlords of all rented housing meet certain minimum standards and (ii) inspection targets are set annually by the Housing Department in this regard, (iii) Council have a rolling programme to upgrade Council Housing stock and (iv) a survey is being worked on by Director of Housing.

GMD 145/19 SI Housing

Cllr. Mac Giolla Easbuig asked that the Council repair roads to SI houses and the Housing Manager clarified that this matter is an issue for the Housing SPC to amend current policy.

Cllr. Gallagher recommended that a special case be made to the Department for additional SI provision.

GMD 146/19 Provision of Sheds

In response to a query from Cllr. Mac Giolla Easbuig regarding the provision of sheds at local authority houses, the Housing Manager clarified that sheds are only provided when departmental funds are available to upgrade units.

GMD 147/19 Changing places

Niamh Walsh, Phd Researcher at University of Ulster made a presentation to the Committee in relation to the Changing Places Ireland agenda. Members were advised that the aim of the campaign is to promote the provision of fully accessible toilets in public places. Changing Places facilities are designed to enhance the health, safety and dignity of people who need extra support and additional equipment during personal care tasks.

Ms. Walsh (i) informed the Committee of logistical difficulties experienced by local families who have to leave this jurisdiction to avail of necessary toilet facilities in the 6 Counties, (ii) challenged the Council to pursue and promote the 'Changing Places' campaign in Donegal and (iii) to strive for standards greater than the 'bare minimum'.

The Committee commended the presentation and highlighted the necessity to amend the County Development Plan to incorporate this agenda into Council policies, plans and actions.

We had Fiona Boyle and Merisa McGettigan from the Smoking Sensation Service to talk about the effects of smoking and what enforcements need to be made within the community to reduce the temptation for young people. 21/09/2019 - During this meeting DYC members gave an update on meeting that were attended and upcoming events. DYC members decided on roles for members on the day of the AGM. Sinead from Break out will performed a work shop with DYC members to create a greater awareness of the LGBT community. 29/10/2019 - During this meeting DYC members gave an update on meeting that were attended. Lisa O'Hagan from the HSE and Eilish McArt from the Eylash clinic completed a workshop with the DYC members around STI's as there is an increase of STI's within young people of their age group and wanted to gain more knowledge to create a campaign in the new year. 08/10/2019 - The Glenties Municipal District presented to the Councillors on their work to date. The Youth Council received great
	support and recognition for their work. Regional meetings take place on a monthly basis. Representation on the following Committees; Road Safety Working Group Donegal Youth Council members have attended monthly meetings with the Road Safety Working Group. On the 8th and 9th of October Donegal Youth Council members assisted in the facilitation of the Annual Road Show to promote Road Safety.

CYPSC

Anne Timony Meehan attended the DYC monthly meeting on the 29/10/2019. Three Donegal Youth Council members have completed a short video focusing on the importance of being included in Society. They choose to discuss three different areas. They are as follows; being included in the education system, being included in employment and as a sibling looking on for her younger sister and how the public should act.

This video will be shown at the Inclusive Training Careers and Lifestyle Fair on the 16th of November. Also a number of Donegal Youth Council members will be facilitating on the day.

On the 26th of September Donegal Youth Council members gave a presentation to CYPSC a presentation on their work to date. This was a great opportunity for the different services to become aware of the Donegal Youth council's work to date and extended support was offered as a result.

Paddy explained that the last ETB meeting was cancelled and that a date was not given for the next one. Paddy agreed that there are seats there for DYC members and that he will contact once a date has been given to invite DYC members along.

Regional/National Events

On the 6th of September Donegal Youth Council Members were involved in the HPV Campaign. During this process Donegal Youth Council members were involved in a briefing which was delivered by Pauline Gallagher from the HSE Area Medical Officer. The following information was published in the Donegal News Paper; "#ProtectOurFuture On Tuesday, August 27th the HSE launched the 2019/20 schools HPV vaccine programme. The HPV vaccine is now being given to all first year students in secondary school, including girls and, for the first time, boys. HPV is a virus that can cause cervical cancer, and other cancers in both women and men. The HPV vaccine will protect young people from HPV related cancers when they grow up. The uptake of the HPV vaccine has a participation rate of approximately 70%, which is an increase of 20% points since 2017. Back in 2008, the Donegal Youth Council of the time campaigned for the rollout of the HPV Vaccination for girls. The current Donegal Youth

Council is keen to support this important work by encouraging young people to 'get the facts', which is one of the key messages of the HPV campaign. In preparation for this, a sub-group of youth councillors, met with the HSE Area Medical Officer for a briefing on the virus, the importance of the HPV vaccination and the schools programme. The sub-group were able to ask questions so they are well informed. When asked what messages they took from the session, one Youth Councillor said, "know where your information is coming from and get the facts" while another commented "the vaccine is free and it can change your life." The next steps will be for the Youth Council to promote the key messages, to their followers via their instagram and twitter accounts, throughout the rollout of the school's programme, and also through discussions with their families and friends. The Donegal Youth Council is one of 31 Comhairle na nÓg's throughout the country, so their message will be wide-reaching. The sub group will report back to the wider Youth Council at their

The sub group will report back to the wider Youth Council at their next county-wide meeting. However, in the meantime, all youth councillors have received information on the campaign.

With high uptake of the HPV vaccine there is the potential to save 112 lives each year by preventing the most common strains of HPV that cause cervical cancer and other cancers. The HPV vaccine now protects against 9 out of 10 HPV cancers. The HPV virus can cause cancers and conditions that can affect boys too, making it extremely important for all young people to get the vaccine. This year Ireland will join over 20 other countries including the UK in giving HPV vaccine to boys and girls in 1st year of secondary school.

The vaccine is endorsed by major medical and scientific bodies worldwide including the World Health Organization, the Centres for Disease Control in the USA, the EU funded European Centre for Disease Control and Prevention, and the International Federation of Obstetricians and Gynaecologists.

 On the 7th of October Donegal Youth Council were involved in the #mywee5 campaign in partnership with Jigsaw. Through this week they got members of different services involved in the promotion of this campaign. The aim of the campaign is to promote positive mental health by showing everyone some simple things they can do to help improve their mental wellbeing through the FIVE-A-DAY. They include CONNECT, BE ACTIVE, TAKE NOTICE, GET INVOLVED and GIVE!



 Donegal Youth Council members have been sitting on the LCAPP steering committee. On the 30th of September Letterkenny Community Action on Alcohol in partnership with the Alcohol Forum held an Awards night for work that has been complete by individuals or groups in the community to raise an awareness of the effects of Alcohol. Our Donegal Youth Council Mayor Grainne McGlynn accepted an award on behalf of Donegal Youth Council for recognition of their work.





On the 4th of October Donegal Youth Council Members attended the Connecting for Life Seminar in the Central Hotel Donegal town. At this event they launched their video called "What's your relationship with Alcohol". This video displayed the effects of alcohol within young people and not being able to connect the emotions with feelings. Also members co-facilitated a workshop on the day to gather information on a way forward to tackle the issues relating to Alcohol in their community.





 Donegal Youth Council members were involved in Enact the Act in the Buswell Hotel in Dublin on the 18/10/2019. During this Donegal Youth Council members were interviewed by TodayFM, i104FM and News Talk. Highland Radio also wrote an article on the Donegal Youth Council's actions and interview. The speech that was read out on the day by one of the Donegal Youth Council members is as follows;

What the alcohol enact means to Young People from the West of Ireland

"Good afternoon, my name is Amylee and I am part of Donegal Youth Council and I am here to tell you what the alcohol act means to young people from the west of Ireland. This act means protecting our future, it means protecting our children, our families and our communities from harm.

It means creating an environment that supports a low risk approach to alcohol consumption. It also means that the next generation don't have to grow up in a society where it is known that alcohol is having a massive negative impact on them and their well-being.

Our children, our families and our communities will thank our officials and government ministers who are determined to save our lives and their lives in the future by enforcing the act. I think that this act is very important because I personally feel that for my age or younger, to walk into our local shops and see alcohol displayed so openly is upsetting. This also applies to posters on shop windows advertising alcohol for sale. I find it disturbing that there is significantly more promotion of alcohol than there is for positive mental health. When you consider the negative effect that alcohol has on mental health, you realize that something needs to be done to discourage this type of behaviour, that's why this act is so important. Alcohol has always been an accepted part of Irish culture, and the fact that society knows more about the price of alcohol than it does about mental health issues, is no longer an acceptable social norm. Is this the type of society we want our young people to grow up in? More needs to be done to discourage young people from drinking and to break the widespread reputation that Ireland is a drinking nation. More must also be done to educate young people on the physical and mental negative effects of alcohol. It is not a personal issue, it effects families and communities.

I am asking everyone here today to show how negative alcohol can be instead, of glamourizing it.

Our journey started from scratch making this video. We wanted to create visual imagery that would capture the effects of alcohol use within young people and the effects that follow.

This was completed by storyboarding our ideas, to scripting and filming and getting the end result that you will see here today. Through the process we did not have to use our imagination as these are situations that are happening on a daily basis and can quickly escalate.

There are hidden messages throughout the video that you will have to watch more than once to grasp. We hope that this shows

the impact of not being able to control and understand emotions and as a result act in a certain way to help numb the feelings.



1. N56 Kilkenny Letterilly

Fox Contracts are continuing construction and are almost complete. It is expected that the Works will be completed in Q1 this year.

2. N56 Dungloe to Cloghbolie

Barry Transportation has completed the detailed design and Tender Documentation for the N56 Dungloe to Cloghbolie Scheme. This scheme was tendered on 06th September 2019, tenders were returned on 25th October and the tenders are now being assessed. It is expected that the Contract will be awarded and Construction will commence in Q1 2020.

3. N56 Letterilly to Glenties (Kilraine)

RPS Consulting Engineers are progressing the detailed design and Tender Documentation for the N56 Letterilly to Glenties (Kilraine) Scheme. The first section of this scheme from Letterilly to Glenties will be tendered in Q1 2020 with construction scheduled for Q2 2020. The section from Glenties to Kilraine will be tendered separately in Q2 2020 with construction commencing in Q3 2020.

4. N56 Dungle to Glenties - Land Acquisition

Close out of the remaining Land Acquisitions will be completed by the end of the year, although a small number of the remaining cases will possibly be referred to arbitration.
