MINUTES OF THE INISHOWEN MUNICIPAL DISTRICT MEETING HELD ON TUESDAY 16th January 2024 AT 2.00pm IN CARNDONAGH PUBLIC SERVICE CENTRE

Councillors Present:

Cllrs Paul Canning (online), Nicholas Crossan, Terry Crossan, Albert Doherty, Rena Donaghey, Martin Farren, Martin McDermott, Johnny McGuinness (online) and Jack Murray (online).

Officials Present:

Bryan Cannon, Director of Service Roads & Transportation, Una Cresswell, A/Area Manager, Housing & Corporate Services, Dolores Lafferty, A/Senior Staff Officer, Housing & Corporate Services, Michael McFadden, A/Senior Executive Engineer, Roads and Transportation, Elaine Harley, Executive Architect, Housing Capital, Fiona Doherty, Development Officer, Community & Enterprise, Ryan Nolan, Executive Planner, Matthew Byrne, Waste Regulation Officer (online), Philip O'Kennedy, Business Advisor, Local Enterprise office (online).

The meeting was opened by the Cathaoirleach, Cllr Terry Crossan who welcomed all to the meeting.

24.01 Expression of Sympathy

As requested by Cllr Terry Crossan, a minute's silence was observed in memory of Cllr Noreen McGarvey who sadly passed away.

Cllr Terry Crossan, on behalf of all the members of the Inishowen Municipal District also expressed condolences to Sinéad McLaughlin, Executive Librarian, on the death of her father, Mario Comiskey.

24.02 Consideration of the Minutes of the Meeting of Inishowen Municipal District held on 05th December 2023

On the proposal of Cllr Rena Donaghey, seconded by Cllr Martin Farren, the minutes of the Inishowen Municipal District Meeting held on 05th December 2023 were agreed.

24.03 PLANNING

Ryan Nolan, Executive Planner presented the planning report to the members, and it was taken as read.

24.03.01 Planning Applications

Ryan Nolan advised the members that the Inishowen Municipal District had the highest number of planning applications for 2023. He advised that Inishowen MD also had the highest number of invalid applications in Donegal.

Cllr Paul Canning requested that the electoral divisions map be updated on the Donegal County Council website.

24.03.02 Vacant Property - Inishowen

The members advised that they had received several queries from members of the public outlining concerns about a vacant property in the Inishowen area and its potential change of use in the future. A discussion took place around the suitability of the vacant property for alternative use and possible, potential planning irregularities. Ryan Nolan advised that he could not comment on individual cases. However, if there are any unauthorised works carried out at any property, this matter would be dealt with through Planning Enforcement.

20.03.03 IPAS (International Protection Accommodation Services)

The members expressed their frustration with the lack of information from IPAS regarding properties, sometimes suggested as unsuitable, being considered for refugee accommodation. Bryan Cannon advised and clarified that if a property is made available to house refugees the contract would be between the private property owner and the International Protection Accommodation Service (IPAS). As noted, any unauthorised works on such properties would be dealt with by Planning Enforcement.

24.03.04 Defective Concrete Blocks Grant Scheme

Cllr Martin McDermott raised concerns around the timeframe in obtaining a Certificate of Compliance with Planning Permission when applying for the Enhanced Defective Concrete Blocks Grant Scheme in certain cases. Ryan Nolan agreed to follow up on this matter.

Cllr Paul Canning highlighted the difficulty in obtaining plans/drawings for a dwelling if the owner had not made the original planning application. The original plans/ drawings can only be obtained from the Planning Office if consent is given from the original applicant. This is not always possible, and Cllr Canning requested that this consent be waivered in the cases when the applicant intend to rebuild under the Defective Concrete Blocks Grant Scheme.

24.03.05 Draft County Development Plan - Workshop

It was agreed that a Workshop be held on 30th January 2024 at 10am regarding the Draft County Development Plan.

24.03.06 Croi Conaithe Vacant Property Refurbishment Grant

Cllr Albert Doherty referred to the 125 Vacant Property Refurbishment Grant applications that were received for the Inishowen Municipal District area and requested that these applications be progressed. He expressed his gratitude to the team for the work that was carried out to date in relation to this scheme.

24.03.07 Tús Nua Project

Cllr Albert Doherty requested an update in relation to the Tús Nua Project.

24.04 ROADS AND TRANSPORTATION

Michael McFadden, A/Senior Executive Engineer, Roads and Transportation presented the report to the members, and it was taken as read.

24.04.01 Roads Programme 2024 - Workshops

It was agreed that workshops would be held on 30th January 2024 and 09th February 2024 in relation to the 2024 Roads Programme.

24.04.02 Inishowen Roads Team

The members acknowledged the huge amount of work that was completed by the Inishowen Roads team during 2023.

24.04.03 LIS/CIS

Michael McFadden requested that any applications under LIS/CIS should be submitted as soon as possible.

24.04.04 Battery Brae2, Greencastle

Cllr Martin Farren acknowledged the work that was carried out at Battery Brae, Greencastle.

24.04.05 Traffic Calming Measures

Cllr Martin Farren requested that traffic calming measures be put in place at the Moville/Greencastle Road.

24.04.06 Clar Corner, Redcastle

Cllr Martin Farren requested that traffic speed be monitored at Clar Corner, Redcastle.

24.04.07 Clar Bridge, Redcastle

Michael McFadden advised that the outlets at Clar Bridge were cleared following a request by Cllr Martin Farren.

24.04.08 Mill Bridge, Buncrana

Cllr Rena Donaghey highlighted her concern regarding the Mill Bridge in Buncrana and requested that a solution be found as soon as possible.

24.04.09 Glentogher Road, Carndonagh

Cllr Martin McDermott referred to funding for the Glentogher Road, Carndonagh as outlined at previous meetings and asked that this be followed up.

24.04.10 Francistown Junction, Malin

Cllr Martin McDermott referred to Francistown Junction as discussed at previous meetings. He asked that this matter be followed up and progressed and a solution be found.

24.04.11 Car Parking Facilities at Wild Alpaca Way, Malin Head

Cllr Albert Doherty requested that car parking facilities be provided at Wild Alpaca Way, Malin Head.

24.04.12 Footbridge, Culdaff

Cllr Johnny McGuinness requested an update regarding the provision of the footbridge in Culdaff.

24.04.13 Tooban/Fahan Road

Cllr Jack Murray requested an update regarding the provision of a crossing at Tooban/Fahan Road.

24.04.14 McCarter's Road, Buncrana

Cllr Jack Murray requested that appropriate measures be put in place at McCarter's Road, Buncrana to allow pedestrians to cross the road safely.

24.04.15 Winter Maintenance

Cllr Rena Donaghey requested that St Joseph's Nations School, Illies, Buncrana be included in the Winter Maintenance Programme. She stated that there is a water treatment plant close to this school and suggested that contact be made with Irish Water requesting that they also assist with gritting the road. Cllr Martin McDermott concurred with these comments. Michael McFadden agreed to follow up with Irish Water.

24.04.16 Infrastructural Fund

Following a request from Cllr Paul Canning, Michael McFadden agreed to update him on the Infrastructural Fund that is available to members.

24.04.17 Donagh Park, Carndonagh

Cllr Albert Doherty thanked Michael McFadden and his team in relation to assistance that was provided at Donagh Park recently.

24.05 ECONOMIC DEVELOPMENT

Philip O'Kennedy, Business Advisor, Local Enterprise office, presented the report, and it was taken as read. He highlighted the following items from the report –

- Holiday World Show 2024 Event taking place in RDS 26th to 28th January 2024.
- New Tourism Brochure 2024
- Event in London Irish Centre on 08th February Packie Bonner and Shay Given will be promoting the relocation campaign and employment opportunities in the County.
- Six events will take place in 2024/205 aimed at connecting SMEs with International buyers with the first event taking place on 31st January 2024 which will focus on Food and Nutrition and the second event will take place on 09th February 2024 which will focus on Construction, Engineering and Sustainable Energy.

24.05.01 Tourism - Workshop

Philip O'Kennedy requested a date for a workshop with the members during the first quarter of 2024. The date of this workshop is to be confirmed.

24.05.02 Local Enterprise Office

Cllr Nicholas Crossan requested a report on the benefits of the different events organised by the Local Enterprise Office, that take place as outlined in the report.

24.05.03 Relocation Marketing Campaign

Cllr Albert Doherty referred to the high interest in the #MoveToDonegal campaign as outlined in the report and asked if there were adequate housing, healthcare, education and transport in Donegal to support this campaign.

24.05.04 Golf Tourism

Cllr Albert Doherty referred to the Golf Cluster Meetings that take place as outlined in the report and raised issues with coastal erosion and the effect on our golf clubs and beeches and asked that these issues be considered.

24.05.05 Grianán of Aileach

Cllr Jack Murray queried the opening hours of Grianán of Aileach and the importance to Donegal tourism to have this attraction open to the public. He requested that this matter be followed up with the OPW. The members concurred with these comments. Cllr Paul Canning requested a meeting with the OPW in this regard.

24.05.06 Ballyliffin Golf Club

Cllr Martin McDermott referred to the R&A Amateur Championship which will take place at Ballyliffin Golf Club in June 2024 for two weeks. He advised that this will be an excellent opportunity to promote

Donegal. He requested that Donegal Tourism and Go Visit Inishowen contact Ballyliffin Golf Club in order to make the most of this opportunity.

24.05.07 Regional Festival & Events Grant Scheme

Cllr Nicholas Crossan queried if the Regional Festival & Events Grant Scheme was closed for applications.

24.05.08 Tourism - Inishowen

Cllr Johnny McGuinness raised concerns around the lack of bed nights available in Inishowen which was having a detrimental effect to the tourism sector. He said that this has led to a reliance on day trippers to Inishowen and outlined the need to have our tourist attractions fully supported. He outlined the negative effect on businesses throughout Inishowen and asked that these concerns be addressed. He requested a meeting with Fáilte Ireland and Donegal Tourism.

24.06 ENVIRONMENT

Matthew Byrne, Waste Regulation Officer presented the report, and it was taken as read. He highlighted the following items from the report –

- Climate Action Plan Pack will issue to all members in relation to the CAP in mid-January which will allow time for members to review prior to the adoption of the CAP at the Plenary meeting on 21st February 2024.
- Community Climate Action Fund Public information session will be held in the Public Service Centre, Carndonagh on 23rd January from 7-8pm. The closing date for applications will be 22nd March 2024.
- Deposit Return Scheme Commencement date 01st February 2024. Any queries can be referred to Environment Section.

24.06.01 Jet Skis, Moville Beaches

Cllr Martin Farren expressed his disappointment that the Jet Ski signs that were erected at Glenburnie Beach and Sweet Nellie's Beach were removed again. He requested that this matter be investigated further and a solution be found.

24.06.02 Lifeguard Provision at Beaches

Cllr Martin Farren asked that he be kept up to date on the provision of lifeguards during the summer period.

24.06.03 Buncrana Anglers Association

Cllr Jack Murray requested that Buncrana Anglers Association be provided with additional resources in the provision of public amenities in the area. Cllr Terry Crossan concurred with these comments.

24.06.04 Public Conveniences

Cllr Johnny McGuinness acknowledged the provision of temporary public convenience facilities at Culdaff Beach over the Christmas period. He requested that a more permanent solution be found for the area and suggested converting the existing structure that was already there. Cllr Nicholas Crossan also queried if there was any progress in the provision of public conveniences at Ned's Point.

Cllr Nicholas Crossan and Cllr Rena Donaghey thanked Pearse McCrory, Litter Warden for his prompt action in the removal of rubbish from the Crana River over the Christmas period.

24.07 COMMUNITY DEVELOPMENT

Fiona Doherty presented the report, and it was taken as read.

24.07.01 Clár Funding

Fiona Doherty updated members that Carrowmenagh Community Centre, Malin GAA and Gleneely Colts recently received Clár Funding.

Cllr Albert Doherty requested a letter be issued from Inishowen MD to Minister Humphreys in relation to the inclusion of additional areas to the Clár Programme following the recently published Pobal HP Deprivation index where the number of people living in area classed as very or extremely disadvantaged has increased from 143,506 individuals to 195,992. Cllr Rena Donaghey and Cllr Terry Crossan concurred with these comments.

24.07.02 Capital Projects

Fiona Doherty updated members on the completed projects in 2023 as outlined in the report. She thanked the members and community groups for their support in the delivery of the projects. She also highlighted the upcoming Capital Projects that will be completed and progressed in 2024.

Cllr Martin Farren thanked Fiona Doherty and the team for the work carried out in 2023.

24.07.03 Development Fund Initiative 2024

Fiona Doherty advised members that the closing date for receipt of completed applications under the Development Fund Initiative 2024 is 4pm on Friday 02nd February 2024.

24.07.04 Workshops

The members agreed the following workshop will take place on 23rd February 2024 -

- Development Fund Initiative at 10am
- Local Economic Community Plan will take place directly after.

24.07.05 Pride of Place Awards

Cllr Albert Doherty congratulated Carndonagh Traders Association in winning the IPB Pride of Place Award in category population 1500-4000. He thanked Fiona Doherty for the support and assistance she provided to Carndonagh Traders Association.

24.07.06 Friar Hegarty's Coastal walk, Buncrana

Cllr Terry Crossan welcomed the update in regarding Friar Hegarty's Costal Walk, Buncrana. Fiona Doherty advised that she would meet with members in relation to proposed works.

24.07.07 Repowering Buncrana

Cllr Nicholas Crossan requested an update in relation to Repowering Buncrana. Fiona Doherty agreed to follow up with Patricia McIntyre.

24.07.08 Muff Féile Group

Cllr Terry Crossan thanked Fiona Doherty for meeting with the newly formed Muff Féile Group.

24.07.09 Malin Head Visitor Management Plan

Fiona Doherty advised members that Community Development directorate are working on a roadmap/timeline for the advancement of the Malin Head Visitor Management Plan as advised at the workshop meeting held on the 28th of November 2023.

24.08 HOUSING & CORPORATE SERVICES

Una Cresswell, A/Area Manager, presented the Housing and Corporate report, and it was taken as read. She welcomed Elaine Harley, Executive Architect, Housing Capital, to the meeting.

24.08.01 Social Housing Developments

Cllr Nicholas Crossan welcomed the report in relation to the provision of social housing in the Inishowen Municipal District. Cllr Rena Donaghey raised concerns around lack of suitable land in the Buncrana area for future Social Housing developments. Cllr Jack Murray concurred with these comments. Elaine Harley advised that the land team continue to identify further land parcels across the Inishowen Municipal District area and assess their suitability for social housing. Una Cresswell advised of the huge demand for Social Housing in the Buncrana area and stated that the Council continue to strive to find solutions to increase housing supply.

24.08.02 Social Housing through Turnkey Acquisition

Following a query raised by Cllr Albert Doherty in relation to potential turnkey acquisition at Carndonagh, Elaine Harley advised that the Council has made an increased offer to the Developer for the acquisition of the units.

24.08.03 Specific Instance Housing (SI)

Cllr Martin McDermott requested an update on the progress of delivering SI properties to those qualified on the housing list within the Inishowen MD area. Una Cresswell advised that the process is ongoing, and applications are progressing.

24.08.04 Defective Concrete Blocks

Cllr Martin McDermott requested an update in relation to the remediation of social housing stock. Una Cresswell agreed to follow up.

Martin McDermott also stated that he wanted to clarify the building regulations were the same for both private and social houses.

24.08.05 Homeless Accommodation

Following a query from Cllr Albert Doherty, Una Cresswell outlined the emergency accommodation options which may be available in certain situations. She outlined the need for more focused homeless accommodation for people that find themselves in extremely difficult circumstances.

24.08.06 Deputation Go Visit Inishowen

Una Cresswell advised that a request has been received from Go Visit Inishowen for a deputation with members. It was agreed by the members that a deputation would take place at the next Inishowen Municipal District meeting on 26th February 2024.

Members were asked to consider the request that was circulated to them on 15th January 2024 by Michael McFadden, Senior Executive Engineer that Donegal County Council proposes to lease various sites at Greencastle Harbour to entities associated with the Marine/Fishing Industry as outlined below.



1.0 Rural Regeneration and Development Fund (RRDF)

Funding is provided from the Department of Rural and Community Development and calls for application to the Fund are sought under two categories. **Category 1** relates to projects with all necessary planning and other consents in place and which are ready to proceed, i.e shovel ready. **Category 2** projects are those which require further development to become ready for Category 1 status.

1.1 Summary update of Projects

1.2 Fifth Call for Category 1 Projects (shovel ready) under the Rural Regeneration and Development Fund (RRDF).

In November 2023 a fifth call for Category 1 projects was announced. This is a competitive application process and Local Authorities can submit a maximum of 3 applications for large scale and ambitious in nature projects. The minimum request per project is €500,000 with no upper limit but projects seeking over €10m would be considered exceptional in nature.



In recognition of the classification by the EU Commission of the North West Region as a Transition Region, grant aid of 90% will apply with 10% to be provided in matching contributions by the Council – this 10% matching contribution can be in the form of Local Authority investment, community investment or philanthropic contributions.

The deadline for submission of applications is **12 pm on Tuesday 8th February 2024**. As confirmed to Elected Members at the November 2023 Plenary meeting of the Council, work is underway to bring forward applications for Regeneration Projects in Rathmullan and Creeslough under this Call.

2.0 Urban Regeneration and Development Fund (URDF).

Funding is provided from the Department of Housing, Local Government and Heritage for towns with a population in excess of 10,000 which includes Letterkenny in this County, with calls for application to the Fund sought under two categories. **Category 1** relates to projects with all necessary planning and other consents in place and which are ready to proceed, i.e shovel ready. **Category 2** projects are those which require further development to become ready for Category 1 status.

2.1 Summary update of Projects

Table 2 below provides a summary update on the current status and delivery of projects under the URDF.

- Grants are recouped on completion of works and on submission of vouched expenditure. The applicant must also complete a Charge Document which is prepared by the Local Authority to register a charge on the property to the value of the grant obtained.
- The timeframe for processing application is approximately 5 6 weeks where the applicant has submitted all supporting documentation at the outset.
- Donegal currently have the highest number of grant applications processed nationally.

4.0 Compulsory Purchase Order Activation Fund/Survey of Vacant Properties

In April 2023, the Department of Housing, Local Government and Heritage launched

the CPO Activation Programme for the activation of vacant and derelict properties.

The main steps of the programme include:

Step 1: Identification of vacant and derelict properties

Step 2: Identification of and engagement with owners.

Step 3: Communication with owners regarding the supports available.

Step 4: Consideration of options available to owners and DCC.

The Council have undertaken Step 1 to identify vacant and derelict properties through the GEO Directory. This survey has been undertaken in the towns listed in

Table 4 below and will be carried out in further towns over the coming months:


Building Control Activity

a. Commencement Notices

In 2023, 583Commencement notices were submitted, representing 616 new buildings and 167 building alterations or extensions. This compares with 556 Commencement Notices in 2022 representing 429 new buildings and 127 building alterations or extensions and 565 Commencement notices in 2021 representing 634 new builds and 138 building alterations or extensions.

The number of "Opt-out" Commencement Notices submitted in 2023 was 299, 52% of the overall total submitted.

As reported previously, this consistent level of submission of these type of Commencement Notices remains a concern. Where these types of Commencement Notices are being used the owners have declared themselves to be competent to ensure that the works comply with the Building Regulations and are therefore taking on ALL the responsibility for ensuring compliance with the Regulations.





Types of Commencement Notices:

- <u>Ommencement Notice with Compliance Documentation:</u> An Assigned Certifier is appointed to oversee the construction and to ensure that there is compliance with the Building Regulations.
- <u>Commencement Notice with Opt Out:</u> This can be used for single dwellings <u>only</u>. The owner is given the option to "opt out" from the Certification Process. They are still legally obliged to comply with the Building Regulations. For this type of commencement notice, an assigned certifier is not appointed, and the owner must sign a declaration to ensure that the building is constructed in accordance with the relevant Building Regulations.

It needs to be stressed here that if this option is chosen, then the Owner is declaring that they are "Competent" and will ensure that the works comply with the Building Regulations. These are still subject to spot check inspections and must provide compliance documentation upon request.

- <u>iii) Commencement Notice without Compliance Documentation:</u> This is referred to as a Short Commencement Notice and requires minimal documentation. It cannot be used for:
 - The construction of a new dwelling house.
 - An extension to a dwelling involving a total floor area greater than 40m^2 .
 - Any works that require a fire certificate
- <u>iv)</u> <u>7 Day Notice:</u> This type of notice is used, where a fire certificate has been applied for but has not yet been granted.

b. Disability Access Certificates (DAC):

A Disability Access Certificate (DAC) is a Certificate issued by the Building Control Authority and states that the works or building to which the application relates will, if constructed in accordance with the plans and specifications submitted, comply with




the requirements of Part M of the Second Schedule to the Building Regulations 1997 - 2011.

Except for houses and certain agricultural buildings, a DAC is generally required for all new buildings, including apartments and flats. A certificate is also required for material changes of use and certain alterations and extensions to buildings.

A building <u>may not</u> be opened, operated, or occupied or permitted to do so unless a DAC has been granted or pending determination of an appeals process.

The Building Control Authority is obliged to determine all DAC applications within 8 weeks of receipt unless an extension of time is agreed with the applicant.

The Building Control Department received 96 DAC applications in 2023 which compares with 87 DAC applications in 2022, 99 applications in 2021, 58 applications in 2020 and 53 in 2019.



Taking in Charge of Private Residential Estates.

The Taking in Charge team is today presenting the following estate in the Municipal District to Members seeking approval to complete the Taking in Charge process:

- Wheatfield, Muff,
- The Woods/Doonwood in Buncrana.

Where it is proposed to Declare a road to be a Public Road under Section 11 of the Roads Act, Members are obliged, under subsection (1)(b)(ii) to consider the financial implications for the Authority of the proposed declaration. However, in the case of a development which has not been completed satisfactorily and an application for takeover has been received and the Planning Authority has not commenced enforcement proceedings within the appropriate period, subsection (1)(b)(ii) of section 11 of the Roads Act shall be disregarded.



In this instance however, the financial implications are not significant, with no specific issues within the estates being raised by the Area Roads Engineers.

Donegal was showcased to thousands of visitors and members of the trade at the Holiday World Show in Dublin from 26th- 28th January and was attended by 30,000. Donegal Tourism hosted a branded stand at the Holiday World. Fifteen tourism businesses from each MD were represented under the umbrella of Donegal Tourism

New Tourism Brochure 2024

The new Donegal Tourism 2024 brochure was unveiled at the Holiday World Show. The brochure will be promoted on the govisitdonegal.com and social media channels, the content will be used over the summer months as part of ongoing marketing. The brochure will also be distributed to attractions and airports servicing the region. With the environment and sustainability in mind, a limited amount of printed promotional material with QR codes for the brochure will also be distributed to tourism businesses to make it easy for visitors to access information on what to see and do once they arrive.

Tourism Ireland Marketing Plans 2024

Donegal Tourism attended the launch of Tourism Ireland's Marketing Plans for 2024 in January, where the team had an opportunity to meet on a one-to-one basis with TI representatives working across many different countries. Following these several promotional events and opportunities have arisen, which includes an interview on Spanish national radio in relation to Donegal.

Shoulder Season Campaign Spring 2024

Donegal Tourism will re-start its shoulder season campaign on Monday 19th February for a four-week period. The aim of this campaign is to drive incremental visitors to our county in the non-peak period. This campaign enjoyed phenomenal success during Oct/Nov 2023.

Health Service Executive: Severe Weather Events:

During severe weather events, such as snow, frost and icy conditions, Civil Defence provides transport support to the HSE and National Ambulance Service with their 4x4 vehicles. This service allows the Home Care Support workers to continue their twice daily care of the vulnerable in the community, during the severe weather.

	Main Provisions
	 It is estimated that about 1.9 billion drinks bottles and cans are consumed each year in Ireland, in-house and 'on the go'.
	 The Deposit Return Scheme aims to boost the recycling rate for these drinks containers by charging a small, refundable deposit for each plastic bottle or cans.
	 The Scheme will be operated by Deposit Return Scheme Ireland CLG, trading as Return, who Minister Smyth appointed in July 2022.
	 The Scheme will include PET plastic bottles and aluminium and steel cans between 150ml and 3 litres.
	 A deposit of 15c will apply to containers 500mls or less and a deposit of 25c for each container above 500ml.
	 All producers and retailers are legally obliged to register with Re-turn. Registration is open at <u>www.re-turn.ie.</u>
	 Customers get this money back when they return the container to a retailer or other collection point to be recycled.
	 Places supplying beverage bottles and cans will be obliged to take back the containers and reimburse the deposit.

NOTE – Not every place supplying drinks has to take back containers (e.g. chip vans, small shops) but they have to apply for an exemption and if granted have to display their exemption


The scheme will be up and running from 1st February 2024.

Notes

This is a deposit return scheme commencing on the 1st February 2024 geared towards promoting recycling and addressing littering concerns by assigning a monetary value to beverage containers. If you purchase a drink in a plastic bottle, aluminium, or steel can bearing the Re-turn logo, a small deposit is added to the drink's price. Upon returning the empty, undamaged container to any retail outlet, the full deposit is refunded. Container size determines the deposit amount, with 15c for 500ml or less and 25c for containers exceeding 500ml. The scheme covers PET plastic bottles and aluminium/steel cans ranging from 150ml to 3 litres.

Designed for convenience, Re-Turn offers return points throughout Ireland. Any establishment selling drinks with the Re-turn logo is obligated to accept and refund deposits for empty, undamaged containers, except those with a Take Back Exemption. This exemption is applicable to on-site drink-serving businesses (hotels, restaurants, bars, cafes), off-site sellers with small store sizes (250 sq. meters or less), and online drink retailers. These exempted businesses must display a QR code and website link indicating the nearest return points.

Beyond convenience, the scheme is expected to benefit communities by promoting recycling as a potent tool for addressing climate change. Re-Turn seeks to transition away from the 'take-make-dispose' mindset, encouraging the return of valuable materials to the economy for prolonged use.





Final Checklist for Retailers

Re-turn is encouraging all Retailers to do a final checklist in preparation for go live of the Deposit Return Scheme on 1 February. This applies to all Retailers regardless of whether they have been granted a Take Back Exemption.

There is good news for households in rural areas. New legislation, came into effect in January 2024, meaning all householders in Ireland are entitled to a brown bin recycling collection service from their waste collector.
	The brown bin service accepts all types of food including raw and cooked meat and fish, plate scrapings, along with fruit and vegetable peelings. Other items that can go into the brown bin include food-soiled paper napkins, paper towels, pizza boxes as well as grass clippings and light garden waste. Activity / Donegal household waste collectors will be taking part in the National Food Waste Recycling **Project Title** Project in 2024 **Project** Description/ Activity The EPA estimates that Ireland generated 753,000 tonnes (t) of food waste in 2021. Growing, processing and transporting food uses a huge amount of resources, such as land, water, energy and fertiliser. If food is wasted, these resources are wasted too. The EPA estimates that food waste costs the average Irish household about €60 per month or €700 per year. That's an annual national cost of €1.29 billion. In order to help households to separate their waste and to reduce contamination in the food waste stream Donegal household waste collectors will be taking part in the National Food Waste Recycling Project this year. This project is funded by the Department of Environment, Climate and Communications (DECC) and is being led by the Regional Waste Management Planning Authorities under the guise of mywaste.ie. Through the project Donegal collectors will be provided with thousands of kitchen caddy packs to distribute to their customers. Each pack consists of a 7 litre kitchen caddy, a starter pack of compostable liners and an information leaflet. Householders can use the caddy and liners to separate their food waste in the kitchen and when the liner is full, place it in their kerbside food waste bin. The **Community Climate Action Fund - Public Information Sessions** are ongoing and are being well attended by community groups across the county.



Buncrana Flood Relief Scheme-Briefing Note No.10

Progress Summary

1.1 Hydrology and Hydraulics:

The revised hydrology report was issued and reviewed by the Steering Group. The project team are currently addressing any remaining comments and will reissue the hydrology report shortly.

The project team have incorporated the updated hydrology output into the hydraulic model. The hydraulic model build is near completion with the Hydraulic Modelling Report expected to be delivered early next year.

1.2 Environmental Assessments:

Specialist environmental surveys, including noise & vibration, air quality and landscape & visual will be carried out once the possible flood measures are identified.

1.3 Natural Water Retention Measures:

Natural Water Retention Measures (NWRM) Report is currently being reviewed by the project team and will be issued to the steering group shortly.

1.4 Stakeholder and Third-Party Communications

1.4.1 Project Website

The project website is being updated on an ongoing basis. The September 2023 Newsletter has been uploaded since the last Briefing Note in August 2023.

1.4.2 Elm Park Participation Event

A meeting with Elm Park residents was held on the 16th of October 2023. The purpose of this event was to present draft baseline flood extents to the residents impacted by the August 2017 flood event and gain meaningful feedback to inform option development. The event generated a lot of responses from the group of residents with 12 Elm Park residents attending. A follow up meeting is being organised in February 2024.

1.5 Contracts

The targeted invasive alien species (IAS) treatment process for 2023 is complete at locations where there is a potential interface with the flood relief scheme.

BURNFOOT FLOOD RELIEF SCHEME

Briefing Note 12 - January 2024

Progress Summary

RPS have now submitted the Final Report for Stage I of the scheme to the Steering Group. Following review and addressing of final queries the Stage I documents will be made available on the project website. This will conclude Stage I of the scheme.

RPS are currently developing the Planning Drawings and identifying the lands which will be required for the Scheme as part of the Stage II (Planning) tasks.

The Preferred Scheme will provide a 1 in 200 year return period Standard of Protection (SoP). A Climate Change Adaptation Plan and a Buildability, Operations & Maintenance Plan have also been developed. Minor alterations have been made to the Preferred Scheme as a result of these plans. The scheme is as per the September briefing note.

The Ground Investigation to support the outline (Planning) design of the scheme is largely complete. RPS have reviewed the draft deliverables and are liaising with Northwest Geotech to get these finalised.

RPS have developed a specification for the additional topographical survey that is required to support the design of the Scheme. This will be procured shortly.

The draft Environmental Assessment Impact Assessment Report (EIAR) and the Natura Impact Statement (NIS) for the Preferred Scheme are complete. These have been reviewed by the project Steering Group and RPS are amending the documents in response to comments raised.

Invasive species treatment for Japanese Knotweed was completed in October. This was the 3rd year of treatment at Burnfoot.

Archaeological test trenching and underwater archaeological surveys have been completed. Following a meeting with National Monument Service (NMS) further assessments of the impact of the scheme on the archaeological heritage related to Burnfoot Bridge have been completed. Photogrammetry and a Heritage Survey of the bridge have been completed. To date, the archaeological assessments have not returned any findings which would have a significant impact on the project.

Next Steps

Stage I of the Project will conclude shortly with the finalisation of reporting, including the supporting Environmental Impact Assessment Report and Natura Impact Statement for the Preferred Scheme. Stage I documentation will be uploaded to the project website once finalised. RPS have commenced Stage II of the Project where permission will be sought from the relevant Planning Authority. Tasks which are ongoing to support this are the procurement of further surveys required, assessment of landowner impacts and the preparation of planning documents.

- Preparation of draft documents for Planning Submission March 2024
- Submission for planning June 2024

1. Restoration Improvement, Restoration Maintenance & Drainage Programmes 2024.

On the 15th of February, the Department of Transport announced funding for the non-National Roads Programme.

The total allocation received by Inishowen MD for the Restoration Maintenance Programme is € 1,261,737 which represents no change from last year's allocation.

Inishowen MD received a total allocation of \in 4,919,340.00 for the Restoration Improvement programme, which represents an increase of 1.7% from last year's allocation. The total allocation for Drainage works is \in 301,364.00 which represents a reduction of 10% from last year's allocation.

At the Roads Workshops of 23rd of January & 9th of February the proposed Restoration Improvement, Restoration Maintenance & Drainage programmes were agreed on the principle that any additional monies would be distributed over the proposed programme or added to the next job on the reserve list. Details of these programmes are shown within the roads report template in Appendix I.

2. Community Involvement Schemes 2023.

Donegal County Council has received an allocation of \in 891,000 for the 2024 Community Involvement Scheme. This has been distributed to the MDs on a per Km basis. The Inishowen MD has received and allocation of \in 220,725.00, which represents no change compared to last year. At the last Roads Workshop, a priority list of schemes was agreed with the Members. Details of these programmes are shown within the roads report template in Appendix I.

3. Safety Improvement works on Regional and Local Roads for Inishowen MD 2023.

As part of the funding announcement for Non-National Roads the Department of Transport allocated Donegal County Council € 535,300 and Inishowen MD received € 260,000 in total for three projects which are listed in Appendix I.

4. Specific Improvement Grants 2024

As part of the funding announcement for Non-National Roads the Department of Transport allocated Donegal County Council €395,000 from the Specific Improvement Grant. Inishowen MD received over 65% of the allocation, € 260,000 in total for the completion of Coyle's/Beggars bridge.

• €260,000 - Coyle's/Beggars bridge R240

5. Climate Adaption Funding for Inishowen MD 2024

As part of the funding announcement for Non-National Roads the Department of Transport announced an allocation of €928,000 for the Climate Adaption and Resilience works in County Donegal. Inishowen MD received 27.4% of this allocation of €255,00 for three schemes.

- €150,000 Lagg Road R242- strengthening of seawall
- € 75,000 Seawall at Easky Bay Malin Head
- € 30,000 Continuation Glentogher Regional Road R240

6. Roads & Footpaths in Council Housing Estates 2024

At the Roads SPC meeting in February 2021, a policy was agreed around the maintenance of roads, footpaths and public lighting in council housing estates. This was subsequently adopted at plenary level at the March 2021 Council Meeting.

Funding of €70,000 has been allocated to each municipal district in the 2024 Revenue Budget. The Road Office in collaboration with the Housing & Corporate recommended a 4-year programme, where year 3 (2024) was identified as Kilbreadagh in Carndonagh. Inishowen MD report dated July 2022 included in Appendix II.

2. Social Housing through Turnkey Acquisition

Donegal County Council has opened a new county-wide turnkey acquisition process seeking proposals from Developers to deliver turnkey social housing units to help meet the Council's social housing need. Proposals are sought for 1, 2, 3 & 4 bedroom housing units towns or villages throughout the county, on lands suitable for housing purposes.

ETenders (reference RFT 2461070) refers, where all documentation and information can be obtained. Submissions must be made in strict accordance with the requirements of the procurement documentation and the deadline for submission is 16.30 on Wednesday, 30th of September 2026.

During February, 6 public information events took place throughout the county and Municipal Districts targeted at Developers who are interested in making a turnkey proposal. Events were very well attended and significant interest in the process demonstrated. Developers were invited to continue to liaise with the Council officials on their proposals on an individual level to expedite the progression of proposals.

In relation to the potential turnkey acquisition at Carndonagh, the Council has made an increased offer to the Developer for the acquisition of the units.

Council officials are continuing to dialogue with Developers regarding the additional valid proposal for Moville. Members will be fully informed of this proposal upon receipt of Irish Water requirements and final departmental approval.

3. Lands / Property for Social Housing Purposes

The Council is planning to develop further projects on existing landbank in various locations throughout the MD. Preliminary designs are underway for a number of these sites and are informed by the pertaining approved social housing need at local level.

In parallel with the construction and turnkey programmes outlined above, the Council is actively pursuing the acquisition of lands suitable for housing purposes, in towns and villages where there is currently not a social housing solution available / shortfall. In addition to the current expression of interest advertisement on the Councils' website for parcels of land, derelict sites / buildings with the potential to deliver social housing, the Council is also separately identifying parcels of land with social housing potential in areas of need.

A number of suitable land parcels have been identified in towns and villages across the Inishowen MD and engagement / negotiations are ongoing directly with multiple landowners / agents, to acquire these lands.

The Council has currently two offers accepted (subject to contract) for lands in Moville (potential for 30 housing units) and Newtowncunningham (potential for 20 housing units).

Going forward, the land team will continue to identify further land parcels across the MD and work with the Council's local service team to assess their suitability for new social housing.

Thank you for your correspondence following a recent meeting of the Inishowen Municipal District members.

The CLÁR Programme provides funding under a number of different measures for small-scale infrastructural projects in designated rural areas that have experienced significant levels of depopulation over a defined period.

A review of CLÁR areas nationally was undertaken in 2021 using the 2016 Census of Population data. The review examined the most recent changes in population patterns throughout the country on the basis of 2016 Census data.

It also examined the approach to developing the existing CLÁR designations, which is based on 2002 data and it considered how changes in population since then impacted on designations.

Many areas will have seen population growth in the relevant period, and indeed the most recent census data published by the Central Statistics Office point to population growth across all counties since 2016.

Any consideration of amendments to the current designations will be undertaken in the context of all areas rather than focusing on isolated changes to individual towns, villages or specific rural areas. The details of the review are being considered by my Department, taking into account the availability of more recent CSO data, in advance of any decisions being taken on changing the areas throughout Ireland which are to be designated as eligible for CLÁR.

I hope this is of assistance to you.
