Corporate Services

Request for a Deputation from Donegal Camping and Caravan Parks Association

Ms. B McBrearty confirmed to Members this matter had been referred to the Plenary Council. It was noted the Chief Executive is due to meet with the Donegal Campervan and Caravan Parks Association.

Housing Services

Progress reports on Grants, Loans, Casual Vacancies, and Social Housing Support Programme

Members noted the update reports on Grants, Loans, and Casual Vacancies, Housing Assistance Payments and Social Housing Support Programme as circulated with the Agenda and presented by Ms. B McBrearty.

Casual Vacancies

In relation to long term voids, Ms. B McBrearty informed Members that funding for same is awaited.

She also informed Members that Choice Based Lettings would be advertised in the next round of such advertisements where there are properties in this District in areas of low need.

Loans

Ms. McBrearty informed Members that no loan applications had been received to-date this year and although there have been some enquiries, potential applicants did not meet the minimum income requirements. She also advised that with the new Tenant Incremental Purchase Scheme it is anticipated there will be more activity in this area.

Tenant Incremental Purchase Scheme

In relation to the new Tenant Incremental Purchase Scheme, Ms. B McBrearty advised that tenants would receive information in the post in relation to the scheme by the end of the week. Any queries should be directed to the Housing Office.

Social Housing Support Programme

In relation to the Building Programme for Donegal Town Ms. B McBrearty informed Members that Part VIII for planning permission had now been advertised.

In relation to the 22 Units in Ballyshannon, Ms. B McBrearty informed Members that an Approved Housing Body is working with a developer in the area and is hopeful that the project will go ahead.

Housing Assistance Payments

In relation to HAP, Ms. B McBrearty informed Members that there over 800 payments being made under the HAP scheme in the County at present.

In relation to the property inspections, Ms. B McBrearty informed Members that inspections had commenced and any due have been completed. She also advised the relevant correspondences arising from the inspections have issued to the Landlords. The issues arising to-date are largely in relation to Fire Blankets and smoke alarms and this is being addressed by the Landlords with appropriate follow up.

In response to a query from Cllr Campbell if persons who avail of HAP Tenancies are regarded as having their housing need met, Ms. B McBrearty informed Members that over 90% of HAP Applicants opt to remain on the Council's Housing Waiting list as this option is available to them. She further advised that to-date four HAP recipients in this Municipal District have been allocated Social Housing.

Homeless Statistics

In response to a query from Cllr Campbell if it would be possible for Homeless Statistics to be circulated for this Municipal District, Ms. B McBrearty informed Members these would be circulated to Members.

2016 Roads Programme

Mr. M Sweeney presented the update reports circulated with the Agenda on the 2016 Road Works Programme. Members noted that

a large number of works are started and that the surface dressing is weather dependent.

A number of comments / queries were dealt with as follows;-

Dunkineely

In response to a query from Cllr Kennedy regarding progress on works at Dunkineely, Mr. M Sweeney advised that the design of traffic lights including traffic calming / hatching etc. is currently being prepared by Road Design and once finalised the works will be carried out by contract.

Crossing in Killybegs

In response to a query from Cllr Kennedy regarding progressing on the proposed crossing in Killybegs, Mr. M Sweeney advised that this matter is currently being worked on by Road Design in Lifford.

Road at back of Cluain Barron Ballyshannon

In response to a query from Cllr O'Neill regarding the back lane at Cluain Barron, Ballyshannon, as previously raised, Mr. M Sweeney informed Members that this road is not currently on the County Roads Schedule and that this matter is being looked at on a county wide basis as there are other similar roads in other areas of the County.

Public Lighting at the Mall Car Park

In response to a request from Cllr O'Neill that lights be installed in the Mall Car Park, Ballyshannon where he understands that ducting etc. is already in place, Mr. M Sweeney advised he would investigate with a view to having the lights installed.

Signs on Approach Roads to Towns

Cllr O'Neill made a lengthy submission in relation to signs appearing on the approach roads to Towns in this Municipal District and in particular in Bundoran and Ballyshannon. He submitted that with such a number of signs appearing, particularly in the summer season, and also with the Tidy Towns competition imminent, these are a form of litter and need to be addressed.

He requested that the Council take action to address this matter together with the issue of 'cars for sale' on the approach roads. He further suggested that perhaps a small designated area could be set aside for erecting signs, that the Council could charge a fee for and on a first come first served basis.

In response to same Mr. M Sweeney advised that the Council Roads Department does actively remove signs at roundabouts and if Members are in agreement, the Roads Department can remove all the unauthorised signs. However there would be complaints regarding this. In response to the request for a designated area for signs, Mr. Sweeney informed Members he would investigate this and revert to Members at a later meeting of the District.

HD15 Leghowney and Harveys Point Junctions

In response to a request for an update on progress in relation to the HD15 – Leghowney and Harveys Point Junctions, Mr. M Sweeney informed Members that these are being reviewed at present and explained the process of how such junctions are reviewed for HD15. He also confirmed that if a budget is allocated for the two junctions this year the works will be completed before year end.

Retirement of Mr. Vincent Callaghan, Roads Services Supervisor.

Cllr Jordan acknowledged the contribution of Mr. Vincent Callaghan, Roads Services Supervisor to the roads service and wished his well on his retirement.

In response to a query from Cllr Kennedy if there would be discussions on zoning in the Local Area Plans, Mr. E Quinn informed Members this would be a topic at the workshop in May.

He advised Members he would be happy to do a small presentation to them in relation to where An Board Pleanala fits into the planning system if they wished.

Casual Trading

In response to a request for an update in relation to Casual Trading review from Cllr O'Neill who submitted he was not happy with the length of time the process is taking, Mr. E Quinn informed Members that the matter will be before the Plenary Council in June 2016 and noted the concerns expressed at the length of time the process is taking.

A number of comments / queries were dealt with as follows;-

Donegal Gathering Website

Mr. B McLaughlin informed Members that the Donegal Gathering Website can be used to advertise events.

Playgounds in Bundoran

Mr. B McLaughlin informed Members the works to the playgrounds in Bundoran are being investigated as requested at the previous meeting of the District.

Tourism

Cllr O'Neill recognised the work which is being done in respect of tourism which is paying dividends to the District.

Mall Park Playground

Cllr O'Neill advised the Mall Park Playground Committee will be seeking permission to develop more facilities at this area. He advised there are more than 2000 visitors to the park each week in Ballyshannon and they are proposing to develop multi-surface playing areas to cater for the demand.

Teelin Pier

In response to a query from Cllr Kennedy for an update in relation to the requested disabled access for Teelin Pier, Mr. B McLaughlin informed Members there had been no success in securing funding in respect of this.

Signage at Largy

In response to a request from Cllr Kennedy for the signage at the Picnic Area at Largy, Killybegs to be reviewed and for some advance signage for the picnic area to be erected, Mr. B McLaughlin undertook to investigate this matter.

Advertising Accommodation on Websites

Cllr O'Neill referred to the 'Stay and Discover Bundoran' website and advised that a lot of Bed & Breakfasts are not listed on same. He submitted when events such as 'Sea Sessions' and Rory Gallagher' festival are advertised online the B & B's in the area should be listed on the websites.

In response Mr. B McLaughlin informed Members that Donegal County Council works as a partner to Fáilte Ireland when promoting events and that it is a matter for these businesses to ensure they are registered with Fáilte Ireland in order to be promoted on the websites. He also confirmed that this matter is being pursued by the Bundoran Tourism Officer with the businesses.

MDD/058/16 ENVIRONMENT SERVICES REPORT

Members welcomed Mr. Suzanne Bogan, Waste Awareness Officer to the meeting. She noted the report circulated to Members dealing with the following updates:

A number of comments / queries were dealt with as follows

Tidy Towns Seminar

Ms. S Bogan drew Members attention to a Tidy Towns Seminar which is taking place in the Radisson Hotel in Letterkenny at 1.30 pm on Monday the 18th April 2016 and encouraged local groups to attend. She confirmed that applications for the Tidy Towns had to be in for May 2016 with the adjudications taking place in June.

Sea Mammals

In response to a query from ClIr Campbell regarding the procedure for dealing with sea mammals, Ms. S Bogan informed Members the procedure would be issued to Members from Headquarters.

Road Side Litter and Road Side Safety

Cllr Kennedy submitted that the clean ups were going good but expressed concern in relation to the amount of litter on the road sides and the safety aspect of groups cleaning up same in particular with regard to traffic. She requested if possible for the Council to provide road signage that groups could erect when doing clean ups for road safety. She also submitted it was very disheartening for groups carrying out clean ups with the recurrence of litter along roads and 'fly tipping' and emphasised the need for enforcement. In response to the matters raised, Ms. S Bogan informed Members she would take advice from the Council's Safety Officer with respect to signage for groups and revert to Members at the next meeting. She also confirmed to Members that with respect to road side litter, there has been local and social media campaigning and there are ongoing efforts with respect to enforcement.

Designated bathing waters

In response to a query from Cllr Campbell regarding the criteria for the 21 designated bathing waters in Donegal, Ms. S Bogan informed Members a number of these have been there for years in Donegal and part of the process is to submit water samples to the Environmental Protection Agency. She also confirmed she would arrange for the criteria to be sent out to Members.

Beach Management

Cllr O'Neill made a lengthy submission with regard to beach management and the role of the lifeguards. He queried what their functions were outside of life saving e.g. had they any enforcement role with respect to beaches e.g. litter, trading etc. He also made reference to the activities that take place every year on the beach at Rossnowlagh which contribute to litter and also impact on the local rate payers. He submitted there should be 'no littering' and 'no trading' signs erected on the beaches and also that the beach byelaws should be enforced.

In response to the concerns raised, Ms S Bogan informed Members that the main focus of the Beach Lifeguards is in respect of water safety, however they would contact An Garda Siochana in some instances where they feel it is warranted in respect of safety matters. She confirmed she would convey the matters which had been raised to Headquarters.

Bottle Banks

Cllr Kennedy submitted that there are issues with respect to household rubbish being dumped at bottle banks, which is unacceptable and that there is a need for cameras for detection and enforcement at the bottle banks. In response to the matter raised, Ms. Suzanne Bogan informed Members that there are facts and figures in relation to recent enforcement actions taken by the Council including prosecution. She also confirmed she would engage with enforcement staff to get cameras at particular locations.

MDD/059/16 DISCUSSION ON MOBILE PHONE COVERAGE IN GLENCOLMCILLE

On the proposal of Cllr Kennedy, seconded by Cllr Campbell the following motion was adopted;-

"That this MD of Donegal County Council contacts the mobile network providers and requests that mobile phone coverage is prioritised and immediately dealt with as a matter of urgency in Glencolmcille particularly in relation to Malinbeg".

Members were advised;-

"Subject to the motion being adopted, a letter will issue to mobile phone providers in the area to bring the matter to their attention."

Cllr Kennedy in speaking to her motion made a lengthy submission with regard to the poor mobile phone coverage in the Glencolmcille area. She submitted it is of great inconvenience to residents and visitors to the area. She advised it is of concern when trying to contact emergency services, to workers trying to contact their employers, First Responders, Tourists and Visitors and also the fact that there is no longer a telephone box in the area. She also referred to the lack of Broadband or Wifi in the Area.

Cllrs Campbell and Jordan also spoke in favour of the motion supporting the sentiments expressed by Cllr Kennedy.

Mr. G Martin informed Members that this matter has been previously raised at a county level and that there is a broad band scheme which would offer a solution but this could be a few years into the future. He advised that with respect to the emergency services, they Minutes of Meeting of Municipal District of Donegal on 12th April 2016

are not dependent on the mobile networks for communication as they have their own system. He also advised with the increase in data usage, this has impacted on the capacity of mobile networks in some areas. He suggested with the agreement of Members, follow up in relation to this matter could be channelled through Mr. Brian Boyle, Head of Information Systems and this was agreed.

In conclusion Cllr Kennedy asked that the matter be pursued as a high priority.

MDD/060/16 DISCUSSION ON SAFE WALKING ACCESS AT COOLCHOLLY, BALLYSHANNON

On the proposal of Cllr O'Neill, seconded by Cllr Kennedy the following motion was adopted;-

"That this Municipal District and the NRA jointly provide a safe access for the public who walk as an activity at Coolcholly, Ballyshannon in the vicinity of the main roundabout that has the 'Morning Star' boat sculpture. The provision of a footpath needs to be assessed along the link road from main roundabout to the Abbey River Bridge on Rossnowlagh Road."

Members were advised;-

"NRA/TII response - The TII(NRA) will not provide funding for Works on Regional Roads.

As noted above, the NRA/TII do not fund works on Regional Roads, therefore if the MD wishes to advance the provision of a footpath along this section of road, funding in the region of €275,000.00 will need to be secured. The works would entail the provision of 1000m of 2 m wide footpath, installation of road gullies and public lighting."

Cllr O'Neill thanked the Roads Service for the response to the motion. In speaking to his motion, Cllr O'Neill submitted this is a busy walking route and requires safe access for the public. He submitted that TII/NRA should re-consider funding or at least part funding works to provide a safe walkway, in particular given that works some years ago by the NRA had taken away the safe access and the matter could be jointly pursued with Donegal County Council. He also submitted that the Council should be pursuing a more realistic allocation for footpath and walkway provision and that Central Government needs to be pursued in the regard.

In conclusion, Mr. M Sweeney advised that he would revert TII/NRO, given the submission made and revert to Members at a later date.

MEMBERS NOTED THE FOLLOWING QUESTIONS:-

MDD/061/16 WAW at Kilcar

The following question was submitted by Cllr Kennedy;-

"Has there been any progress made with Failte Ireland in relation to the WAW route at Kilcar?"-

Cllr Kennedy was informed that:-

"Discussions have commenced with Fáilte Ireland in this regard and a route inspection has also taken place. The Council will revert to Members in due course."

"How much money was retained from the contractors who did the work in Killybegs main street?"-

Cllr Kennedy was informed that:-

"The works on Killybegs Streets took place between July 2009 - Nov. 2009

DPH Groundworks Ltd, Lisfannon, Fahan, Co. Donegal was the Contractor employed to out the works. carry The value of the contract was \in 181,600.00 (incl. VAT@ 13.5%). The retention amount of €10,476.05 (excl. VAT) was retained from the Contractor for the 12 month defects period. This amount was released to the Contractor in December 2010 after the expiry of the defects period"

Minutes

Slow Zone Scheme

Mr. Mark Sweeney circulated and presented the up to date report on the proposal to introduce Slow Zones at Housing Estates that are in charge of Donegal County Council including their current status. He also introduced Mr. Peader Espey, Assistant Engineer, Road Design and Mr. Cathal Moss, A/Senior Executive Engineer, Road Design who were in attendance to deal with queries in respect of its review.

A number of queries were dealt with as follows;-

In response to a query from Cllr O'Neill as to the inclusion of private estates that have been taken in charge by Donegal County Council in the Slow Zone Scheme, Mr. Peader Espey confirmed that any estate is taken in charge will be included.

In response to a query from Cllr Kennedy in relation to the Pilot Slow Zones, Mr. P Espey informed Members that out of the 30 which had been piloted, 11 have had traffic counters installed but that this is to be expanded to monitor speed and the results of this monitoring will be available for review. He informed Members that in general the slow zone speed limits are being adhered to, but that in some cases where they are not, engineering solutions will be examined.

In response to a query from Cllr Jordan as to the success of the pilots, Mr. Cathal Moss informed Members of the steps involved in the Slow Zoning process i.e., Monitoring, Signage and where necessary engineering solutions. He informed Members that if the results show non-compliance, applications for funding would be submitted to fund any measures required.

In response to a queries from Cllrs Jordan and Kennedy regarding the installation of ramps as a method to reduce speed, Mr. Cathal Moss informed Members that the Council is discouraging installing ramps due to the noise complaints etc. these give rise to.

In response to a query from Cllr Campbell as to feedback from the pilot estates, Mr. P Espey informed Members that there are submissions and other recorded feedback from the pilot estates with the residents in the estates in favour of the slow sones.

Cllr Campbell submitted that there should be more of an emphasis on education / promotion of the slow zones, Mr. C Moss advised that the Council, through the Road Safety Working Group, had ran a successful awareness campaign in Liscooley.

In response to a query from Cllr Campbell if funding would be available for awareness/education, Mr. C Moss informed Members that at present there is funding available to introduce the slow zones for signage, monitoring and engineering methods and that the awareness would normally be dealt with through the Road Safety Working Group. However, he submitted that if awareness is a more successful method of achieving compliance funding can be applied for same.

Following a request from Cllr Jordan in relation to inclusion of Forge Road, Mountcharles, Mr. Cathal Moss agreed that this would be reconsidered.

In response to a query from Cllr Kennedy in relation to the starting point for the 30 kmph limit at Gleann Aoibhinn, Killybegs, Mr. Peader Espey informed Members it starts at the entrance to the estate and that the road outside the estate is being included in the submission for speed limits under public roads.

Speed Limit Review 2015-2017

Mr. M Sweeney circulated and presented an update report on Speed Limit Review 2015-2017. Mr. C Moss informed Members that Transport Infrastructure Ireland (TII) is undertaking a full speed limit review of national roads which would be sent to the Districts for comment prior to the public consultation. Local Road Speed limits would also be reviewed during this period. He advised that in the new review, it will be the condition of the road that will determine the proposed speed limit and anticipated a lot of changes in the limits.

In conclusion in response to a query from Cllr Campbell regarding the process for making submissions, Mr. P Espey informed Members he would forward the designated e-mail address to Members for making submissions.

1916 Commemoration – MD Donegal

Mr. Garry Martin briefed Members in relation to the discussion that took place at Corporate Policy Group where it was agreed to allocate a maximum amount of €2500 to each Municipal District for an appropriate 1916 Commemoration. He also advised in relation to the arrangements that some of the other District had made.

A discussion took place in relation to this matter and a number of suggestions were made. In conclusion, Members agreed that the matter should be referred to the Youth Councillors of this Municipal District in order to seek their suggestions as to what might be an appropriate 1916 Commemoration for the District and that any suggestions would be subject to the approval of the Municipal District of Donegal. Mr. B McLaughlin informed Members he would arrange to refer this matter to the Youth Councillors for the MD of Donegal.

Development Fund Initiative Allocations 2016

Mr. B McLaughlin presented the list of applications for DFI received for the MD of Donegal. He also sought Members agreement to obtain a contribution of €416 from each Member to fund the Junior Achievers and Pride of Place for 2016.

ENVIRONMENT SECTION REPORT APRIL 2016.

1. Big Donegal Clean Up'16

This campaign is well underway and has been a great success to date. Lot's of groups are also sending in there photographs and our Communications office is promoting and publicising events where possible.

2. Tidy Towns Seminar

Donegal County Council hosted a very successful seminar on the 18th April for Tidy Towns groups on the sustainable waste and resource management category of the competition. Among the guest speaker was Anne O'Leary Tidy Towns National Adjudicator who gave an excellent overview of the Tidy Towns competitions with other presentation focussing on the sustainable waste theme. The Radisson Hotel presented a very interesting case study on the activities of the hotel in the area of waste prevention.

3. Pay By Weight

A national and regional awareness campaign on Pay By Weight will be commencing 18th May with an intensive media campaign, a national launch event will take place on May 18th with a print and radio campaign taking place from 22nd - 29th May and again from the 19th - 26th June. A suite of awareness resources has been developed for Donegal County Council to use at a local level.

4. Enforcement Figures 2016.

Total number of environment complaints for the year to date, 438 of which 85% were for waste and litter.

Total number of Fixed Penalty Notices served under the Litter Pollution Act 1997 is 58 of which 34% have been paid to date and 13% of the total were served on persons with NI addresses.

Coastal Management

Priority Beach Works

A list of beach priority works has been drafted following direction of An Taisce re Criteria Compliance to retain Blue Flag and Green Coast status and recent Irish Water Safety beach risk assessment recommendations. Immediate works are pending for Dooey, Killahoey and Drumnatinney.

Downings beach access was improved ahead of the Easter holidays as the access path was badly choked with sand.

Designated Bathing Areas

The EPA has just awarded Donegal County Council two additional Designated Bathing Area status for Dooey and Magheroarty beaches. This brings our total to 21 (or 15%) of the total 140 beaches Nationally.

Coastal Erosion

• A very productive meeting was held with An Mhacháire le Chéile Teo to address erosion issues affecting the <u>Maghery</u> area. Coastal

Officer is progressing the issues agreed.

- An application is in Preparation to the NPWS to address the erosion issue on <u>Magherawarden</u> beach by the local river. Work is necessary to divert the river flow toward the sea. The erosion has an obvious impact re land loss but also potential deterioration in water quality.
- A meeting was held with management of <u>Carrickfinn</u> Airport re accretion issues affecting the airport and locality. With their input, an application can be made to the OPW for funding to assess the situation.
- Approval was received from the OPW to progress and seek an appropriate contractor to assess the coastal erosion issues in Inishowen from Clonmany to Malin Head.

Beach Sea Mammals

Under the Wildlife (Amendment) Act 1976-2005, all cetaceans and seals are protected species listed on the 5th Schedule. There is an obligation to protect these animals should they arrive on our shores (alive or dead). Also, there is a scientific interest to record the details of such events to track and monitor trends. Such recording can allow the introduction of measures to reduce/prevent deaths. Again, this is an obligation under the Wildlife (Amendment) Act 1976-2005.

A very productive meeting was held with the County Vet where a draft policy policy on dealing with beached sea mammals (dead or alive) was presented. The Litter Wardens, Mobile Litter Units, etc, were supportive of the policy. This policy is the first developed in the country with input from all relevant agencies.

Beach Lifeguards

Interviews are being held to appoint seasonal beach lifeguards for 14 beaches across the County. Supporting infrastructure (Lifeguard Stations, ringbuoys, toilets, uniforms, etc) is also currently being procured.

Access for All

A Loughs Agency sponsored beach wheelchair will be delivered this week to Rathmullan Water Sports and Sailing School for use by them over the 2016 season. This will enable access to the water and beach by the group's members of all abilities. This will be a valuable pilot project.

DCC is making arrangements for a long term loan of our Loughs Agency sponsored pontoon hoist to Gartan Outdoor Centre. This hoist is used to transfer disabled water enthusiasts from land to vessel safely. It was previously used in the Greencastle Marina but has been replaced with a permanent hoist.

Public Conveniences

PC Assessment

An assessment is nearing completion on the Public Convenience status at each of the 24 locations county wide. There are additional portaloo services provided both seasonally and annually. These have been excluded from this initial assessment.

These services are being reviewed in consultation with Michael Hanley re the Health and Safety of the facilities as a place of work for our staff.

Initial costs have been sought for improvement works at Bundoran, Dungloe, Arranmore Island, Ballywhoriskey, Dunfanaghy, Downings and Moville.

		Response:	It is acknowledged that the majority of elected members present at the meeting on 9th February were not opposed to abolishing the car parking charges in Ballyshannon.
			However, it must also be acknowledged that there was not a full deliberation and consideration of what the implications of abolishing the long established parking charges in one town would have on other towns in the Municipal District and indeed the whole county.
			In addition, it has to be taken into account here that the local members approved a loan to improve the Ballyshannon car park on the strength of introducing car park charges on the improved 87 spaces after the work was completed at a cost of €248,000. When the new work was completed, they

would not follow-on and introduce the charges and indeed now, not only want the charges on the new spaces not introduced but also want the existing charges in the other areas of the town abolished.

The matter of how the €248,000 will be re-paid must be dealt with in any decision to abolish car parking charges.

The expectation and the agreed plan that charges on the new spaces would ultimately pay-off the loan is still valid even though it is accepted that it is not appropriate to initiate at this point in time. Nevertheless, it is expected that in time, Ballyshannon will turn around economically and have the ability to sustain small car parking charges. As such, it would be a retrograde step, to abolish the existing car parking charges when they need to be expanded in the longer term. The existing system helps with town traffic management even though it is acknowledged that this is only a problem at certain times in the town.

The Council is anxious to assist Ballyshannon in its economic turnaround and the executive is currently examining options on how this could be supported in a proactive way and which would, in the round, contribute a value greater than the cost of the car parking charges in the town.

This is being done in the knowledge that car parking charges are not the contributory problem which caused or which is sustaining the economic downturn currently being experienced in Ballyshannon.

Finally, it should also be noted that the previous Report presented to the local members showed that there are currently 567 free car park spaces against the 97 with charges in Ballyshannon which would point to the ability of shoppers, workers and visitors having a choice to pick a free or paid space in the town.
