Minutes of Budget Workshop of Municipal District of Donegal held on Wednesday the 7th October 2015 in the Peter Kennedy Chamber, Donegal Public Services Centre, Donegal commencing at 4.00pm.

Proposed Approach to General Municipal Allocations for 2016 Mr. Garry Martin, Director of Service, circulated and presented a briefing note to Members in relation to the proposed approach to the General Municipal District Allocations for 2016.

He asked for feedback from Members in order to ensure that all items can receive consideration in the preparation of the Budget. He asked that they contact him by e-mail or phone.

Having briefed the Members in relation to the background, the 2015 General Municipal Allocations and the requirements of the Local Government Reform Act 2014 and associated regulations, and asked that the Municipal District consider the adoption of a provisional general municipal allocation in the amount of €100,000.00. This figure will be reviewed in conjunction with the consideration of the 2016 revenue budget with a view to assessing the capacity of the organisation to increase to an amount similar to that included in the 2015 revenue budget.

A number of comments/queries were dealt with at the workshop and there was consensus with the approach recommended.

Budget Timelines 2016

Mr. G Martin circulated and presented a report on the proposed Budget Timelines 2016.

Members noted the Plenary Budget Meeting will be held on Wednesday the 18th November 2015 and it was also noted as agreed at the recent plenary meeting that the Statutory Municipal District Budget meeting would be held on 28th October 2015 in Lifford at 10.30am. Formal notifications will issue in due course.

Members' attention was drawn to the fact that the Council had not varied the Local Property Tax and that the Revenue Commissioners had been notified accordingly. In addition the 3 Year Capital Programme would be presented to Members at the Plenary Council meeting of the 30th November 2015.

Commercial Rates Harmonisation & Base Year Adjustment

Mr. Martin circulated and presented a detailed report to Members on the background, main Features, issues for consideration and requirements in relation to Commercial Rates Harmonisation and Base Year Adjustment. Members were advised that it was proposed to continue the small business grant up to a maximum of €250.00 to rate payers which could mitigate against increases arising from the harmonisation.

A number of comments/queries were dealt with in particular the following:

Cllr Kennedy queried if 69.18 is the agreed ARV for Donegal, Mr. G Martin confirmed that this is what is proposed for 2016 but it is subject to Members' agreement. He further advised that the Council is precluded from increasing the adopted multiplier of 68.37 until after the harmonisation process is complete.

Mr. Martin also informed Members that the Valuation Office is due to do a national re-valuation of commercial properties in 2018/2019 and it is envisaged that this will eliminate any inequities potentially in the system at present. This re-valuation will be a re-balancing exercise and will not increase the overall valuation for the County.

Cllr Campbell asked if Rate Payers could pay by Direct Debit, Mr. G Martin informed Members that there are a number of payments options for Rates Customer including Direct Debit, Standing Order, Cash Office, Deferred Payments etc. He further advised that the Council continue to work with customers and that it was not in the Council's interest to close any business.

In response to a query from Cllr Campbell if there would be a separate report from the Audit Service in relation to rates, Mr. G Martin informed Members he did not expect this on Donegal this year.

Local Government (Reform Act) 2014 – Amendment of certain provisions relating to rates and vacant premises

Mr. Martin circulated and presented a report on the background, considerations and conclusions regarding the Local Government (Reform Act) 2014 – Amendment of certain provisions relating to rates and vacant premises.

It is recommended to Members not to vary the refund rate as currently constituted in Donegal and that full refunds will continue to apply in eligible circumstances going forward.

A number of comments / Queries were dealt with as follows:

In response to a query from Cllr Campbell as to whether a decision can be taken at Municipal District level to for example charge 50% rates for vacant properties or if this is a decision for the Plenary Council, Mr. G Martin informed Members that the decision can be made at the Municipal District but that if this is agreed there is, from his perspective and based upon best available information, a requirement to make a similar provision for bad debts.

Cllr Kennedy submitted consideration should be given to a levy on properties in town centres to encourage property owners from leaving units vacant and the benefit this would have for towns. In response to the suggestion, Mr. G Martin informed Members the implications of such a scheme/levy would have to be considered in order to make a determination on the impact of such a scheme.

In response to a query from Cllr Campbell regarding the average amount of write offs of €590,000.00 for the Municipal District of Donegal, Mr. G Martin informed Members that this relates to vacant properties in the District.

Emerging Issues in Preparation of 2016 Revenue Budget

Mr. Martin briefed Members on emerging issues for the 2016 Budget as follows:

- The requirement to make principal repayments in additional to interest payments on non-mortgage loans
- Lesser income anticipated in 2015/2016 from Non Principal Private Residence Charge
- Shared Services Central Payroll additional cost of approximately €157,000.00
- Proposed contributions to Knock and Donegal Airports
- Workforce Plan increase in payroll costs
- Review of Leisure Centres i.e. Aura, Ballyshannon, Bundoran WW and Finn Valley Centre
- Change in Pension Related Deduction

- Increase cost of insurance in the region of 4% 5 %
- Car-parking charges need to be reviewed currently happening in this District
- Costs to be held at the Centre where there is a contractual obligation on the Council to meet costs, e.g. Abbey Centre, Sea Sessions
- Development Fund Initiative currently being considered by the Strategic Policy Committee
- Noted Stranorlar Members concerns in relation to inadequate funding allocated for roads in their District.
- Increase in Housing Maintenance funding required to adequately maintain existing stock.
- Strategic Development Fund
- Marine Section Piers and Harbours
- The need to maximise funding from European sources
- The need to further develop Tourism Product
- The need to maximise the use of Assets
- Commercial Rates/Development Contributions from Wind-farms

 noting there is a national policy which will be coming into being in the near future and this may have an impact on the DCS for Wind-farms

Mr. Martin re-iterated that if Members had any feedback in relation to the Budget for 2016 to let him know at an early date so that this can be reflected in the Budget preparation.

In response to a query from Cllr Jordan in relation to commercial rates on Wind-farms, Mr. G Martin informed Members that the Council continues to be in a position to collect rates from wind-farms once they are operational but that a realistic level of DCS should be a requirement from the winds-farms at planning stage.

Proposed Approach to 3 Year Capital Budget preparation 2016 – 2018 as required by Section 135 of the Local Government Act 2001 (as amended)

Mr. G Martin informed Members it is intended to present the 3 year Capital Programme to Members for consideration on the 30th November 2015. He advised that the capital programme is largely dependent for co-funding on the Development Contribution Scheme for all services.

In response to a query from Cllr Campbell regarding the Development Contributions from Wind-farms, Mr. G Martin informed Members that he has asked the Planning Section to develop a more straight forward Development Contribution Scheme, keeping within the legal framework.

In response to a further query from Cllr Campbell regarding DCS and if conditions can be imposed to extract fees for example to

provide for Road Works, Mr. G Martin informed Members that the debate in relation to DCS in relation to Wind-farms was to charge wind-farms but to reduce the general DCS. He submitted the DCS Scheme needs to be balanced and requires more debate as the scheme that is put in place will determine the Councils capacity to fund its Capital programme for the next number of years. He further submitted the current DCS is still very low in Donegal compared to other parts of the Country.

Feedback from Municipal Districts on 2016 Budget Requirements

In response to a query from Cllr Kennedy as to increase in funding in the Development Fund Initiative Mr. G Martin informed Members this would depend on the final Budget figures.

In response to a query from Cllr Campbell if there are any proposals to amend the method in which monies are divided out between the Districts, Mr. G Martin informed Members there wasn't at this point.

Cllr Kennedy submitted that the feedback she is receiving regarding the Local Property Tax that the Council should be cutting hedges in rural and other areas. In response Mr. Martin advised that the Council needs to reflect to the public more of what is actually being done by the Council.

Cllrs Kennedy and Jordan submitted it would be of great benefit if the Local Improvement Schemes could be re-introduced as it was a good way to get rural roads improved. Mr. Mark Sweeney informed Members the scheme had been discontinued a few years ago and at that time there was a list of LIS jobs and if they were to be re-introduced, consideration would have to be given to either a new list or the ones that had previously applied. Mr. Martin submitted the Members could use the Members or Strategic Development Fund for such a scheme if they so wished as it would be coming out of the existing pool of money. Cllr Kennedy queried the Community Assist Programme and Mr. M Sweeney informed Members he would investigate this and revert to Members. However he advised he understands that owing to Health & Safety Requirements, this has become much more restricted.

Mr. Martin also informed Members there is a meeting on Thursday the 8th October 2015 as a follow up to the Malin Waters Project and the Council would be investigating if other areas could be funded via EU Funds.

In response to a query from Cllr Campbell if the Municipal Budget process would take place after the Plenary Budget from 2017, Mr. G Martin informed Members he was hopeful it would, as this would be a logical process which required amendments to the existing regulations, which he understood the Department is working on.

In response to a query from Cllr Campbell regarding Housing Policy and discretionary funding for Housing, Mr. G Martin informed Members that there are little discretionary monies.

In response to a query from Cllr Kennedy if for example the Rory Gallagher Festival should be funded by the Centre rather than through the Members Development Fund, Mr. G Martin informed Members that the matters which are funded through the Centre are ones where the Council already has a contractual obligation e. g. Sea Sessions, but there is no contractual obligation for the Rory Gallagher Festival. Mr. Martin submitted that strategically the Council should be looking at adding festivals/events for the tourism benefit this would bring to the District and this could be done through the Strategic Development Fund.

In response to a query from Cllr Campbell if the possibility of 'improvement districts' had been looked at where the Council could levy an additional charge in an area to be spent on improvements within that area, Mr. G Martin informed Members that this has not yet been examined by the Council. However he advised if localities had any particular proposals in this regard the Council would review same. He also advised he would investigate if any such activity had been undertaken in other Counties and revert to Members.

Other Matters

Donegal Town – Christmas Lights

Mr. M Sweeney informed Members that he had been approached by the Donegal Town Community Chamber who are seeking assistance for funding the Christmas lights in Donegal Town. He submitted they are seeking a contribution of around €8000.00 towards extending the lights further down Quay Street and in the past Donegal County Council has contributed to the lights in Donegal Town from the Car Parking income. He recommended that an allocation of €6000.00 should be considered in this regard by the Council. Members accepted this recommendation which would go to the next Meeting of the Municipal District for ratification.

Draft Road Traffic (Special Speed Limits) (County of Donegal) (Amendment) Bye Laws 2015 – (Certain Housing Estates)

A discussion took place in relation to the proposed introduction of special speed limits in certain estates.

In response to a query from Cllr Campbell regarding the forthcoming special meeting of the Plenary Council to deal with the proposed bye-laws which will introduce a 30 KMPH speed limit in certain estates, Mr. M Sweeney informed Members that the intention is to introduce the 30Kmph speed limits in certain estates and then to monitor if speed has reduced. If speed has not reduced the

intention is then to apply for funding to introduce engineering methods to reduce the speed limits. He further advised Members the 30 kmph signs are to be erected on the estates before the 30th November 2015 if the Bye-Laws are adopted in order to draw down the funding for the signs.

A number of other matters were raised that will require clarification as follows:

- How estates were selected
- Why was Brookfield Manor in Donegal Town not included given the proximity of the Gael Scoil to the estate
- Why were some estates left out in Killybegs
- Will this pilot scheme be extended to other estates
- If speed ramps will be included as part of the engineering methods to reduce speeds if the signage does not have an impact
- Suggested using the 'snail' on the signage
- Are there other opportunities to reduce speed in estates rather than solely relaying on signs or engineering methods e.g. through residents associations

In response to the matter raised Mr. M Sweeney undertook to convey same to Roads Headquarters in advance of the Special Meeting of the Plenary Council in order that these matters can be clarified.

On the proposal of Cllr Kennedy, seconded by Cllr Conaghan the Minutes of the Workshop of the Municipal District of Donegal held on the 8th September 2015 were confirmed.

MDD/157/15 Attendance of Deputation from Donegal Bay Rowing Club

Members welcomed the deputation from Donegal Bay Rowing Club. The Deputation was represented by: Mr. Seamus Maguire, Mrs. Deborah Bonner, and Mr. Pauric Kennedy. Mr. Maguire made a detailed presentation which included video clips etc. in relation to the following:

- Background and progress of the Donegal Bay Rowing Club from the 1970's to-date
- Youth Development and Club activities/competitions
- Other Clubs in the County and Relevant Associations
- Background to the All-Ireland Coastal Rowing Championships and previous years events
- The success the Club has had to-date in obtaining funding from Sports Council and Members Strategic Development Fund and the appreciation of same
- All-Ireland Rowing Coastal Championships 2016 to be held in Donegal, hosted by Donegal Bay Rowing Club and the benefit this will have to the local economy including additional events/entertainment being organised around the main event
- The process/strategy involved in securing the event for Donegal for 2016 and the involvement of other clubs in the County
- The funding required to run the event
- Other Maritime Festivals
- Ulster Championships
- The potential for this event to come to Donegal for future years
- The input from Malin Waters Joy Harron/ Barney McLaughlin in producing a magazine/programme for the 2016 event (this document was circulated for information purposes)
- Submitted any funding or other assistance that could be provided to them would be appreciated.

A number of comments / queries were dealt with as follows:

Cllr Jordan thanked the Deputation for their very comprehensive and information presentation and invited Members to ask questions.

Cllr O'Neill complimented the deputation on their hard work in bringing the event to the county. He queried if the southern

crews will travel to Donegal to compete. Mr. Maguire informed Members they had engaged early with the Groups to encourage as much participation as possible. He also submitted they had endeavoured to keep costs as low as possible e.g. availability of camping facilities in the area, providing information on accommodation etc. to the Groups. He also noted that the assistance from 'Malin Waters' in producing the event magazine had been of benefit in creating awareness for groups attending. He confirmed that accommodation providers are now booked out for the period of the event.

Cllr O'Neill also thanked Mr. B McLaughlin and Ms. Joy Harron for their assistance and asked that the potential for the event to return to Donegal in future years be examined.

Cllr McEniff submitted this is a fantastic event for the area as events such as this, is what builds tourism. He wished the deputation all the best for the future and to continue the good work.

Cllr Jordan queried the involvement of Clubs or Community Groups in organising Maritime Festivals, Mr. Maguire informed Members they had approached groups, Rowing Clubs, Festival Committees etc. in relation to the Maritime Festival as this had the potential to become an annual event.

In response to a query from Cllr Jordan as to when the Ulster Rowing Championships would be held, Mr. Maguire informed Members they would be held before the All Ireland event.

In response to a query from Cllr Campbell if the club are confident they can fund the event, given €50,000.00 is a large sum of money, Mr. Maguire informed Members they have experience of sourcing funding and in any event they could not turn down the opportunity to host the event. He also submitted they are confident of the support of the other clubs and would be grateful for any support they could get from the Council or any other source for the event in 2016 and subsequent years.

Cllr McEniff queried had the group applied to Failte Ireland for funding to assist with the event, Mr. Maguire advised that they are engaging with them. Cllr McEniff also advised that the potential for cross border funding should be examined.

Mr. Maguire further informed Members that they have engaged with the local Credit Union, who is examining ways in which to support local events until grants come through. In response to a query from Cllr Campbell in this regard, Mr. Maguire advised Members they have the capacity to spend the money to cover the event and then to draw down grants thereafter.

In response to a query from Cllr Campbell if the clubs from the very south of the Country would travel to Donegal for the Championships, Mr. S Maguire informed Members he expected they would as a lot of the families involved in rowing will make this week of the event their summer holidays and stay the full week to enable them to train before the competition starts.

Mr. Garry Martin submitted it was very impressive to get the All Ireland Rowing Championships for 2016 to Donegal and congratulated the Donegal Bay Rowing Club. He submitted it was a great event and also that the Maritime Festival would tie in well with the Malin Waters. He submitted that a lot of the satellite events running in conjunction with the Championships would be great for the local economy. In response to a query from Mr. Martin regarding the timing of the event given it was the busy tourist season and the potential conflict with other events at that time of year, Mr. Maguire informed Members the competition was held during August due to the availability of young people to attend during the school holidays.

In response to a query from Cllr Kennedy if there had been any agreed rates with the Accommodation Providers for the Championships, Mr. S Maguire informed Members they had encouraged as far as possible to keep the costs low and also that they had received some sponsorship from the providers. He also informed Members that the event will be opened in the Sand House Hotel in Rossnowlagh with the closing ceremony being held in the Abbey Hotel in Donegal Town.

Cllrs Jordan and Kennedy offered their congratulations to Ms. Deborah Bonner on her recent dragon boat event in Dublin.

The deputation thanked Members for the opportunity to present the details of the 2016 All Ireland Coastal Rowing Championship and Members wished them all the best in their endeavours.

MDD/158/15 HOUSING AND CORPORATE SERVICES REPORT

Progress reports on Grants, Loans, Casual Vacancies, and Social Housing Support Programme

Members noted the update reports on Grants, Loans, and Casual Vacancies, Housing Assistance Payments and Social Housing Support Programme as circulated with the Agenda and presented by Ms. B McBrearty.

Ms. B McBrearty informed Members that the 2 properties that were advertised as Choice Based Lettings have since been let. A further 7 houses will be ready to let shortly and 4 properties are being dealt with through Cluid Housing in Ballyshannon. There is one property

in an area for which there is no need and the property at 60 St Benildus Avenue in Ballyshannon would be re-advertised for sale.

She further informed Members that the Council had been asked by the Department to set out a strategy to bring long term voids which will cost more than €30,000 to refurbish back into stock and this is currently being worked up. She also informed Members of the funding draw downs for vacant units which will total in excess of €150,000 for 27 units in this District.

In relation to Housing Loans there have been no applications to-date in 2015 although there have been a few enquiries. In relation to Housing Grants she confirmed that the processing of same is up to date.

In relation to the Social Housing Investment Programme, Ms. B McBrearty informed Members that the layout plan for the Donegal Town Houses has been submitted to the Department for comment before being finalised. She also advised that the Council is carrying out survey works at Laghey and Killybegs to seek approval for the construction of housing units at these locations. She further advised the Department is allocating additional funding for house purchase and that this is being further examined in areas of need in the Municipal District.

In relation to the Council's extension programme in this Municipal District the two extensions have been completed.

In relation to the Housing Assistance Payments, Members were advised that the scheme is progressing well in Donegal. In next few weeks, existing Rent Supplement Recipients will begin to transfer to Housing Assistance Payments in tranches in agreement with the Community Welfare Officers.

In relations to the CAS Programme, Members noted approval has been granted for the 2 group homes and plans are being drawn up in conjunction with the new scheme at Railway Park.

A number of queries / Comments were dealt with as follows:

In response to a query from Cllr Kennedy if there are any plans to carryout works to older houses e.g. replacement windows, Ms. B McBrearty informed Members that funding is currently available for insulation programmes and when all houses in the country are insulated to the appropriate standard then monies will be provided for such works. Tenders are currently being finalised for 60 houses in this District. She also informed Members she has asked the Clerk of Works to compile a list of properties that require works that might be funded from this year's budget eg. Range windows/doors replacements. She also informed Members there are a small

number of roofs that require replacing which will be completed during 2015.

In response to queries from Cllr Campbell in relation to Housing Assistance Payments, Ms. B McBrearty informed Members that the issues that had been anticipated before the scheme was introduced have largely not materialised and that the scheme is progressing well with some households seeing an improvement in their financial situations. In relation to inspection of HAP properties she confirmed these would be commencing within the 8 month required period and that a resource is being provided to carryout same.

In response to a query from Cllr Jordan regarding applying for Housing Loans to the Council and if there is a specific timeframe for applying, Ms. B McBrearty informed Members applicants can submit their application at any time to the Office.

Corporate Matters – Book of Condolences

Ms. B McBrearty informed Members there is a book of Condolences at the Main Reception Desk in Donegal PSC, available for signing in respect of the victims of the Carrickmines Fire which will be there until the end of this week.

MDD/159/15 ROADS / TRANSPORTATION SERVICES REPORT

Schedule of Road Works 2015

Members noted the progress report on the schedule of Road Works 2015 for the Municipal District of Donegal as circulated with the Agenda and presented by Mr. Mark Sweeney.

Mr. M Sweeney also briefed Members in relation to a number of items on the Schedule of Works that have been completed since the report was prepared and works which are due to commence shortly. He advised that the surface of the Drumlonagher roundabout will be re-laid over three nights next week.

Low Cost Remedial Works

In relation to Low Cost Remedial Works Mr. Sweeney informed Members there had been no agreement reached with the Landowner at this stage and therefore the works are being transferred to another location in order to be in a position to draw down the funding in this years schedule of works. It is hoped that the works at Cavangarden Junction can be undertaken in 2016 if the matters can be resolved.

In relation to proposed works at Laghey, Mr. Sweeney informed Members designs have been completed by the National Roads Office and that the advance works would be undertaken shortly.

In relation to the Leghowney Junction, Mr. M Sweeney informed Members a response is due from the National Roads Authority this week.

In relation to the Solice/Harvey's Point Junction, Mr. M Sweeney informed Members that the National Roads Authority have included this for a HD Assessment for 2016 which he regarded as a step forward for this junction.

Footpath Programme

In relation to the Footpath Programme, Mr. M Sweeney informed Members the works in Ballyshannon have yet to commence but the other works have been completed.

Gateway

Mr. M Sweeney advised Members that up to 14 participants are coming to the Roads Section under the Gateway Scheme. The works which they may undertake will compliment the works being undertaken by the Community Chamber in Donegal Town. He asked that any requests for works to be undertaken through this scheme should be channelled through him-self and that he would welcome such requests.

A lengthy discussion took place in relation to the Gateway Scheme and in particular the following points were made:

In response to a query from Cllr Campbell if the participants in the scheme will receive training for which they will receive e.g. FETAC Certification, Mr. M Sweeney informed Members they will received the normal in-house training that full-time employees receive e.g. Safe Pass etc. and will be supplied the Personal Protective Equipment. He also advised that this is a national scheme and that roads in Donegal are taking on 14 Participants. He further informed Members the participants would not be carrying out duties normally undertaken by County Council employees but that there are several other suitable works that they can undertake.

Cllr Campbell questioned if the experience gleaned by participants in the scheme would lead to full-time employment and also questioned if the scheme was merely to artificially reduce the numbers on the live register and to provide cheap labour

In response to a query from Cllr Jordan if most of the participants are from the Donegal Town Area, Mr. Sweeney informed Members they are and that one supervisor will supervise the participants and that a pick-up is being provided for travelling to and from jobs.

Cllr O'Neill expressed his concern at the negativity in relation to the scheme and welcomed it advising it would be a good opportunity for unemployed persons to get back to work from a personal development point. In addition the scheme would lead to a lot of

improvements in the area. He submitted a lot of towns will be happy to identify works that can be undertaken by the scheme.

Cllrs Kennedy and Conaghan welcomed the scheme and the benefits it will have for both the Participants and improvements it will bring to this District.

Members submitted it would be good see the Council recruit staff on a full-time basis as this would be of benefit to the County also.

Contribution to Christmas Lights in Donegal Town.

As discussed at the recent Workshop, Mr. M Sweeney informed Members he had received a request for funding from the Donegal Town Community Chamber towards the Christmas Lights in Donegal Town where they propose to extend the lights at Quay Street. Following a short discussion, on the proposal of Cllr McEniff, seconded by Cllr Jordan, Members agreed to a contribution of €6000.00 towards the Christmas lights in Donegal Town.

ESB Fence, Ballyshannon

Cllr O'Neill referred to the ESB Fence at Ballyshannon as raised by him at the previous meeting of the Municipal District of Donegal. He made a lengthy submission in relation to the water safety issue and the fact that public safety was being compromised. He referred to a letter he had that had been issued by the Donegal Water Safety personnel. He referred to a recent meeting that had taken place with Council staff, ESB and Irish Water Safety. He submitted that the issue has not been properly addressed and that he would continue to raise this matter.

In response to the planning issues raised, Mr. K Smith informed Members as this matter has been dealt with by An Board Pleanala, the matter is closed from a Planning perspective, apart from two conditions that have been attached to the permission as granted by the Board.

In response to a query from, the Cathaoirleach as to what Cllr O'Neill was seeking, he advised he was seeking that the Council readdress the whole area of public safety at this location in Ballyshannon by meeting with Irish Water Safety.

Members noted there is a meeting in Killybegs on the 13th October 2015 in relation to Tidal Energy.

Donegal Town Craft Village

Cllr O'Neill complimented the great work done at the Craft Village in Donegal Town noting that it is fully occupied. He also paid tribute to the Mental Health Workshop.

MDD/163/15 ENVIRONMENT SERVICES REPORT

Members welcomed Mr. Dearn McClintock, Waste Regulation Officer to the meeting. He presented the report circulated to Members dealing with the following updates:

- Backyard Burning and Bonfires
- Free Household Hazardous Waste Collection
- Tidy Towns successes in Donegal.

A number of comments / queries were dealt with as follows:

Cllr O'Neill submitted it was a great achievement for all involved in Donegal in the Tidy Towns in particular the work of the voluntary groups and others involved in improving our towns and noted that the groups involved must gain satisfaction with the number of additional points achieved in the competition. He thanked every one involved and encouraged them to keep up the good work.

Cllr Kennedy noted that Killybegs had gained 13 points in the Tidy Towns competition which was a huge jump and offered credit to all Towns involved. She also thanked Donegal County Council for collecting the rubbish gathered by the various groups.

MDD/164/15 DISCUSSION ON CARPARKING CHARGES IN BALLYSHANON

The following motion was submitted by Cllr O'Neill

"That this Municipal District Council abolishes Car Parking charges in the town of Ballyshannon".

Cllr Campbell objected to the motion being included on the Agenda advising in accordance with Standing Order no. 18, the submitted motion was out of order.

Following a discussion, Cllr O'Neill proposed an amended motion as follows:

"That the Municipal District of Donegal calls on Donegal County Council to consider abolishing car parking charges in the Town of Ballyshannon as part of the review of the charges."

The amended motion was seconded by Cllr Kennedy and adopted.

Members were advised;-

The Donegal County Council (Parking Places) Bye-Laws 2004 relate the following towns, Ballybofey, Stranorlar, Donegal Town and Ballyshannon.

The Council is currently reviewing these By-Laws with a view to updating them in line with the report previously presented at the Workshop meeting held on 8th September 2015. To assist the Members in their consideration of this motion our review will include an analysis of the parking statistics in Ballyshannon together with a report on the benefits of retaining pay and display in the Town. Subject to workload I hope to be able to present the Bye-Law review and Ballyshannon report before the end of the year.

In proposing the motion Cllr O'Neill submitted that the parking charges in Ballyshannon are a deterrent to customers. He advised that Ballyshannon required assistance not only in relation to all the business closures that have taken place in the last number of years but also to existing businesses to remain open. He disputed the fact that there wouldn't be monies available to provide services if charged are abolished noting that there are a number of other towns in the County of a similar size where parking charges had not been

introduced. He requested that the Council expedite the process of reviewing the charges in Ballyshannon.

Cllr Campbell opposed the motion submitting that it would be a negative step to abolish charges in Ballyshannon. This in turn would mean a reduction in funding for other towns which would in effect come back to the ratepayers in the County. He further submitted there had been a previous commitment for charges to fund the construction of the car park in Ballyshannon which the Council completed a few years ago.

Mr. M Sweeney informed Members that the money collected in Ballyshannon will have to come from elsewhere in the event that charges are abolished. He advised he would finalise the review bring and back a report to Members as early as possible.

Mr. G Martin submitted that a review of parking charges is taking place at a county level and noted the benefits to the Towns where there are charges and the importance of a balance between reasonable charges and creating a pool of income to benefit the towns. Noting the sentiment of the motion initiatives are required to create economic activity in Ballyshannon and other small towns in the county. He submitted that the Council is committed to finding solutions for the challenges which are present in small towns and that when the review is completed work will commence on working through the statutory process.

Cllr O'Neill thanked Members for passing the motion.

MDD/165/15 DISCUSSION ON KILCAR - WILD ATLANTIC WAY AND SIGNAGE

On the proposal of Cllr Kennedy, seconded by Cllr O'Neill the following motion was adopted;-

"That this MD along with Failte Ireland reconsider, investigate and resolve the reasons why Kilcar village and the coast road at Kilcar is bypassed (Wild Atlantic Way and Signage)."

Members were advised;-

The Council will forward this proposal to Failte Ireland and request a meeting to discuss same.

Cllr Kennedy in proposing the motion made a lengthy submission in respect of the motions and in particular in relation to the following:

- The decline in visitor numbers to Kilcar
- That the signage for Kilcar is confusing and not just the Wild Atlantic Way Signage

- No direct signs to the Coast Road and no need to direct traffic away from the Coast Road
- Has been in contact with Failte Ireland and went around all the signs in the area
- 75 % of visitors to Sliabh Liag are by car and therefore should be made aware of the facilities available in Kilcar e.g. Hostel, Knitwear and other facilities
- The Junction at Kilcar has become dangerous with no lines on the road

In seconding the motion Cllr O'Neill submitted that the Council should engage with Failte Ireland to try to address this matter and to encourage traffic through Kilcar and not to have the village sign posted better is a mistake. He submitted contact should be maintained with Failte Ireland in this regard.

Cllr Campbell submitted that Donegal County Council is not the lead or partner Agency in the development of the Wild Atlantic Way and that this is a matter for Failte Ireland. He noted that the WAW does not go through Kilcar, similar to other towns and that much more needs to be done to enable businesses to identify opportunities which would expand their footfall. He referred to the conference run by the Councill to show businesses how to make opportunities out of the WAW and that this needs to be pursued by the business/tourist sector. He advised he did not anticipate that Failte Ireland would amend the WAW route, but perhaps they may allow for a sub-route. He stressed the importance of businesses looking at other solutions to maximise the benefit of the WAW to their respective areas rather than changing the WAW route. He recommended that signage for Slieve League should be repositioned.

Mr. B McLaughlin confirmed that the Wild Atlantic Way is a Failte Ireland initiative and therefore route /signage etc. is their responsibility. He advised that the Council would engage with Failte Ireland in relation to this motion.

MDD/166/15 Request for a Deputation from the Bundoran Surf Industry

Members noted the correspondence received from the Bundoran Surf Industry circulated with the Agenda seeking to send a deputation to the next meeting of the District. Members noted the Bundoran Surf Industry were in attendance at a meeting of this District in May 2015. It was noted that the Bundoran Surf Industry had not specified in their correspondence which matters they wished to raise at the Meeting and it was agreed that this should be clarified by them so that the request could received further consideration at the next meeting. Mr. G. Martin advised that he had no issue in dealing with the access issue at Bundoran Surf Industry and would meet them again if their request is in relation to this. He asked for

agreement in principle to this course of action and informed Members that he would keep them fully informed of updates. On the proposal of Cllr Campbell, seconded by Cllr Kennedy, Members agreed that a letter issue to them as agreed above and agreement in principle was given to Mr. Martin's to proceed as requested. Ms. B McBrearty confirmed the letter would issue shortly to seek the clarification.

MEMBERS NOTED THE FOLLOWING QUESTIONS:-

MDD/167/15 Speed Ramps in Housing Estates in the Municipal District of Donegal

The following question was submitted by Cllr Kennedy;-

"Can the Municipal District of Donegal consider placing speed ramps at housing estates in this MD and give reasons for and against?"-

Cllr Kennedy was informed that:-

"Donegal County Council as part of a pilot scheme set up to coincide with Circular RSD 01/2014 issued by the Department of Transport, Tourism and Sport have identified a number of social housing estates where it is proposed to introduce a 30km/hr "Slow Zone" in line with the guidelines issued by the Department. The estates identified in the Donegal MD are as noted below:

- 1. Emerald Drive Housing Estate in Killybegs.
- 2. St Theresa's Housing Estate in Bruckless.
- 3. Mill Race Crescent housing Estate in Donegal Town.
- 4. Saimer Drive Housing Estate in Ballyshannon
- 5. Erne Dale Heights Housing Estate in Ballyshannon. Elaghmore Housing Estate in Bundoran.

The Slow Zones should be developed and implemented as a Local Authority supported community based approach to reduce speed limits to 30km/hr and to add safety measures within a select area in order to change driver behaviour. The ultimate goal of a Slow Zone is to lower the incidence and severity of crashes and to enhance quality of life.

Once a Slow Zone has been set up the Local Authority will then monitor vehicular speeds within the estates.

If the vehicular speeds are not adhering to the 30km/hr speed limit (85th percentile) then the Local Authority can apply to the Department for funding to add engineering solutions to the estate to slow vehicles down. The introduction of speed ramps is one such

engineering solution. The main benefit of the introduction of speed ramps is that they will slow traffic down.

The main drawbacks are as follows:

- 1. Vehicles tend to speed up between the speed ramps.
- 2. Speed ramps can cause driver distraction in that the driver focusing on the speed ramps making them less aware of their surroundings.
- 3. Some residents are happy to see speed ramps but do not want them in front of their property.
- 4. Speed ramps on steep slopes can be a hazard to the road user.
- 5. Speed ramps will reduce response times for emergency vehicles.
- 6. Speed ramps generate increased noise levels from vehicles crossing the ramps.

It is recommended that speed ramps are only installed within self contained sections of an estate with low traffic volumes and not on through roads within the estate where there are higher traffic volumes.

Speed ramps in housing estates should only be considered after the introduction of a Slow Zone."

MDD/168/15 Pilot Scheme for the treatment of Invasive Plant Species

Can this MD implement a pilot scheme for the proper treatment of invasive plant species eq Knotweed?

Cllr Kennedy was informed that;-

There is currently a pilot project underway within this Municipal District for the treatment of Japanese knotweed.

Local Area Plan Update

Mr. Denis Kelly introduced the Planning Staff in attendance to Members and proceeded to present the report on Initial Stage of Public Participation and Consultation to Prepare Draft Local Area Plan in Respect of Tier 2 Towns. Members were brought through the report in detail and a number of queries were dealt with at the Workshop. Members complimented the Central Planning Unit on the level of work and detail in the report. In response to a request for feedback, Members made the following submissions:

Cllr O'Neill submitted the following:

- Welcomed focus on economic, tourism and heritage development in Ballyshannon as opposed to being centred on residential zoning.
- Asserted that Ballyshannon, as the oldest town in Ireland didn't have the same problems with dereliction and 'ghost estates' as other towns outside of the County

- which he felt may have been due to only 15ha of the 200ha of land zoned for development actually having been developed since the last CDP.
- Felt every town should develop to its strengths with Ballyshannon needing to draw on its designation as a Heritage Town.
- Would like to see parking charges reviewed given close proximity of Ballyshannon to the Border encourage people to shop local.
- Stated the LAP will be critical to the development of Ballyshannon and to all towns over the next few years.
- Highlighted the visual importance of historic streetscape development with particular reference made to the Town Clock in Ballyshannon.
- Emphasised the importance of developing, improving and promoting the IDA Portnason site as part of the LAP, advised of business interest in the site. Cited the success of the Craft Village in Donegal Town. Feels the development of Portnason should be lead by Donegal County Council, LEO and the Ballyshannon Regeneration Group (BRG).
- Commended the work carried out by the BRG and the value of the group to Ballyshannon.
- Proposed an index of recorded protected structures relevant to each MD should be detailed on each LAP.
- Proposed an index of public 'Rights of Way' relevant to each area should be detailed on each LAP.
- Requested a Town Design Statement for Ballyshannon to reflect and protect the heritage and architecture of the Town.
- Acknowledged the excellent restoration of the Convent Building and the importance of preserving a building of such architectural value.
- Proposed making the development of the Mall Quay area, incorporating the 'old dog pound' with a breakwater in the estuary, a key objective of the LAP. Felt it could be a huge amenity for the south of the County.
- Welcomed the 'town centre outwards' approach in relation to retail in the Donegal Town Plan and felt that this should be the same for all towns.
- Remarked that the ESB were not required to carry out an Environmental Impact Assessment for the fence they erected in Ballyshannon in a Natura 2000 site.

Cllr Kennedy submitted the following:

- Noted the volume of submissions in relation to Killybegs and in particular with regard to St. Catherine's Well.
- Advised that there are 4 piers in Killybegs, the largest of which the port pier being the oldest area in Killybegs.
- Advised of past developments that overlook the vicinity around St. Catherine's Well, the Church graveyard and Kitt's Castle. Would not like to see future development advance further along this area. Advocated the need to safeguard St. Catherine's Well
- Acknowledged the importance of port related activities and the further development of same but asserted that there is adequate alternative lands for development removed from St. Catherine's Well.

- Welcomed future development of the Letterkenny Institute of Technology, Killybegs Campus.
- Queried where the Town Boundary for Killybegs would be in the new LAP and would it include the new industrial road and/or Fintra Beach and the Clock Tower development.
- Highlighted the need to protect the old railway line and bridges out past the Hollybush Junction
- Queried how much land is to be zoned for recreation and/or greenfield site opportunities and how much land to be zoned for residential / other development
- Welcomed that Killybegs is making progress with employment increasing
- Enquired how are NIAH Buildings listed
- Emphasised the need to enhance the appearance of Killybegs and in particular the Donegal Road into the town
- Enquired if the submission the Killybegs Community Council made in relation to the Local Economic and Community Plan could be used in part to enhance their submission regarding Killybeg's LAP
- Requested that maps for the previous town plans showing the various zonings be circulated to Members for information purposes

Cllr Conaghan submitted the following:

- Welcomed the report presented
- Stressed the importance of all community and business committees/groups in Donegal Town working together to ensure a comprehensive LAP for the town.
- Advocated the need for a traffic management plan for Donegal Town to alleviate congestion in particular at the bus stop in the town centre, which is hampered by 'double parking' and at school drop off/pick up points.
- Proposed the consideration of 'pay and display' parking as a solution to town centre traffic congestion and/or a pedestrian only zone but recognised that 'buy in' would required from retailers and community groups in the town. Recommended that revenue collected from 'pay and display' could be used to enhance the town.
- Detailed the repair work required on The Iron (Tirconnell) Bridge
- Expressed concern for elderly residents in relation to the risk of flooding on Water Street. Suggested the estuary could be dredged to reduce the danger of flooding.
- Recognised the potential of the town.

Cllr Jordan submitted the following:

- Welcomed the report presented and emphasised the importance of learning from past oversights in other areas in relation to zoning.
- Complimented the Donegal Town Business Focus Groups on their excellent submission
- Highlighted the need for investment in Ballyshannon.
- Was critical of the level of investment by the IDA in the County.
- Expressed surprise at the lack of submissions in relation to recreation for Killybegs given its recent success stories and accomplishments.
- Enquired if the spokesperson for Taxi Drivers could still make a submission as he had missed the consultation period.

- Queried when the Town Design Statement would be completed for Donegal Town, emphasised the need for considered zoning.
- Concurred with Cllr. Conaghan in relation to flood risk.

Mr. Kelly thanked Members for their feedback and advised that each town has different requirements that need to be reflected in the Town Design Statements and reaffirmed the importance of policies being in place to support same. Ms. Claire McCallan concurred with Mr. Kelly and suggested that while an urban design statement may be the best fit for Killybegs for example, a village management document may be more fitting for Ballyshannon and the need to be mindful of the character of each of the towns mentioned is of the utmost importance, as it is not a case of 'one size fits all'.

Ms. McCallan gave a brief overview of the role of the NIAH and of the cultural significance of NIAH recorded structures to a town. Mr. Kelly highlighted the potential opportunities available in Ballyshannon, Donegal Town and Killybegs regarding heritage. In relation to a query regarding The Iron (Tirconnell) Bridge in Donegal Town being on the NIAH, Ms McCallan advised the Members that a detailed assessment had already been carried out of the bridge and that all of the NIAH recorded structures are mapped.

With respect to the Town Clock in Ballyshannon, Members were advised that as the clock is in private ownership and although a number of attempts have been made by the Council to engage with the owner, no progress has been made. It was also noted that there is a grant aid process open until 20th November 2015 but this would require engagement from the owner.

Mr. D Kelly advised the Members that there will be further public consultation regarding the Local Area Plans and that town boundaries would be examined in relation to each LAP. Mr. Kelly furthered that the submission received from the Killybegs Community Council with respect to the LECP could be considered with regard to the Killybegs LAP.

In concluding this item, Members noted the next phase of the Local Area Plan process will be the arrangement of a further facilitated workshop in each town. Members also confirmed their endorsement to the general approaches as outlined in Sections 5.1 to 5.4 and 5.5 to 5.11.

Casual Trading

Mr. D Kelly referred to previous discussions held with Members in relation to Casual Trading both at Strategic Policy Committee and Plenary Council meetings where it had been agreed that the matter would be discussed at workshops in the Municipal Districts to obtain feedback from Members. Mr. Kelly advised that this feedback would subsequently be presented to the Plenary Council with respect to updating the current Donegal County Council (Casual Trading) General Byelaws. Mr. Kelly submitted it is timely to review the byelaws in the County given the amalgamation of the Town and County Councils and also with the preparation of the draft LAPs in relation to Tier 2 towns. Mr. Kelly briefed Members in relation to the matters that require consideration including

- Exemptions
- Fees

- The formation of a subcommittee with full stakeholder representation to discuss relevant issues
- Designation of Casual Trading areas.

Mr. Kelly outlined that Casual Trading means selling goods at a place (including a public road) to which the public have access as of right or at any other place that is a Casual Trading area and added that Donegal County Council introduced the following exemptions

- the selling of hot food by touring Hot Food Vendors provided that they do not remain static for a period exceeding four hours at any one stop and provided that they do not trade within 100 metres of any commercial premises trading in hot food, between the hours of 20.00 and 9.00 hours
- the selling of ice-cream by touring ice-cream vendors which do not remain static for a period exceeding four hours at any stop.

Mr. Kelly went on to clarify that ice-cream vans selling 'door to door' in residential areas does not constitute Casual Trading. A discussion took place in relation to the disparity in fees currently charged in each Municipal District and whether they should be standardised throughout the County. Mr. Garry Martin proposed that while Casual Trading fees should be fair, proportionate and reasonable, they should be harmonised at County level. Mr. Martin suggested a comparative with what other counties are charging should be undertaken and the amount ratepayers are charged should be also be taken into consideration.

A number of comments/queries were dealt with as follows:

In response to a query from Cllr Kennedy if Casual Traders are obliged to clean up the trading areas after trading times, Mr. Kelly advised this should be considered as part of the process and the Council needs to review this matter with the Roads and Transportation Directorate and the Water and Environment Directorate in relation to the associated costs involved which in turn need to be reflected in the Casual Trading fees charged.

Cllr Conaghan asserted that Casual Trading fees are disproportionate to what ratepayers are charged and that the 100m exemption is not enforced especially during peak trading times like festivals which has an impact on local rate paying businesses. Cllr. Conaghan also highlighted the issue of litter after big events and the cost to the Council which is not contributed to by Casual Traders.

Cllr O'Neill detailed his concerns in relation to Casual Trading in Ballyshannon as follows;-

- Two thirds of the Casual Trading spaces in the County are in Ballyshannon
- The current designated Casual Trading site is the only open public space in Ballyshannon and is unavailable during the hosting of other festivals and events of significant benefit to the local economy e.g. Rory Gallagher festival which bring €2m to the local economy as it operates on a year-round basis.
- The fee currently charged for Casual Trading in Ballyshannon of €250.00 for the first Casual Trading space and €150 for each additional space thereafter, is disproportionate and needs to be increased. The price of Event Licences also needs to be reviewed and regulated/enforced.

- Casual Trading Licences should be valid for a calendar year as opposed to issued for a 12 month period.
- The traders contribute little to Ballyshannon and they have an unfair advantage over and are having a detrimental effect on ratepayers businesses
- The lack of enforcement is an issue with breaches of the Casual Trading Bye-laws going undetected/ not enforced.
- Proposed the use of signage to highlight Casual Trading bye-laws.
- Proposed the use of an alternative site for Casual Trading on the Rock Road, Ballyshannon as opposed to the current site.

Cllr O'Neill detailed his concerns in relation to Casual Trading at Rossnowlagh Beach as follows:-

- In accordance with beach bye-laws there should be no trading on Rossnowlagh Beach.
- There is no regulation of Casual Trading currently taking place on Rossnowlagh Beach e.g. Ice-cream vans, donkey rides, jet ski hire etc.
- Casual traders operating on the beach do not partake in or contribute towards any clean up of the beach. This service is provided by the local community with assistance from Donegal County Council.
- Referred to a previous proposal for a beach management centre at Rossnowlagh which he submitted and expressed disappointment that it did not proceed.
- Suggested designating a Casual Trading area in Rossnowlagh away from the beach.
- Submitted that the exemptions in relation to hot-food touring vendors and ice-cream touring vendors need to be reviewed as 100m is not an adequate distant from ratepayers. Suggested that 1000m would be a more appropriate distance and that the no trading period of between 8pm and 9am should be extended to a 24hour period.
- Need for regulation and enforcing of bye-laws.
- Fees for Event Licences need to be increased significantly and regulated/enforced.

Cllr Jordan concurred with comments made by Cllr. O'Neill and Mr. Martin in relation to a review of fees currently charged with a view to harmonising fees across the County which will have a significant impact on Ballyshannon which hosts the majority share of Casual Trading in the County.

Mr. Kelly acknowledged the feedback from the Members and the issues they felt were caused by the existing bye-laws and exemptions including; the need to increase the distance of 100m; the need to increase the no trading period of between 8pm and 9am; waste management issues; traffic safety issues and noise pollution.

Mr. Kelly thanked the Members for their feedback and advised that in tandem with feedback received from the other Municipal Districts he would revert to the Plenary Council with same for the purpose of establishing draft general bye-laws in relation to Casual Trading for the County which will provide a framework for agreeing a designated Casual Trading area in the Local Area Plans currently being drafted.

It was further noted that a clear definition of 'hot food' clarity in respect of the current exemptions.	would be provided for the purpose of

MDD/176/15 Draft Budgetary Plan for the Municipal District of Donegal for 2016

Mr. Garry Martin, Director of Finance, Information Systems and Emergency Services, briefed Members as to the purpose of the meeting which was to confirm and put on record that the approach adopted in consideration of the Draft Budgetary Plan for the Municipal District of Donegal for 2016 was in line with existing Regulations. He advised that it was a statutory meeting required by Section 102 of the Local Government Act 2001 (as amended) and associated regulations, including the Local Government (Financial & Audit Procedures) Regulations 2014 and the Local Government (Financial & Audit Procedures) (Amended) Regulations 2015 as advised to Members at their meeting on the 28th October 2015.

Mr. Martin informed Members that a similar approach was being taken as that of previous year and it is in line with the current legislation governing Local Authority budgets. Members were advised that it was a reserved function of the Member to either adopt the Draft Budget as presented with or without amendments and as provided in the legislation, (Section 102 (4A) (e) the Chief Executive "shall take account of any budgetary plan adopted...in preparing the draft local authority budget (in accordance with subsection (2))".

Mr. Martin also briefed Members in relation to the sequencing of decisions as currently set out in the legislation which it is hoped will be amended in time, to allow for the Municipal Districts to adopt their budgets after the plenary budget meeting, when it is clear what discretionary funding is available to the Municipal Districts. Members noted the Draft Budget for 2016 was adopted with amendments in some of the Districts and without amendments in the others.

The following documents as circulated with the Agenda were noted by Members;-

- 1. Draft Budgetary Plan & General Municipal Allocation for 2016.
- 2. Circular Fin 05/2014
- 3. Appendix 1 Overview of Budget Process
- 4. Appendix 2 Report to be submitted to the Department of the Environment, Community and Local Government by 30 September
- 5. Appendix 3 Draft Budgetary Plan
- 6. Circular Fin 08/2015
- 7. Appendix 1 30 September report to Department Preliminary estimate of capital and current income for the forthcoming financial year.

A number of comments /queries were dealt with as follows;-

In response to a query from Cllr Campbell regarding the meeting held on the 28th October 2015, Mr. G Martin informed Members the minute for this meeting will be available to Members for consideration at the December 2015 meeting of the Municipal District.

In response to a query from Cllr O'Neill, Mr. G Martin clarified that the purpose of today's meeting is to adopt a draft Budget for 2016 for the District which would be reviewed after the Plenary Budget has been agreed for 2016.

Cllr Jordan proposed that an allocation be made for Local Improvement Schemes in Budget for 2016 and this was seconded by Cllr Kennedy. A discussion took place in relation to LIS's, following which Mr. G Martin clarified that Members are not required to put a figure on LIS if they wish to have it included at this stage, as the MD Budgets will be reviewed following the adoption of the Plenary Budget. It would then be a matter to be reviewed in discussion with Members.

Following further discussion on the proposal of Cllr McEniff, seconded by Cllr Conaghan, Members agreed to adopt the Draft Budgetary Plan for 2016 for the Municipal District of Donegal

with the following amendment as referred to above;- 'that the Municipal District of Donegal recommend that an allocation for a Local Improvements Scheme be provided in the Plenary Budget for 2016.".

Cllr O'Neill also requested that a portion of the Plenary Budget for Tourism be allocated to the Districts specific to each Municipal District. Mr. G Martin informed Members that as an observation, the global figures in the Plenary Budget may relate to non-discretionary funding e.g. staff or other fixed costs but advised he would ask the Director to outline what the costs are included in the Tourism Budget for Members consideration at plenary level.

In response to a query form Cllr Kennedy in relation to funding for bridges in the District with particular reference to Fintra Bridge, Mr. G Martin informed Members he would request this matter be reported on by the Director of Roads / Transportation either in his Plenary Budget Report of alternatively in the Strategic Infrastructure report.

Mr. Martin thanked Members for their consideration and adoption with amendment, of the draft Budget for 2016 for the Municipal of Donegal.

Killybegs Community Council: A lot of development and initiatives in & around the town, e.g., The Niall Mór Centre, The Carpet Factory, The Mens Shed, Mooneys Boat Building Yard, The LYIT Catering College, the Community Hospital, work on large fishing vessels at the main pier. There is great & evident community involvement in the Tidy Towns (floral displays all around the town, painted derelict buildings on the main street, maintenance of old churches and graveyards kept. Campaigns were organised to keep the local community hospital and the Catering College in the town and succeeded. Tidal Wave Energy research in progress. Making the most of the Wild Atlantic Way - succeeded to have signage relocated in the town and marina being developed at present. Great awareness of funding and development resources. A vibrant, interesting and go-ahead town to live in and to visit. 3. The Workhouse, Dunfanaghy: Developed considerably over the past 10 years as a tourist, children's activities, heritage, community and cultural centre. Local walks have been developed by the centre in the Dunfanaghy and Horn Head area and guided nature walks are in demand. The Tidy Towns committee operate from the centre and are very much involved in various festivals such as the annual Dunfanaghy Jazz & Blues, Errigal Arts, St Patrick's Day, Halloween and other seasonal activities throughout the year. The playground has been a great addition to the Workhouse. There is a restaurant and craft shop in the building and the centre is utilised by locals & visitors throughout the year. It is a hub of activity and visited by tourists more and more recently. The Wild Atlantic Way has showcased the various activities to draw tourists/visitors to the town regarding eateries, singing pubs, surfing, horseriding, walks, beaches etc.

It also houses a genealogy centre for the area. A wedding took place in the centre in August that attracted a lot of media attention. The North West cycling club use the centre as their point of starting & finishing. The Sliabh Sneacht walk has been developed by the community organisers and toilet & shower facilities are provided for their use. The local school uses the facilities. The organisation uses the Wild Atlantic Way to promote all their facilities and welcomes everyone to use and visit their wonderful facilities.

particular for the arrival of cruise ships. Donegal County Council is in discussion with Cruise Ireland the marketing body for cruise tourism in international markets about membership with the aim of increasing cruise tourism into 2016 and beyond.

Marine Infrastructure

Greencastle, Teelin and Mountcharles pier pontoons were put in place but have been removed from the waters for protection from storm damage during winter months. They will return in the Spring. The new pontoon is in place at Bunagee Harbour and will now be featured in the Welcome Anchorages publication in 2016.

Sliabh Liag Branding and Website Development

The Sliabh Liag Facebook page is growing from strength to strength with over 4963 likes on the page. The Facebook page has been set up at www.facebook.com/sliabhliagexperience The website www.sliabhliag.com is now live and has already received several thousand visitors. A number of promotional materials have been developed including a brochure, flyer, nomadic stand, pop-ups and online banners that will be used in the future promotion of Sliabh Liag.

Fanad Lighthouse

The Fanad Lighthouse Facebook page is performing well. https://www.facebook.com/fanadlighthouse and has over 1574 likes. A new manager has been appointed to Fanad Lighthouse and will begin work in December 2015 at which point training will be provided by Donegal Tourism Ltd for the new manager on the booking engine and website CMS. World Boat Angling Championships

The World Boat Angling Championships took place in Bundoran and Mullaghmore in September 2015 and MalinWaters provided sponsorship and other support such as digital marketing. 22 teams of 5-8 anglers from all over the world took part in this week long event.

Crana Fest 2015

The Crana Fest 2015 kayaking event took place in October 2015 in Buncrana with sponsorship from MalinWaters. The event was very well attended with competitors taking part from Ireland, Scotland the UK and further afield. The event was organised by Moville based company Inish Adventures. The event continues to grow year on year.

All Ireland Rowing Championships 2016

A new website has been development to promote rowing and the All Ireland Championships in Donegal www.donegalbayrowingclub.com
The website features a blog, social media integration, e-mail marketing options etc. Training will be provided to the rowing club members so that they can update the Wordpress CMS system themselves.

Tides of Time Project

The final Atlantic Area Programme manual has not been published however the project is still being developed. A list of over 15 interested partners in this project has been compiled. The proposed Atlantic Area Programme project called 'Tides of Time' is in circulation to potential partners around Europe including Sail West partners. Expressions of interest have been received and the EU Unit are working to determine the best project partners to form consortium. This project incorporates both education and tourism in the development of a marine touring route of locations where marine events of historic significance took place such as the Spanish Armada,

World Wars etc. Donegal has a huge amount of shipwrecks. This project seeks to educate, to conserve and enhance locations of historic importance and to promote the coast a location of marine heritage and history. It is likely that the call for submission of applications will now take place in January 2016.

NEA 3 Project

Donegal County Council is working with the council in Brittany on NEA 3 an Atlantic Area project. Applications will be submitted for consideration in Q1 of 2016. Donegal County Council has specified the areas of interest to them as part of this project that would provide the best benefits for Donegal. The project is based on the development of three centres of excellence including tourism, waste and seaside sports, industry & trade services and pleasure boating, ports development. The project seeks to develop a 'Destination Atlantic' to promote marine tourism activities on the Atlantic coastlines. Donegal County Council has made suggestions as to a new name for the project as requested by Brittany County Council.

Sail West

The new Sail West Marketing Plan has been completed and is currently under review pending approval from partners. (A full update is available in the Sail West report).

Project Targets for the next bi-monthly/quarter 4 reporting period

WILDSEA Europe Project

Following the recent meeting in Donegal, it has been agreed that Donegal County Council will be responsible for the video production element of the project. Procurement for this video production element will take place in Q4 of 2015 with a view to completing the video in the Spring of 2016. Partners are providing footage from every region along the route. Procurement for the new website has been completed and a company in Spain appointed by lead Spanish partners. Arranmore Island Website

Work has commenced on the new website for Arranmore Island with an expected completion date in December 2015. The island community groups are working to develop content, a new CMS has been installed and the website is being converted to a mobile responsive design.

Fanad Lighthouse Developments

The new Fanad Lighthouse manager will be provided with training by Donegal Tourism Ltd on the new website CMS, booking engine and donation system with a view to handing over the management of these systems. The Facebook page and website will continue to be updated and managed by Donegal Tourism Ltd until January 2016. Bookings have been received for the Christmas period and this is when the lighthouse is expected to open pending no complications.


Donegal Public Participation Network (PPN) is delighted to be launching this newsletter to provide community organisations with an update on the work of the PPN.

TUAIRISC CHUN DÁTA AR AN LRP / PPN UPDATE

Donegal PPN is being managed by a 19 person secretariat that were selected at the inaugural meeting of the PPN in November 2014. The secretariat members are drawn from Environment, Social Inclusion and Community & Voluntary organisations as well as groups that are located from within each of the five municipal districts of the County.

The main function of the PPN Structure are to ensure that community based organisations are afforded an opportunity to influence Local Authority Policy through participation in it's various structures. The Donegal Age Friendly Strategy, launched in May 2015, is a multi stakeholder strategy which aims to make County Donegal a great place to grow old in, so the County can be enjoyed and appreciated by everyone for it's quality of life.

One of the actions contained in the Age Friendly Strategy is the establishment of the Donegal Older Person Forum. COSME

Programme for the Competitiveness of Enterprises and SMEs 2014-2020

The project, HikingEurope was successfully submitted to the Executive Agency for Small and Medium-sized Enterprises' (EASME) COSME second call for "Supporting Competitive and Sustainable Growth in the Tourism Sector" under theme 2, "Diversifying the EU tourism offer and products -Promoting transnational thematic tourism products" on the 30th June 2015.

Donegal County Council were invited by the Spanish Catalan Tourist Board to join their consortium of partners who are located in Spain, Italy, Croatia, Germany and Austria. HikingEurope, if successful, will look to tackle the issue of tourism diversification in European regions that have traditionally focused and benefitted from mass tourism but are willing to commit to a more sustainable, responsible and highquality alternative based in less explored European areas, specifically in inland/rural locations.

The project will place a focus on hiking activities considered as a unique way to unveil the local heritage in a sustainable manner, while contributing to physical activity and thus to a better health and quality of life of citizens. Stage 1 Project TIDAL concept bid to the North West Europe Interreg VB Programme.

Donegal County Council led a Stage 1 concept project bid to the North West Europe Interreg VB funding programme. This transnational financing programme seeks to encourage public, scientific, private and civil society organisations to cooperate with a view to improving the economic, environmental, territorial and social development of Europe's regions. The region covers Ireland, Uk, regions of France, Belgium Netherlands and Germany and is one of the European Unions programmes that finances large scale capital projects. The project is titled - TIDAL and is an acronym for Technology Innovation Demonstration and Learning and

involved a transnational consortium from Ireland, UK, France and Belgium.

In July 2015 Donegal County Council as the lead project partner were informed that project TIDAL had successfully passed the stage one concept and were invited to submit a 2nd bid to the more detailed stage of the process in December 2015. Work has recently commenced on this bid with Donegal County Council and LYIT playing host to the first partner meeting on21st & 22nd September. The meeting was attended by all partners including the NWE programme project officer. The two day meeting was detailed and with the programme project officer in attendance it was the forum to discuss all detailed matters relating to the project. The detail of the project and the content of the stage 2 project are still under discussion and a decision taken on the most appropriate course for the consortium. PROJECT TIDAL Workshop in Lille 7th & 8th September

Donegal County Council as lead partner on project TIDAL was invited to attend a workshop hosted by the North West Europe Programme in Lille, France on 7th and 8th September. This event provided all applicants who were successful at the Stage 1 of the application process with an opportunity to meet with the Programme secretariat and other project promoters. The workshop provided information to project leads on the next phase of the application process and the programme team were on hand to advise on the stage 1 project feedback provided by the monitoring committee.

The stage 2 bid opens in October 2015 and closes by 30th December 2015. The project bid is being lead by Donegal County Council with full partner commitment and input from Letterkenny Institute of Technology. Other project partners are from France Belgium and private industrial partners. The first full Tidal Partner meeting took place on 21st and 22nd September in LYIT, Donegal and also attended by the project officer from North West Europe. Donegal County Council are now exploring the stage 2 requirements and the timeline for completion of the project by December 2015.

Transnational Interreg VB Project: HERICOAST

Donegal County Council are a partner in a project application entitled 'HERICOAST' which is an acronym for 'Management of Heritage in Coastal Landscapes'. The application was submitted to Interreg Europe which is a transnational Interreg VB **European Regional Development** fund programme, in July 2015 by the lead partner, Vest-Agder County Council, Norway. The project aims to improve regional policies for heritage management in maritime and fluvial regions across the 8 partners comprised of county and regional authorities from France, Spain, Italy, Romania, Lithuania; Clue University Amsterdam and Civilscape landscape forum Europe are advisory partners. In Donegal



the project will focus on a range of coastal settlements and their unique and valuable maritime heritage and aim to improve the existing policy instruments in place and thereby revitalize coastal communities. In the context of the wider project, Donegal will contribute to, and be informed by the wider shared experience

across the partner regions within their coastal landscapes. Claire Mc Callan, Conservation Architect and Alana Green, Executive Planner from the Central Planning Unit have worked closely with the EU Unit and Vest-Agder County Council, Norway to formalize the application. A decision on the application will be made by the Monitoring Committee of Interreg Europe in Luxembourg in early December 2015. SCALE Project Steering meeting, Brussels June 2015

In June, the EU Unit and Social Inclusion Unit staff travelled to Brussels to attend a two day project steering meeting of potential partners for a project titled "SCALE - SCaling up Assisted Living in Europe". This project has emerged from the members of the CORAL Network which is a European network of regions collaborating in the field of Ambient Assisted Living and Active and Healthy Ageing. Project SCALE aims to identify innovative solutions

and create effective ecosystems for Active and Healthy Living by building on partners' experiences, via mutual learning /knowledge transfer events and sharing of good practices in order to identify common approaches that can support policy goals. The meetings in Brussels were very informative and Donegal County Council submitted its application, along with 24 other partners, as part of the overall project proposal to Interreg Europe on the

31st of July. If successful, this five year project will commence in 2016 and will link with the Donegal Age Friendly Strategy which was launched by Daniel O'Donnell on May 22nd of this year.

WILDSEA Europe

The EASME EU funded WILDSEA Europe project was launched in July 2015 in Barcelona and is led by lead partners Travelecoology from Spain. Mr. Garry Martin from Donegal County Council was in attendance at the launch and has joined the project Steering Committee.

The project seeks to develop a touring route based on the wonderful variety of marine biodiversity and wildlife along our European coastlines, while at the same time looking at methods of conservation of our marine biodiversity and protection for future generations. The project includes elements of research and conservation in addition to the marketing and promotion of an EU wide marine wildlife and biodiversity trail called WILDSEA Europe. Donegal County Council will have a number

of key responsibilities in the project including communication, marketing, video production and much more. Malin Head has been chosen as a key pilot area for the WILDSEA Europe project due to its rich wildlife and biodiversity, including the basking shark and dolphin population.

Donegal County Council was pleased to host the recent meeting of the WILDSEA Europe delegation. Partners from all over Europe came to Donegal from the 7th to the 9th of October. The project partners also attended the **Donegal County Council Wild Atlantic** Way Tourism Conference which took place on October 9th. The Cool Route project continues to develop following the successful bid for INTEREG VB funding under the Northern Periphery & Arctic programme 2014-2020 by lead partner Cork Institute of Technology. Project partners include Glasgow Caledonian University, Royal Cork Yacht Club, Derry City Council, Port Authority Torshavn Faroe Islands, Blue Seas Marinas Scotland, Western Norway Research

Institute and associated partners Donegal Tourism, the Irish Cruising Club and Sail Scotland.

Cool Route partners are delighted to welcome Údarás na Gaeltachta who have recently joined the Cool Route project as an associate partner. Udaras na Gaeltachta will be hosting a meeting at their offices in Cork this September where CIT will present the Cool Route project to County Council Directors of Service from all along the West Coast of Ireland. This will be an excellent opportunity to discuss the project in detail and to look at potential ways to maximise the positive impact on sailing along our joined west coast.

Donegal County Council is a project partner on the Cool Route project and has responsibility for the communications and product dissemination element of the project. The project merges all aspects of the practical logistics and business potential to establish a bi-directional yacht cruising route along the offshore areas of the Northern Periphery Area, stretching from the South of Ireland, to the UK (Northern Ireland and Western Scotland) on onwards to Norway. CLEAN-Technologies and open innovation for low carbon regions

The common challenge addressed by the CLEAN project is how best to meet EU low carbon targets in Europe's regions, focusing on how to decrease energy consumption in existing buildings. Buildings are responsible for 40% of energy consumption in the EU and consume between 8 and 12 times as much heating oil as new

ones. The overall objective is to work together between 2016-2020 to improve the energy performance of the built environment by 4% in the project regions. The expected changes will be better performance in 7 policy measures that address low carbon. This will be as a result of greater focus in policy instruments on: 1) Better design of services and products in the regional energy efficiency market; 2) Improved promotion of the products and services to building occupiers. This will benefit all stakeholders in a region's energy value chain, i.e., consumers of energy services, suppliers of energy products and services, centres of energy expertise (including innovation) and public authorities (promoters of energy efficiency).CLEAN proposal was submitted by ERNACT to the 1st call of the Interreg Europe Programme. Decisions are expected in December 2015.



(Involving The Community To Co-Produce Public Services)

This is a project led by ERNACT and with the participation of Donegal County Council and Derry and Strabane County Council and which was approved in the 1st call of the Northern Periphery and Arctic Programme. With a total budget of €1.5 million and €560,000 specifically ring fenced to benefit the North West region, IMPROVE aims to increase the level of innovation in the six partner regions in the field of technologydriven public service solutions. It adapts a novel living labs-driven approach to maximise knowledge transfer between regions and stakeholders.

Real communities will demonstrate the approach by using it to coproduce services, and develop tools and methodologies for use by other regions to implement the results of the project. The project was officially launched with the kick-off meeting celebrated in May 2015 in Letterkenny (Donegal). The main work at the moment is focused in partners documenting and sharing the good practices coming from their regions that will serve as a basis to develop the common methodology that will guide the development of the future public services planned in the project. In order to widespread these good practices the project started in September a series of 9 webinars that will last until October 2015. The launch conference will take place on 10th and 11th November in Bifrost (Iceland).

Smart Creativity Hubs

This project addresses the challenges created by ongoing advances in production processes, digital technology and new materials on the business and operating models of enterprises in the design-led sectors. This includes enterprises in the fashion and textile sectors and those producing ceramic, wood and artisan food products.

These challenges occur predominantly in peripheral or older manufacturing areas of the NWE that do not have the market size or modern innovation infrastructure needed to overcome them. The project's novel approach will network or cluster distinct strengths



in new technologies, materials and processes from existing organisations across NWE to effect a critical mass of new innovation services for enterprises, regardless of location.

The proposal, submitted by ERNACT has been selected by the North West Europe programme to enter into stage 2 and will be submitted at the end of 2015. Only 19 out of 82 project ideas have been approved to get to stage 2 which is very promising.

NICHE - BUILDING INNOVATIVE FOOD VALUE CHAINS IN **REGIONS**

The NICHE project aims to support the food sector as a whole to face its major challenges that arise from changes in the sector's economic

and non-economic environments. The availability of safe, sustainable and healthy food has taken a new and pressing dimension in the light of an ever-growing global population and increasing environmental and sustainability concerns. Technology has already substantially re-shaped the business models, value chains and efficiencies in this sector, but a new wave of driven innovation is needed to give response to this new demand.

A special feature of the food production sector in Europe is that the 99% of the enterprises, generating 50% of the turnover, are SMEs. These current challenges cannot be met by any individual enterprise but require concerted actions and coordination of initiatives.

Aware of the role that innovation may have in giving response to this demanding sector, the NICHE project wish to realize its potential by effectively promoting policies in 7 European regions where food has been identified as a key sector to apply existing research and innovation strengths.

By working together the NICHE partnership aims, by 2019 and through the improvement of existing policies, achieve an average 15 % increase in the adoption of research and innovation solutions by food sector companies in their regions to give response to the demand of this sector identified as high-potential sector for their smart growth.

NICHE proposal, prepared by ERNACT and with the participation of Donegal County Council and Derry and Strabane District Council as partners, was submitted to the 1st call of the Interreg Europe Programme. Decisions are expected in December 2015.









Sliabh Liag **Project**

Excellent progress has been made on elements of the Sliabh Liag project, co-funded through the INTERREG IVA Cross-border programme and the Failte Ireland's Tourism Capital

Investment Programme funded under the National Development Plan 2007-2013.

Construction works have been completed to both the access road (Carrick – Ranger Station) and existing par park (Ranger Station). Visitors to Sliabh Liag have been utilising the new extended car parking facilities at the Ranger Station throughout the summer of 2015.

The Visitor Centre / Transportation Hub at Teelin village is programmed for completion in September 2015. The new centre when operational will provide parking, services and other facilities and enable management of visitors accessing the cliffs.

A communication and marketing plan has been developed and implemented, incorporating online advertising, photography and creation of a new Sliabh Liag website www. sliabhliag.com.





Enterprise Europe Network

Enterprise Europe Network is made up of over 600 business support organisations in over 50 countries from both within and beyond Europe. The Network helps small business make the most of European and international markets, facilitates them to explore new opportunities and assists them in accessing both new technologies and funding. Donegal County Council through the Local Enterprise Office is one of four national partners delivering the project in Ireland for the next six years and the Local Enterprise Office will manage both the activities of all 31 Local Enterprise Offices and the budget for these activities over this period. The other project partners are Enterprise Ireland (Lead), Dublin Chamber of Commerce and Cork Chamber of Commerce. The project is funded under the COSME Programme for the Competitiveness of Enterprises and SMEs 2014-2020.

Ms Eileen Kelly, has been appointed coordinator of the project within the Local Enterprise Office and the project was officially launched by Council Chairman, Kieran Brogan on July 21st in Letterkenny. The project has an overall budget of €4.78M for the six years with some 55% of the budget dedicated to the Local Enterprise Offices. International SMEs Everywhere Project (ISEP)

SMEs are much more likely to survive and grow in the current competitive global business environment if they can internationalise. We also know that SMEs that do enter international markets or internationalise are more innovative and more resistant to local and national crisis. The Local **Enterprise Office in Donegal County** Council is partner to an application submitted under Interreg Europe by HAMPSHIRE County Council, as the lead partner, that involves partners from eight countries across Europe -Ireland, Austria, UK, Denmark, Italy, Czech Republic, Poland and Spain. The project aims to identify good practice in the area of internationalising of SMEs, facilitate each participating region develop robust action plans to assist SMEs internationalise, identify national and regional policy issues and recommend policy and programme changes to enable greater levels of internationalisation to happen. It is hoped that a decision on the application will be made before the end of the year. If the application is successful Donegal Local Enterprise Office as a key role in the project with regard to identifying and codifying best practice within the project and in facilitating the project workshops. ReNew Project

Renew project looked at the fish waste industry in Donegal and an appraisal was carried out by consultants on behalf of Donegal County Council and Inishowen Development Partnership in 2015. It outlines the scale of Fish Waste in the pelagic, demersal and aquaculture sector in Donegal. An objective of the ReNew project is to deliver innovations for the waste supply chain, promoting recovery of valuable materials from waste.

Information provided by our partner the Technology Centre for Bio-refining and Bio-energy (TCBB) demonstrates that through selective enzymatic processing, collagens for cosmetic applications, gelatins for food applications and bioactive peptides for biopharmaceutical applications can all be recovered. For mature sludge anaerobic digestion with another carbon rich bio mass waste is the best approach.

The report highlights the approach taken in Scotland of all stakeholders coming together in planning an integrated solution to fish waste issues. With developments in Killybegs including the planned construction of a state of the art Biomarine plant there is opportunities in maximising the commercial value of what too now has been considered waste. New discard rules will increase the volume and potential for developing commercially viable alternatives, these could include markets for dried heads and frames of fish in African countries where it is seen as a cheap source of protein. The Renew project ran from 2013 – 2015 with Donegal County Council joining the consortium in early 2014. The project has been valuable to Donegal and to the sector and has assisted in examining a growing market and economy for the region.

The Peace III Pettigo/Tullyhommon - Termon Project is now completed. The Project was led by Donegal County Council and partners included, Association for the Development of Pettigo and Tullyhommon (ADoPT) and Fermanagh District Council. Since 2011, the Project activities have regenerated the twin villages of Pettigo and Tullyhommon. Outputs have included creation of a riverside walkway straddling the Donegal - Fermanagh border, streetscape improvements, extension/ refurbishment of the Methodist Hall, development of a purpose built childcare facility and a paint scheme for business and residential properties. At the core of the Project is the Termon Complex which is a state of the art community centre.

The Complex features include a gym, multi purpose hall suitable for a variety of sports, concerts, stage

productions, exhibition space, coffee dock and also meeting/conference rooms. In the adjacent grounds are a multi use games area (MUGA), landscaped gardens and playpark. In addition to the capital aspects of the Project, ADoPT implemented a Community In Action Plan which involved activities and events that have encouraged greater cooperation on a cross border and cross community basis.

The project is an achievement and tangible result of the Interreg cross border collaboration programme and is a long term legacy of which the village and surrounding locality will benefit for years to come. Centre for Cross Border Studies Workshop for Interreg VA River Restoration Project

Joint management of the environment has been identified as a key economic challenge for the INTERREG VA Programme. On the 31st July 2015, the Centre for Cross Border Studies (CCBS) facilitated a project development workshop focusing on Specific Objective 2.4 aiming to "improve the water quality in cross-border river basins" using the Impact Assessment Toolkit for Cross Border Co-operation.

Within the Programme area, Ireland and Northern Ireland share 11 cross-border river basins. A greater level of cross-border collaboration between both jurisdictions is needed in order to improve freshwater quality and contribute to compliance with the Water Framework Directive requirements.

Led by the Environment section of Donegal County Council in

partnership with AFBI (Agri Food and Bio Sciences Institute), University of Ulster, Blackwater catchment, Geological Survey Northern Ireland and Loughs Agency are developing a river restoration / catchment management project under this call.

The proposed INTERREG VA River Restoration project will address the problem of how to restore or maintain good (or high) status on a catchment specific basis in three cross-border catchment (e.g. Blackwater, Melvin and Finn) taking into consideration both surface and groundwater. Tides of Time Project Update

Apply Skills and Conserve our Environment with New Tools

The EU Unit of Donegal County Council is currently working with the Errigal Stakeholders Committee to identify funding opportunities for Errigal Mountain. The Committee's overall aim is to cater for the growing number of visitors to Errigal while minimising the environmental impact and creating opportunities for local communities. In response to the challenges being experienced on the site, and to negate environmental impacts, Donegal County Council, in partnership with the National Parks & Wildlife Service, the local community and other stakeholders wish to undertake a project in partnership with other regions to develop sustainable environmental

management tools and techniques. This will be known as the ASCENT Project - Apply Skills and Conserve our Environment with New Tools. Errigal Mountain Path Study In July 2015, the Committee commissioned a study, the Errigal Mountain Path Study, to secure expert advice on how to address the recreation-induced erosion at Errigal and how to best care for this iconic mountain into the future. The early findings of the study indicate that it is a long term project, which will require significant funding to develop a vision for conservation management and protection of Errigal.

The EU Unit intends to further explore the Northern Periphery & Arctic 2014-2020 Transnational Cooperation Programme as a fitting funding programme for the ASCENT Project as it has a strong priority focus on 'Protecting, Promoting and Developing Cultural and Natural Heritage' and specific objective 'Increased capacity of remote and sparsely populated communities for sustainable environmental management'. EU Unit Submission to preconsultation process for the preparation of Donegal County Council Killybegs Local Area Plan.

Donegal County Councils Development Planning Unit initiated pre-consultation on the preparation of a Local Area Plan for Killybegs. An invitation for submissions was extended to the public during August 2015 and closed on 11th September 2015. The EU unit on behalf of a Killybegs working group consortia lodged a submission to address and identify areas for consideration during the plan preparation process. Such areas for consideration are based on the work undertaken to date on the development of the Northwest region for marine renewables, food product development and tourism innovation.

This three sector focus is the subject of this submission and is based on the work of a stakeholders consortium led by Donegal County Council, and which includes a range of relevant partners, including Letterkenny Institute of Technology and Bord Iascaigh Mhara.

Work has been ongoing for a number of years on the development of an Innovation centre based in Killybegs with a particular emphasis on the marine economy in Killybegs and the 3 sector focus of activity. The aim of the project is to capitalise on the very rich marine resources available to Donegal and the North West Region as a whole.

It is also intended through this initiative to capitalise on the physical and human infrastructure and valuable resource that exists across a range of sectors and business activities in the Killybegs Marine Hub. Regions, EU Institutions and Policy-Making – Online Course

Heritage Streets Alive 2015













Heritage Streets Alive 2015 was launched in June 2015 and is a cross-border cross-community regeneration project. The aim of the project was to invite local people from three historic streets in Donegal and Derry to showcase the strengths of their streets and to cocreate a better future for them. The project was funded by the Heritage Council of Ireland, and co-partners Church Lane Campaign Group, Holywell Trust, Peace Walls Project, International Fund for Ireland, Derry City and Strabane District Council and Donegal County Council. The Project involved the streets of Church Lane in Letterkenny as well as Fountain Street and Chamberlain Street in Derry.

The participants visited each of their streets and at later workshops shared great stories of the things that make them special and unique – past and present. The project went from an inquiry into these street's many strengths and leapt forward into a better future with a workshop to co-create visions for each of the three historic streets. Creating three street visions was a key milestone in this project and the main finale seen

each of the streets come alive on the 29th of August as part of National Heritage Week 2015 when each street hosted a special day of culture and showed each of the 3 streets 2020 vision in a fun and creative way.

The project was the vision of Mary Kerrigan who is the project leader and a Built Environment Educator and Creative Visionary. Participants and co-funders/delivery partners are extremely positive about the emerging benefits of the project, especially in its capacity building and groundbreaking community engagement which showcased the enthusiasm, commitment and support for the project from all involved. The opportunity to upscale this project over a longer period of time is something that is being explored.

Waste Awareness

Adopt a Road 2015 / 2016:

Applications for the Adopt a Road 2015 / 2016 scheme have been sent to Tidy Towns groups that entered the 2015 national competition. The closing date for applications is Friday 13th November 2015.

LA 21 Environmental Partnership Grant 2015:

This an annual grant administered by the Department of the Environment. It was advertised both nationally and locally in August 2015. Donegal County Council received an allocation of €15,700 with matching funding to be provided by Donegal County Council. A total of 19 applications were awarded funding for a wide variety of projects.

Waste Enforcement Report

Halloween Bonfires.

Donegal County Council Mobile Litter Units and Litter Wardens were involved in the removal of waste materials stored at 5 locations around the County.

Additionally the Council removed over 800 tyres illegal dumped on the run up to Halloween, which potentially could have been used to build bonfires.

This happened after the Council appealed on Radio for the public to report such illegal activities in their communities.

The harmful consequences to burning waste cannot be underestimated and the Council is committed to preventing such activities, should the opportunity arise.

Smokey Coal.

Donegal County Council Environment Enforcement personnel attended the annual 'Smokey Coal' conference in October, hosted by Leitrim County Council. It was important to note that the problems around Smokey Coal enforcement are similar in most other Local Authorities.

Council staff are currently conducting enforcement activities around this legislation, involving site inspections of retailers and distributors as well out of hours vehicle inspections in Letterkenny to prevent the illegal sale and distribution of unauthorised fuels.

The Council is currently using Public Service Announcement on Radio about the enforcement of the Smokey Coal Regulations.

Brown Bins.

Donegal County Council waste enforcement personnel are conducting a series of inspections of household waste collector's premises to ensure that there is an effective roll out of Brown Bins in all localities that fall under the current Regulations.

Environment Complaints 2015 = 914 Fixed Penalty Notices served under the Litter Pollution Act 1996 (Litter Fines) = 126 Paid = 53

Cases before the Courts for unpaid Fines = 14 Successful prosecutions for 2015 = 4.

Beach Report.

Beach Improvement Works

Work continues at a number of our beaches to improve access for visitors of all abilities. This includes:

- Murvagh: A new boardwalk access path will be installed from the car park to the beach. This followed extensive survey work and approval by the NPWS in this Special Area of Conservation. Chestnut paling fencing will also be erected to restrict access to the beach across the dunes which have become badly degraded over recent years. Having beach access restricted to one dedicated, fit for purpose, access path will allow the dunes recover and resolve this issue which was of concern to An Taisce and the Blue Flag status of the beach.
- Fintra: A new plinth is being installed adjacent to the beach car park to accommodate the seasonal Lifeguard Station. This will allow better patrolling of the beach by the Lifeguards during the bathing season. It will also free up spaces in the car park which is limited in size and frequently congested.
- Carrickfinn: Access improvements to Tra Bhaide (Carrickfinn) are nearing completion. This development was supported by Coiste Tra Bhaide installing a hand rail, extending access path and reducing the slope of same.
- Shrove: A new boardwalk access path is being installed from the car park to the beach. This will replace the traditional access path which was extremely steep and had become a hazard following years of degradation. Chestnut paling fencing will also be erected to restrict access across the dunes which have become badly degraded.

Dear Bridie,

I refer to your letter asking for clarification on the request to have a meeting with the Donegal electoral area at their November meeting. The main reason for the meeting to seek clarification on how the surf schools are going to be able to safely access Tullan Strand as the current slope has almost been completely destroyed by rain showers and will not last the winter storm season. The council (Garry Martin and Liam Murray) asked the four surf schools to fix the slope 2 years ago. We each contributed €1250 to hire a contractor at a cost of €5,000. The temporary job that was done has lasted till now (2 seasons). This work will now need to be done again to prepare the slope for season 2016. This will be the third time the surf schools have funded repairs in the last 7 years. Given that Donegal Co Co has 450k allocated and has repeatedly "committed" to sorting this problem the four surf schools have decided that we are not going to pay to fix private property belonging to someone else.

The traditional surf school season starts on the 1st of April. This gives the council less than 5 months to sort the issue. When the slope was washed away in January 2015 Garry Martin give a commitment to get the slope sorted. In 2014 money was allocated from Bundoran Town council.
