**MINUTES OF THE INISHOWEN MUNICIPAL DISTRICT MEETING  
HELD IN THE CHAMBER, CARNDONAGH PSC  
ON THE 13<sup>th</sup> OCTOBER 2015**

**15.52 CONSIDERATION OF THE MINUTES OF THE INISHOWEN MUNICIPAL DISTRICT MEETING HELD ON 15<sup>th</sup> SEPTEMBER 2015**

On the proposal of Cllr Bernard Mc Guinness, seconded by Cllr Martin Mc Dermott, the minutes of the Inishowen Municipal District meeting held on the 15<sup>th</sup> September 2015 were agreed.

**15.53 HOUSING AND CORPORATE SERVICES**

**HOUSING**

**53.01 Update Report on Housing**

Lynda Mc Gavigan presented the Housing Update Report to the members.

**53.02 Housing Programme 2015**

Further to the motion discussed at the Council meeting on Monday, Cllr Farren advised that the cost of building a property is expensive and called for a meeting with the executive, and suggested purchasing properties as opposed to building as there is a quicker turn around time. Cllr Farren also enquired as to how much of the 8 million budget has been allocated to Inishowen.

Cllr Mc Guinness reiterated the point and asked 'why are we still going to build when there are properties for sale at Donagh Park'. We should have the right to purchase instead of building. If the Council purchases the houses in Donagh Park more tenancies can be created.

Cllr Doherty suggested that value for money needs to be achieved, properties are being offered for sale at good rates.

Cllr Canning advised that if houses are built there could be a problem with the capacity of the current sewerage network.

John G Mc Laughlin advised that the housing programme provides for the purchase of properties, Community and Voluntary options and new builds.

The properties at Donagh Park can be looked at and the members updated. However cap's are laid down by the department. Cllr Donaghey was advised that the Council can purchase properties up to a point.

John G Mc Laughlin arranged a workshop with the Director and the Divisional Manager of Housing for the 21<sup>st</sup> October 2015 at 1pm in Carndonagh.

Cllr Mc Guinness advised that 30% of people that are offered a council house refuse. Cllr Donaghey iterated that most applicants want a council house,

Cllr Mc Dermott advised that housing applicants from rural areas are choosing urban areas as a preference on their housing application forms because that is the area in which the greater amount of housing is provided, as there is no rural social housing and suggested that priority should be given to the purchase of properties in rural areas.

Cllr Mc Dermott read from a letter he received from Alan Kelly, Minister for Environment, advising that it was up to the local authority to provide what ever combination of options available based on the housing need.

#### **15.54 Deputation – Pastures New**

William Mc Laughlin introduced his social farming project, Pastures New,

This is a unique project that runs perfectly with the HSE's new direction policy, which provides personal support services to adults with disabilities.

Research is widely available and the project has made a great difference to the participants.

There are endless possibilities for the development of the project and a business plan is in place. The project is backed by the HSE, Department of Agriculture and Donegal County Council.

The group requested the support of the Council to prioritize the project as an Interreg project. The members thanked William for the presentation, agreed to support the project and wished them every success.

#### **15.55 Minutes Silence**

On request of Cllr Donaghey the members observed a minutes silence in respect of Carrickmines tragedy. A book of condolences has been opened in the PSC. The members also extended their condolences to the family of Garda Tony Gordon. Cllr Doherty remembered the homeless man in his 30s who died on the streets of Dublin.

#### **15.56 Planning**

##### **56.01 The Local Economic and Community Plan**

Sinead Harkin presented the Local Economic and Community Plan. The purpose of the plan is to identify and implement action to promote and support the economic and community dimensions of the county over a 6 year period. It will be the agreed framework of activity for the county and it's not a funding programme. The role of the municipal district is to consider the draft plan and its consistency with the core strategy and objectives of the CDP 2012-2018, the border regional planning guidelines 2010 and that the community elements and the economic elements are consistent with each other.

The consultation phase included the statutory consultee's being notified, public consultation period and focus groups/meetings.

The 7 priority goals are

1. Promote Donegal as a connected place
2. To harness Donegal's natural and human capital
3. To value and develop our culture and creative resources
4. To promote sustainable, inclusive and healthy communities
5. To develop Donegal as a lead region for learning, research and innovation
6. To develop the Donegal brand
7. To promote entrepreneurship, investment and enterprise

Cllr Farren requested that Merville be included in the Tier 2 Towns, this was seconded by Cllr Mc Guinness. The current 2 tier towns in Inishowen are Buncrana and Carndonagh.

Cllr Doherty expressed the concern of Carndonagh Tidy Towns in relation to the abandoned building and the ownership of properties and enquired if there was a deadline to participation. Cllr Canning commended the work done.

Sinead Harkin agreed to bring the comment back.

On the proposal of Cllr Mc Dermott and seconded by Cllr Canning the draft plan was formally agreed.

#### **56.02 Planning**

Sharon Mc Morran presented the planning update report.

#### **56.03 Planning Section**

Cllr Farren advised that he was not happy with planning section leaving Carndonagh and suggested that someone from planning be located in the PSC full time and iterated that he is not happy with the response that he is getting when placing a call to Lifford.

#### **56.04 Unauthorised Development**

Cllr Doherty requested that an unauthorised update report be brought to the meetings. Cllr Ryan advised that there is a serious situation with commercial and unauthorised developments. Cllr Canning enquired if the European directive could be examined in relation to unauthorised waste recycling facilities, in that under a European directive, the only way of proceeding for permission to regularise the use would be to remove the building, take the site back to its original state and then submit a planning application for the development.

#### **15.57 Community, Development & Enterprise**

##### **57.01 Update Report**

Aideen Doherty presented the update report to the members.

##### **57.02 Donegal Diaspora Website**

For the period January to September 2015, there are 90 unique users to the website from 136 countries worldwide.

##### **57.03 Tip O' Neill Irish Diaspora Award**

The members were thanked for their participation in the programme.

##### **57.04 Community Tourism Diaspora Initiative 2015**

The funding drawdown process is ongoing. 55 of the 64 events have taken place. Event organisers are urged to return the necessary documents for funding draw down. Inishowen tourism is holding an event in November 2015, more detail will follow.

##### **57.05 Playgrounds**

The annual maintenance tender is to be advertised before the end of October 2015.

##### **57.06 Buncrana School Campus**

Donegal County Council is currently compiling the requested information and it will be sent to the Department over the next 2 – 3 weeks.

##### **57.07 Public Participation Network (PPN)**

PPN is providing links through which organisations from the community and voluntary sector have a voice on Council decision making bodies and structures. Cllr Doherty enquired as to the position in relation to nominating for the joint policing committee.

### **57.08 Donegal Gathering website and Facebook**

Donegal gathering statistics show continuous increase of visits to the website in 2015 compared to last year.

### **57.09 Donegal Youth Council**

Donegal Youth Council is running their 'Shake up Sports' initiative in Bunrana on the 20<sup>th</sup> October 2015.

### **57.10 Donegal County Museum Events**

As part of the Wainfest 2015, the museum is organising two events

- Tuesday 13<sup>th</sup> October 2015 – Children in the Workhouse
- Saturday 17<sup>th</sup> October 2015 – Scary Stories in the County Museum

### **57.11 New County Donegal Heritage Plan**

Members were advised that 10% of the Strategic Development fund is being allocated for the new County Donegal heritage plan.

### **57.12 Tidy Towns**

Cllr Donaghey congratulated the Bunrana and Letterkenny tidy towns committees on their success in the tidy towns competition. Cllr Farren concurred.

## **15/58 ROADS AND TRANSPORTATION**

### **58.01 Update Report**

Seamus Hopkins presented the update report on the roadwork's programme.

### **58.02 Road Safety issue at St Edney's School, Desertegney**

A request will be sent to Road Design to investigate the options for this location.

### **58.03 Road Subsidence at the Lenamore Road, Muff**

The location will be reviewed with Cllr Donaghey.

### **58.04 Provision of a footpath at the Big House, Ballymagan**

A footpath at this location has not been included in the 4 year programme agreed with the members, however the issue will be reviewed with Cllr Donaghey.

### **58.05 Tarring of the road from Cockhill chapel to Hilltown**

Area roads will review in context of the 2016 roads programme.

### **58.06 Vehicular access to Grianan Fort, Burt**

The road will be reviewed in consultation with Cllr Doherty.

### **58.07 Directional signage to the Car Park, Carndonagh**

Signage for vehicular traffic has been provided for the carpark. Additional signage for pedestrian traffic can be discussed with Cllr Doherty.

### **58.08 Safety measures at the Ballyloskey, Carndonagh**

The road will be reviewed with Cllr Doherty.

### **58.09 Road crossing at Bridge Street, Carndonagh**

Materials have been purchased to install a pedestrian island on the centre line of the road and to provide a barrier to tighten the turning radius at this junction. The work is to be completed this year.

#### **58.10 Bridge span at Binnion, Clonmany**

Area roads have visited the location with the Cllr Doherty to review this issue. The environment section will be requested to replace the signage.

#### **58.11 Yield sign at the Binnion Road**

A site visit was arranged with Cllr Doherty and additional signage has been ordered, area roads will be endeavouring to replace vandalised signage on an ongoing basis.

#### **58.12 Car park at Malin Head School**

Cllr Mc Dermott advised that there is water lying in the car park at the school.

#### **58.13 Directional Signage to Carn from Derry**

Directional signage has been designed and purchased. The erection of the signage is labour intensive and the signs will be erected when resources allow.

#### **58.14 Bree, Malin Head**

The road will be reviewed in the context of the 2016 roads programme.

#### **58.15 Lagg beach**

The location will be kept under review and the bollard will be moved as and when required.

#### **58.16 Provision of bus shelters**

It is intended to prepare a programme for the provision of bus shelter for presenting to the members at the December Municipal District meeting.

#### **58.17 Bridge between Carrigans and St Johnston**

The bridge has been surveyed by the road design bridge engineer and the most probable solution is to cast another concrete wall outside the existing wall to provide support. This is however complicated by what appears to be a sewer/septic tank discharging at this location. In the meantime area roads are reviewing the temporary edge protection at the location.

#### **58.18 Footpath at Carrigans Village**

The provision of a 250m footpath at Carrigans School has been included in the footpath programme for 2018.

#### **58.19 Causeway Road, Bunrana**

Cllr Crossan advised that the road coming into the roundabout from the Aghilly side is too straight and traffic is coming into the roundabout at speed. The location will be investigated in conjunction with Cllr Crossan.

#### **58.20 Pedestrian crossing at red row, Bunrana**

Area Roads will review this issue with Cllr Crossan.

#### **58.21 Footpaths on the Ballymagan Road**

A footpath at this location has been included in the 4 year programme agreed with the members.

#### **58.22 School signs at Cockhill School**

The issue will be forwarded to Road Design.

#### **58.23 Gulley's at Main Street, Bunrana**

Significant works have been scheduled at Main Street, Bunrana as part of the 4 year programme. The work will be prioritised in 2016.

#### **58.24 Road markings at Umricam, Buncrana**

Road design has prepared drawings detailing a review of the lining arrangements at this location. Area roads to review and implement when lining contractors are in the area.

#### **58.25 Directional signs for Dunree**

Additional signage has been ordered and this work is ongoing.

#### **58.26 Glencrow Junction, Moville**

A ghost island has been provided at this location as agreed during the road design visit to this location.

#### **58.27 The Green, Moville**

It is intended to continue to work in conjunction with FÁS in Moville and to discuss the surfacing of these paths in the Green as part of the 2016 programme of works.

#### **58.28 Salt Supply**

Sufficient salt is currently in stock with Carndonagh and Skeog. Additional deliveries are due within the next week and stocks will be maintained during the season.

#### **58.29 Junction near Dillon's garage, Manorcunningham**

NRDO have confirmed that they are currently finalising design with a view to getting a Task Order to a lining contractor for the N13 issued for this year's implementation. They hope to include localised improvements at this location.

#### **58.30 Safety issue at the school at Cloontagh**

It is intended to provide lining at this location when the lining contractors are next in the area.

#### **58.31 Sponsorship of Roundabouts**

It is intended to review improvements at the roundabouts as part of a parks plan for the Municipal District. Cllr Ryan advised that businesses are willing to sponsor the roundabouts.

#### **58.32 Cycle path on the road from Muff to Quigley's Point**

There is a separate funding channel for the funding of cycle paths. Area roads are to request that roads central consider including the hard shoulder of the R238 as part of any future cycle path funding applications.

#### **58.33 Upgrading of the 3 roads around Inishowen**

The issue has been raised with Roads central and there has been contact at a senior level with the Minister's office on progressing the matter.

#### **58.34 Roads at Malin head and Urbelreagh**

The road at Malin head was overlaid with DBM and surface dressed at the beginning of 2015. The Council's safety engineer has visited the location and her recommendations regarding traffic calming on the road have been implemented, these include horizontal traffic calming bars, "slow" and "slower" and solid centre lines.

The Bree Urbelreagh overlay project was deferred on advise from Water Capital section. This project will be completed once the water main works have completed.

Cllr Donaghey opened the meeting and welcomed everyone. Garry Martin advised that this is a statutory budget meeting to discuss the draft budgetary plan for 2016. In order to clarify the situation he advised that the executive is wholly satisfied that the budgetary process is in line with the legislative process and this has been confirmed independently via legal advice. The process is in line with section 102 of the Local Government Act 2001.

There is no prescribed format in the legislation and it's the executive interpretation of the procedure outlined in circular 05/2014 – section 2, page 5. The template may be customised as appropriate.

The Council is happy to use the discretionary form and the draft budget plan is presented in is the discretionary form.

He indicated that it is premature to attempt to know what the intentions of members are or what priorities will be set, prior to the plenary budget meeting. The budget will be presented on the 18<sup>th</sup> November 2015 and at that stage amendments can be made. The budgetary process does follow the requirements as set out in the legislation.

The members have the right to amend the draft budget plan as they see fit and the only limiting factor is the finance available.

It's a reserved function of the members and it's not outside the scope of the members to amend the plan, however the current position is the most realistic and practical solution available.

Cllr Murray advised that it is good to have the situation clarified and asked if there was a problem with the legislative process. He suggested that "would it not make more sense to have the plenary budget meeting then the municipal district meeting". Garry Martin advised that that would make sense and the current process is impractical, if not impossible, when we don't know what we are prioritising.

Cllr Mc Dermott suggested that the employment of a gardener for the Barrack Hill should come out of the main council budget and not form part of the strategic funds. Cllr Mc Guinness concurred. Garry Martin agreed to look at alternative options for funding.

Cllr Canning enquired about funding for Inch Level project.

Cllr Mc Dermott suggested that funding should be given to the smaller towns, to level the playing field, in the context of the tidy towns.

Cllr Canning enquired if the budget figure was the same as last year or are there any add on's and how is the budget distributed.

Garry Martin advised that the budget book is built on last years figures, with consideration given to any additional areas and outputs. The income and expenditure is reviewed and broken down into service areas. It's only when it comes down to the final allocation that the specific projects are looked at.

The strategic development fund is apportioned by the number of members per municipal district, the total budget is €740,000 with €180,000 for Inishowen.

Funding is allocated based on the services areas, for example, the fire stations, it's per location of station and budget is not divided per municipal district. It's important to note that the total cost of pensions has to be covered by the Council in the budget. The level of discretionary spending is very limited.

Cllr Canning enquired if the pensions for the water service are being passed on to Irish Water. Garry Martin advised that the issue has been raised and the position needs to be clarified.

Cllr Farren enquired if the strategic development fund and the members development fund would be the same this year.

Cllr Farren supported the funding for a gardener for the Barrack Hill. He enquired if funding/support could be made available for the clean up of the Moville area. Funding of the tidy towns should be included in the main budget.

Garry Martin advised that perhaps the Bundoran model could be looked at, using a blend of Tús Scheme, Tidy towns and the Council, also incorporating the Gateway scheme.

Cllr Farren enquired if anything could be done about the Class K stamp, it's not a budget issue but it would be good to have it clarified.

Cllr Murray enquired if funding could be provided for

- Community assisted schemes.
- Single street lighting
- Funding for footpaths to be provided from the County wide budget.
- Grianan an Aileach to be looked at as an area for tourism development.

Garry Martin advised that this could fit into a European funded project.

Cllr Doherty supporting the funding for the Barrack Hill, Carndonagh.

In relation to appendix 3 – Is €100,000 to be filled in there and the rest left blank. Could areas be missed?

Cllr Doherty enquired as to how the council can compliment the funding, that is the CEDRA funding of €250,000 for Inishowen and Leader funding.

Will the Council be seeking funding under EU opportunities?

Cllr Doherty enquired

- About the funding of Cockhill Bridge and if it could be prioritised for funding.
- Enquired if the St Louis trip will be funded centrally
- Funding for LIS instead of slicing off the top
- Funding of public conveniences – Irish Water, the council is responsible for the funding of the public convenience
- North West Region - The region needs to be given priority.

Garry Martin advised that the local property tax is there as well as various funding initiatives. The department has advised the council as to what funding is available from the local property tax for 2016, €22,720,760, the same figure as for 2015.

Cllr Mc Guinness

- clarification as to what the municipal district can and cant do
- Need to ensure that housing roads etc, that Inishowen is getting the same funding as the other areas.
- Tourism should be a county wide issue, will Malin Head be prioritised the same as Slieve League
- Ferry should be funded under a 5 year programme

Garry Martin advised that efforts are ongoing to create efficiencies across the Council and this will continue. Measures are in place to deal with the collection of outstanding rates including

the legal process. The town council's rates will increase this year and county council rates will reduce as part of the harmonisation process. In relation to staffing, a work force plan is in place and decisions regarding staffing will be updated at plenary level. The 3 year capital plan for 2016 – 2018 will be considered, with a meeting being held at the end of November 2015. Demands for additional monies have been noted and this will be fed back to the centre. The community composting issue will be forwarded to the environment section.

It's a formal requirement to adopt the draft budgetary plan with or without amendments. On the proposal of Cllr Mc Dermott and seconded by Cllr Farren the draft budgetary plan was adopted unanimously with the following amendments

## **New Tenant Purchase Scheme for Existing Local Authority Houses**

By Circular letter dated 17<sup>th</sup> of November 2015, the Council has been advised of the introduction of a new Tenant Purchase Scheme for Existing Local Authority Houses on 1<sup>st</sup> of January 2016.

The Scheme will operate under Part 3 of the Housing (Miscellaneous Provisions) Act 2014 under an incremental purchase model which involves discounts for purchasers linked to household income and a discount – related Charge on the property that reduces to nil over a period, unless the house is resold or the purchaser fails to comply with conditions of the sale. Where the tenant purchaser resells the property before the end of the Charge period, he or she is required to pay back to the Housing Authority a portion of any profits arising from the sale.

While there are a broad range of terms and conditions, some of the notable ones relate to tenant eligibility to purchase and the types of dwellings which may be sold.

Under the Scheme houses may only be sold to a tenant who has been in receipt of social housing support for a minimum period of one year and the tenant must have a minimum reckonable income of at least €15,000 per annum. In calculating the reckonable income, this relates primarily to income from employment including self-employment. Income from social welfare payments (including pensions) by the Department of Social Protection can be taken into account, but only where these payments constitute a secondary source of income i.e. a social welfare payment to a tenant in receipt of income from employment is reckonable income.

Tenants who are in arrears of rent will not be eligible to purchase under the scheme until such time as the arrears are paid or rescheduling arrangements are entered into and complied with by the tenant.

In relation to dwellings that may be sold, there are a number of exclusions including dwellings designated under the existing Incremental Purchase Scheme (in the initial five year period from the date of allocation of the dwelling), apartments and maisonettes/duplex units, houses designed for occupation by elderly persons and dwellings acquired through Part V of the Planning & Development Act in private estates.

The purchase price of the dwelling is calculated as the greater of the market value of the house or half the estimated cost to the Council of providing a replacement dwelling to current standards. In calculating the purchase price, allowance is made for any improvements carried out by the tenant but only where the tenant received the prior approval of the Council to carry out those improvements. An allowance is also made where the site of the dwelling was provided by the tenant to the council at a nominal sum.

A discount of 60% of the purchase price is available where the reckonable tenant income is between €15,000 and €20,000. The level of discount is reduced to 50% where the reckonable income is between €20,001 and €29,999 and to 40% where the income is equal to or exceeds €30,000.

Dwellings are sold in fee simple through a form of combined Transfer and Charging Order following the payment of the purchase monies (discounted purchase price). Where the tenant wishes to avail of a local authority mortgage, they will have to comply with the terms and conditions of the credit policy as provided for by regulations.

On the sale of the dwelling under the Scheme, the Council will place an Incremental Purchase Charge on the dwelling equivalent to the discount granted to the tenant of the purchase price. Thus if the

Council gives a 50% discount to the purchaser, the Incremental Purchase Charge will be 50% of the value of the house and this charge will remain for 25 years.

If a tenant disposes of the dwelling during the Charge period (varies from 20 to 30 years depending on the level of discount) the tenant will have to pay back a portion of the market value on the sale to the Council.

Unlike previous tenant purchase schemes, as the new scheme is a national scheme with the terms and conditions set down in part 3 of the 2014 Act and prescribed by the Minister in Regulations, there is no requirement under the legislation for the elected council members to make a tenant purchase scheme to give effect to the scheme.

An explanatory leaflet is in the process of being prepared by the Department and which will be available for local authorities to issue to all tenants in the New Year.

- **The Workhouse, Dunfanaghy:** Developed considerably over the past 10 years as a tourist, children’s activities, heritage, community and cultural centre. Local walks have been developed by the centre in the Dunfanaghy and Horn Head area and guided nature walks are in demand. The Tidy Towns committee operate from the centre and are very much involved in various festivals such as the annual Dunfanaghy Jazz & Blues, Errigal Arts, St Patrick’s Day, Halloween and other seasonal activities throughout the year. The playground has been a great addition to the Workhouse. There is a restaurant and craft shop in the building and the centre is utilised by locals & visitors throughout the year. It is a hub of activity and visited by tourists more and more recently. The Wild Atlantic Way has showcased the various activities to draw tourists/visitors to the town regarding eateries, singing pubs, surfing, horseriding, walks, beaches etc.

**Teach na mBocht Dhun Fionnachaidh:** Ionad shaibhir i saol an phobail san cheantar. Ionad oidhreachta, cultúrtha, turasóireachta, dúlra agus pobail go mór é. It hosts concerts, meetings, indoor sports, classes of various kinds, e.g., robotics, dancing, computer literacy, etc. It houses the Tip O’Neill Suite where the O’Neill family and interested parties have donated photographs, paintings and other memorabilia to the centre. It also houses a genealogy centre for the area. A wedding took place in the centre in August that attracted a lot of media attention. The North West cycling club use the centre as their point of starting & finishing. The Sliabh Sneacht walk has been developed by the community organisers and toilet & shower facilities are provided for their use. The local school uses the facilities. The organisation uses the Wild Atlantic Way to promote all their facilities and welcomes everyone to use and visit their wonderful facilities.

<b>Activity / Project Title</b>	Marine Tourism Marketing & Development
<b>Project Description/Activity</b>	The Marine Tourism Marketing & Development Plan covers a range of locations, activities and projects.
<b>Progress to date</b>	<p><b>Cool Route Meeting</b> A meeting of the Cool Route partner delegates took place on 27<sup>th</sup> and 28<sup>th</sup> October in the Abbey Hotel, Donegal Town (more details available in the Cool Route report).</p> <p><b>WILDSEA Europe Meeting</b> A meeting of the WILDSEA Europe project delegates took place on 8<sup>th</sup> and 9<sup>th</sup> October in the Clanree Hotel, Letterkenny. Delegates from Spain, Italy, Croatia, Northern Ireland and Donegal were in attendance. The meeting coincided with the Donegal Tourism Ltd 'Connecting the Wild Atlantic Way Tourism Conference'. Project delegates had the opportunity to network with local project stakeholders at the conference and were also given a tour of the county including Malin Head with the guidance of Emmett Johnston from National Parks and Wildlife. Opportunities to develop Malin Head as a world class marine national park were discussed. A list of 15 stakeholders/tourism businesses has been compiled and these businesses will be contacted in due course to engage them with the project.</p> <p><b>Poll an tSnamh</b> A feasibility study has been completed on the old swimming pool in Rannafast. The feasibility study found no issues in terms of the Natura Impact Statement for the site. The feasibility study details a proposed marine leisure facility in the area including pontoons and the development of the old swimming pool. Further funding from the EU or another source will be required in order for works to commence. Failte Ireland and Údarás na Gaeltachta have both provided letters of support for this project.</p> <p><b>Gaeltacht Meeting</b> The Marine Tourism Marketing &amp; Development Officer recently met with a group of 30 tourism businesses in Gweedore and delivered a presentation on opportunities to promote their business. Ongoing support is being provided to these businesses to help them get listed on MalinWaters.com and Govisitdonegal.com. Some of these businesses are now stakeholders in other European projects.</p> <p><b>Killybegs Tourism</b> The new website is continuing to perform for tourism in Killybegs and the Killybegs tourism Facebook page has over 880 likes to date. The</p>

flags and town map were a welcomed addition to the town in particular for the arrival of cruise ships. Donegal County Council is in discussion with Cruise Ireland the marketing body for cruise tourism in international markets about membership with the aim of increasing cruise tourism into 2016 and beyond.

#### **Marine Infrastructure**

Greencastle, Teelin and Mountcharles pier pontoons were put in place but have been removed from the waters for protection from storm damage during winter months. They will return in the Spring. The new pontoon is in place at Bunagee Harbour and will now be featured in the Welcome Anchorages publication in 2016.

#### **Sliabh Liag Branding and Website Development**

The Sliabh Liag Facebook page is growing from strength to strength with over 4963 likes on the page. The Facebook page has been set up at [www.facebook.com/sliabhliagexperience](http://www.facebook.com/sliabhliagexperience) The website [www.sliabhliag.com](http://www.sliabhliag.com) is now live and has already received several thousand visitors. A number of promotional materials have been developed including a brochure, flyer, nomadic stand, pop-ups and online banners that will be used in the future promotion of Sliabh Liag.

#### **Fanad Lighthouse**
