MINUTES OF THE INISHOWEN MUNICIPAL DISTRICT MEETING HELD ON TUESDAY 06th DECEMBER 2022 at 2.00pm in CARNDONAGH PUBLIC SERVICE CENTRE

The meeting was opened by the Cathaoirleach, Cllr Paul Canning who welcomed all to the meeting.

22.64 Consideration of the Minutes of the Inishowen Municipal District Budget 2023 meeting held on 25th October 2022.

On the proposal of Cllr Nicholas Crossan, seconded by Cllr Martin Farren, the minutes of the Inishowen Municipal District Budget 2023 meeting held on 25th October 2022 were adopted.

22.65 Consideration of the Minutes of the Inishowen Municipal District meeting held on 01st November 2022

On the proposal of Cllr Rena Donaghey seconded by Cllr Terry Crossan, the minutes of the Inishowen Municipal District meeting held on 01st November 2022 were adopted.

22.66 PLANNING

Killian Smith presented the report and it was taken as read.

22.66.01 Taking in Charge of Private Residential Estates

The Taking in Charge team as detailed in the Planning Report for the Inishowen Municpal District meeting, presented four estates, as listed below in the Inishowen MD to Members and sought approval to complete the Taking in Charge process.

1. Hawthorn Hill Phase 1&2 Newtowncunningham

- 2. Oakfield Court, Close & Crescent, Buncrana
- 3. Whitehill, Muff
- 4. Connaberry Buncrana

The Planning Authority is satisfied that there is a need for a Public Right of Way over the estate roads and sought approval from Members to make an order to create these Rights of Way in accordance with Section 207 of the Planning & Development Act.

Approval was sought from Members, in accordance with Section 180 of the Planning & Development Act to initiate the procedures under Section 11 of the Roads Act to declare the roads within these estates to be public roads and thereby complete the Taking in Charge of the estates.

Hawthorn Hill Phase 1 &2, Newtowncunningham

On the proposal of Councillor Paul Canning seconded by Councillor Terry Crossan, it was resolved that the Council make an order in accordance with Section 207 of the Planning & Development Act 2000 (as amended) for the creation of a public right of way over the estate roads within the housing estate Hawthorn Hill, Newtowncunningham (Phase 1&2) as set out in the maps in the report, to enable it to proceed with the taking in charge of the estates.

On the proposal of Councillor Paul Canning ,seconded by Councillor Cllr Terry Crossan it was resolved that the Council make an order in accordance with Section 11 (1) of the Roads Act, 1993 to declare the estate roads within the housing estate Hawthorn Hill, Newtowncunningham (Phase 1&2) to be a public road and note the consequential provisions contained in Section 180(4) of the Planning and Development Act, 2000 (as amended) whereby this Council will also take in charge the water services infrastructure and the public open spaces or car park within the attendant grounds of the development and will subsequently transfer the water services within the estate to Irish Water.

Oakfield Court, Close & Crescent, Buncrana

On the proposal of Councillor Rena Donaghey seconded by Councillor Jack Murray it was resolved that the Council make an order in accordance with Section 207 of the Planning & Development Act 2000 (as amended) for the creation of a public right of way over the estate roads within the housing estate Oakfield Court-Close & Crescent-Buncrana as set out in the attached maps in the report, to enable it to proceed with the taking in charge of the estates.

On the proposal of Councillor Jack Murray seconded by Councillor Rena Donaghey it was resolved that the Council make an order in accordance with Section 11 (1) of the Roads Act, 1993 to declare the estate roads within the housing estate Oakfield Court-Close & Crescent-Buncrana to be a public road and note the consequential provisions contained in Section 180(4) of the Planning and Development Act, 2000 (as amended) whereby this Council will also take in charge

the water services infrastructure and the public open spaces or car park within the attendant grounds of the development and will subsequently transfer the water services within the estate to Irish Water.

Whitehill, Muff

On the proposal of Councillor Terry Crossan seconded by Councillor Rena Donaghey it was resolved that the Council make an order in accordance with Section 207 of the Planning & Development Act 2000 (as amended) for the creation of a public right of way over the estate roads within the housing estate Whitehill, Muff as set out in the attached maps in the report, to enable it to proceed with the taking in charge of the estates.

On the proposal of Councillor Paul Canning seconded by Councillor Rena Donaghey it was resolved that the Council make an order in accordance with Section 11 (1) of the Roads Act, 1993 to declare the estate roads within the housing estate Whitehill Muff to be a public road and note the consequential provisions contained in Section 180(4) of the Planning and Development Act, 2000 (as amended) whereby this Council will also take in charge the water services infrastructure and the public open spaces or car park within the attendant grounds of the development and will subsequently transfer the water services within the estate to Irish Water.

Connaberry Buncrana

On the proposal of Councillor Rena Donaghey seconded by Councillor Nicholas Crossan it was resolved that the Council make an order in accordance with Section 207 of the Planning & Development Act 2000 (as amended) for the creation of a public right of way over the estate roads within the housing estate Connaberry Buncrana as set out in the attached maps in the report, to enable it to proceed with the taking in charge of the estates.

On the proposal of Councillor Rena Donaghey seconded by Councillor Nicholas Crossan it was resolved that the Council make an order in accordance with Section 11 (1) of the Roads Act, 1993 to declare the estate roads within the housing estate Connaberry Buncrana to be a public road and note the consequential provisions contained in Section 180(4) of the Planning and Development Act, 2000 (as amended) whereby this Council will also take in charge the water services infrastructure and the public open spaces or car park within the attendant grounds of the development and will subsequently transfer the water services within the estate to Irish Water.

22.66.02 Responses

Killian Smith proceeded to provide a response to various queries raised by Members in the Inishowen MD meeting on 01st November 2022 –

- **Tus Nua** (22.59.03)- Killian Smith advised that a briefing is provided in todays' report from the Capital Projects Delivery Unit in relation to Tus Nua.
- **Buncrana Regeneration Project** (22.59.04) in response to Cllr Murray's query Members were advised that the Leisure Centre will be explored within the Repowering Buncrana regeneration project.
- Residential Zoned Land Tax (22.59.07) -Members were advised that a full briefing was given to Members at a recent plenary meeting and this report can be recirculated to Members if required. Maps are available at Council offices and on the website and Members were reminded that if there is a residential property on the land it is exempt from the tax and that the date for submissions is 01st January 2023. A discussion ensued regarding the tax with Cathaoirleach Paul Canning calling for a workshop so that a further briefing and discussion can take place. Cllr Albert Doherty and Cllr Rena Donaghey both expressed their concerns that there is undue anxiety among landowners as they do not have enough information and that the consultation period is too tight with the deadline fast approaching in January 2023. Killian Smith advised that the matter could be referred to Senior Planners but there possibly would not be the scope to hold workshops in each Municipal District before Christmas.

22.67 HOUSING AND CORPORATE SERVICES

22.67.01 Fáilte Ireland Briefing

Joan Crawford and David Leonard from Fáilte Ireland provided a briefing to Members of the new 5-year plan 'The Inishowen Peninsula Destination and Experience Development Plan' (DEDP) ahead of the official launch on Friday 09th December 2022. It was outlined that the DEDP aims to create a sustainable tourism destination by extending the tourism season and spreading business across all parts of the region over the next five years. It was highlighted that key stakeholders in the area and local community were consulted and the feedback and ideas have been captured in the plan. This collaboration will be maintained throughout the plan with quarterly updates and newsletter and briefing sessions and meeting with Elected Members. As part of the plan Fáilte Ireland and Donegal County Council have invested €12.3 million in Fort Dunree for the development of a visitor center. The Members collectively thanked Joan and David for the presentation and for the work done and investment by Fáilte Ireland to date. ClIr Martin McDermott noted that the redevelopment of Malin Head is too slow, and it still lacks the proper services in terms of tourism. ClIr McDermott further noted that the Council Executive and Fáilte Ireland must move it forward and deliver on it. The Members collectively agreed with ClIr McDermott's comments.

22.67.02 Schedule of Inishowen MD Meetings for 2023

The proposed Schedule of Inishowen MD Meetings for 2023 was presented to Members and on the proposal of Cllr Nicholas Crossan and seconded by Cllr Martin Farren the Schedule was agreed.

22.67.03 Disposal of Land at Carrickfoden Carndonagh

Una Cresswell advised Members that Donegal County Council proposes to dispose of a plot of land at Carrickfoden, Carndonagh comprising of 0.0153 hectares of land to Mr. James McLaughlin, 15 Donagh Park, Carndonagh, Co. Donegal.

Members considered the report circulated with the agenda in relation to the above.

On the proposal of Cllr Albert Doherty and seconded by Cllr Martin McDermott it was recommended that this land disposal under Section 183 of the Local Government Act, 2001 is presented to the full Council at the next Plenary Council Meeting.

22.67.04 Housing Services

Una Cresswell presented the Housing report and it was taken as read. Una Cresswell highlighted that 45 new tenancies had been created in 2022 to date and 21 of those were the new dwellings at Rockytown Buncrana. It was also noted that a further three properties would be offered and hopefully accepted by year end bringing the total number of properties to 48.

22.67.05 Crana Crescent, Buncrana

Shaun Doherty advised that the tenders for the development at Crana Crescent, Buncrana were returned and progressing and it is anticipated that the Contractor will be on site in April /May 2023. In response to a query from Cllr Nicholas Crossan, Shaun Doherty advised that the tenders were currently being assessed and had not been awarded yet.

22.67.06 Single Dwelling at The Meadows, Buncrana

Shaun Doherty advised that the Contractor had been appointed for this project and it is anticipated that they will be onsite December 2022 / January 2023 with a completion date of October 2023.

22.67.07 Phase II, Rockytown Buncrana

Shaun Doherty advised that Phase II of Rockytown Buncrana, the development of 56 social housing units, should be ready for tender in June 2023.

22.67.08 Development at Convent Rd, Carndonagh

Cllr Johnny McGuinness asked for an update regarding the housing development in Carndonagh that was nearing completion. Shaun Doherty advised that this matter was still with the Department and it is hoped it will be resolved soon. Cllr Albert Doherty expressed his disappointment that this matter has not yet progressed.

22.67.09 Barrack Hill, Carndonagh

Cllr Albert Doherty requested for a map to be shared with Members on how lands were divided between community, light industry, and housing at Barrack Hill, Carndonagh. Cllr Doherty noted that it's a significant amount of council owned land and he would like to see the areas of responsibility.

22.67.10 Vacant Housing Officer / Town Regeneration Officer

Cllr Albert Doherty queried whether these posts had now been filled. Una Cresswell advised that the jobs had been advertised and HR were currently working through the recruitment process.

22.67.11 Housing Income Threshold

Cllr Doherty requested that information regarding the increase in the income threshold to qualify for social housing is shared with Members. Una Cresswell noted that this information was only recently received and that the increase in the threshold was welcomed. It was further advised that Members will be kept updated.

22.67.12 Long Term Lease Dwellings

Cllr Albert Doherty acknowledged the work carried out by Housing Officials in Inishowen MD in relation to long term lease dwellings where the leases are due to expire. However, Cllr Doherty asked that the Council pull out all the stops to help alleviate the anxiety of the families concerned and queried what the current position is in relation to a particular number of houses. Cllr Martin McDermott and Cllr Johnny McGuinness also raised queries regarding advising tenants of expiring leases and re the timeline for negotiations with property owners about renewing leases. Una Cresswell advised that it would not be appropriate to discuss individual cases but that over the past few years many leases have been expiring and the Council do examine these in advance. Una Cresswell further advised that there are several factors that must be considered and although the Council try to renew leases for a further ten years it is not always possible. Members were assured that tenants in these dwellings would be rehoused by the Local Authority if necessary.

22.67.13 Defective Concrete Blocks- Modular Homes

Cllr Jack Murray noted that the motion had been past at plenary council for a delegation to meet Housing Minister Darragh O'Brien and one of the items for discussion was temporary modular housing. Cllr Murray suggested that the Council identify serviced sites and collate this information so that progress could be made quickly if this option were to proceed. Cllr Terry Crossan supported these comments.

22.68 COMMUNITY DEVELOPMENT

Fiona Doherty presented the report and it was taken as read. Fiona Doherty highlighted some items to Members.

22.68.01 Outdoor Recreation Scheme - Moville

Fiona Doherty advised Members that €200,000 has been awarded for the upgrade and enhancement of the Moville Shorewalk. Cllr Martin Farren welcomed the announcement.

22.68.02 Completed Projects 2022

Fiona Doherty highlighted that the following projects had been completed in 2022

- Town and Village Renewal Scheme Clonmany
- Culdaff Outdoor Recreation / Playground Project
- Portaleen Viewing Point, Malin
- Burnfoot Village Enhancement Scheme

22.69 ROADS AND TRANSPORTATION

Michael McFadden presented the report to Members and it was taken as read. Michael McFadden highlighted to Members the difficult year that 2022 presented to be, due to increase in costs resulting in a reduced budget. However, it was noted that jobs had still been completed under the programme of works despite this and the only outstanding project under the Restoration Improvement Programme 2022 is the Slab Rd corner at Burt.

22.69.01 Slab Rd, Burt

Cllr Jack Murray enquired if the Slab Road can be lined to make it safer for users. Michael McFadden advised that this route won't be lined at this time, but these works would be included when the restorations works are being carried out.

22.69.02 Disabled Parking Bays Buncrana

Cllr Jack Murray noted that he has had many reports that the disabled parking bays in Buncrana are being misused and he enquired if there is anything the Council can do in relation to this? Michael McFadden advised that he refer this to the parking enforcement team.

22.69.03 Road Safety Measures -McCarter Rd Buncrana

Cllr Jack Murray requested for a road crossing to be installed at McCarter Road Buncrana so that pedestrians may cross safely between Aldi and Lidl supermarkets.

22.69.04 Winter Gritting Programme

Cllr Martin Farren enquired if the Council had sufficient supply of salt for this year's winter gritting programme? Michael McFadden advised that there is an audit procedure in place, and this is something that is continually monitored.

22.69.05 Crash Barriers- Moville

Cllr Martin Farren requested clarity in relation to the crash barrier at Clar Corner, Moville. Cllr Farren also requested that the areas at Redcastle Football Club and Gaelscoile Moville be considered for the installation of a crash barrier. Michael McFadden advised that the crash barrier at Clar corner is at audit and design stage and that the other areas mentioned will be examined.

22.69.06 Footpath repairs - Muff

Cllr Terry Crossan raised the issue of continuous illegal parking of Heavy Goods Vehicles on the footpath between Warrenview Manor and the Filling Station in Muff resulting in the path being substantially damaged and an uneven surface causing obstructions for pedestrian users. Cllr T Crossan also acknowledged the positive engagement that the Roads personnel have carried out in the Muff and Quigleys Point area with the local community and school community to try and resolve some issues.

22.69.07 Straboe, Buncrana

Cllr Nicholas Crossan noted that residents in Straboe, Cockhill, Buncrana have raised an issue with him regarding water running off a county road onto a private road opposite the old Cockhill School causing concerns that the newly repaired surface there will be damaged. Cllr N Crossan asked that the Council examine the matter and carry out any necessary repairs. Michael McFadden advised that it will be examined to try and resolve the issue.

22.69.08 Road Markings Buncrana

Cllr Nicholas Crossan noted that local Driving Instructors have raised the issue with him about faded road markings in and around Buncrana town centre particularly at the junction in Marian Park, Buncrana. Cllr N Crossan asked that the Council carry out works as the town is a driving test town and road markings are essential for all motorists, but it is causing difficulties for learner drivers. Michael McFadden advised that the line markings could be refreshed.

22.69.09 Public Lighting

Cllr Nicholas Crossan raised concerns about the streetlights in several areas in Buncrana. Cllr N Crossan stated that six decorative streetlights are out in Buncrana Main Street and noted that up to €20,000 has been spent on Christmas lights in Buncrana but some streetlights require fixing. Cllr Crossan requested that they are attended too. Cllr Rena Donaghey supported Cllr N Crossan's comments. Michael McFadden advised that Airtricity maintain the public lighting and he will make contact again regarding Buncrana and Carndonagh. Bryan Cannon noted that there are 19,000 public lights in the county and he would encourage the public to report the faulty lights through the online system which helps to keep a track of the repairs submitted and the response times for attending to these repairs.

22.69.10 Fr. Hegarty's Grave, Buncrana

Cllr Nicholas Crossan requested that steps are installed at Fr. Hegarty's Grave, Buncrana to provide better access as he believes access is difficult for some members of the public.

22.69.10 Umricam, Buncrana

Cllr Rena Donaghey asked that the Council examine an area at the Umricam Filling Station, Umricam, Buncrana where it is claimed there have been several road traffic accidents in recent times. Cllr Donaghey enquired if the Council could investigate and determine if there are any safety measures that could be taken in this area that might assist drivers. Michael McFadden advised this could be examined in conjunction with the Road Design team.

22.69.11 Glentogher, Carndonagh

Cllr Martin McDermott enquired if the Part VIII for the road at Glentogher, Carndonagh could proceed ahead of any additional funding being secured. Michael McFadden advised that he enquire with the Road Design team. Cllr Johnny McGuinness supported Cllr McDermott's comments.

22.69.12 Road Maintenance

Cllr Johnny McGuinness noted that repairs had been carried out to the Sheskin Rd Malin and Moss Rd Culdaff but highlighted that these were not long-term solutions. Michael McFadden acknowledged that a longer-term solution is required. Cllr McGuinness also requested that traffic calming measures are examined at the new pedestrian crossing at Culdaff school.

22.69.13 Ballyliffen, Clonmany

Cllr Albert Doherty referred to a road traffic accident that had taken place in recent days on the Ballyliffen road and requested the roads section examine same to see if any or some safety measures could be taken at this junction. Michael McFadden advised that this would be looked at.

22.69.14 Bridgend School

Cllr Paul Canning requested that the issue of the provision of a raised platform at Bridgend Primary School is examined. Michael McFadden noted Cllr Canning's comments.

22.70 ECONOMIC DEVELOPMENT, INFORMATION SYSTEMS AND EMERGENCY SERVICES,

Mary McBride presented the report to Members and it was taken as read.

22.70.01 Community Events

Cllr Nicholas Crossan advised that he had received a response in relation to his query about the community event held at the Irish Legends Golf Tour. Cllr Crossan suggested that Members in each Municipal District are consulted regarding events that are planned and that best value for money is obtained in relation to these events.

22.71 ENVIRONMENT

Matthew Byrne presented the report and highlighted a few items to Members.

- **2022 Tidy Town Awards** Cathaoirleach of Donegal County Council, Cllr Liam Blaney has congratulated Buncrana Tidy Towns for achieving the County First and Gold Medal.
- **Social Media** The Environment section have produced various information videos this year which can be shared across social media platforms.
- Climate Action Plan- The Delivering Effective Climate Action 2030, Local Authority Strategy for delivering on the Climate Action Charter and Climate Action Plan (DECA 2030) identifies resources and measures to support the completion and reporting on actions for each LA Climate Action Plan. The additional resource requirements include a Climate Action Coordinator, Climate Action Officer, Climate Action Community Officer.

• Burnfoot Flood Relief Scheme – the report contains an update on this.

In relation to queries raised by Members at the previous Inishowen MD meeting Matthew Byrne outlined some responses:

- **Public Toilets Buncrana (22.58.03)** Matthew Byrne advised options are being looked at in this regard and response times for attendance to issues is something that will be considered too within the contract.
- Lifeguards Inishowen (22.58.05)- Matthew Byrne advised that there is a lot of work going on with regards to having Lifeguards in place for Summer 2023. Cllr Martin Farren enquired if the team felt satisfied that there will be Lifeguards in place by next summer? Matthew Byrne thanked Cllr Farren for his input to date on this issue and noted that the training is being part funded by BIM. Matthew Byrne further advised that although a lot of work is being done, they can't guarantee anything at this stage, but Members will be kept updated on progress. Cllr Johnny McGuinness suggested the Council reach out through the NWRDG to see if any training could be provided in Derry. Cllr Albert Doherty supported this and suggested that print media in Northern Ireland is used to attract candidates.
- **Public Toilets -Ned's Point (22.58.06)** Members were advised that discussions are taking place regarding the provision of toilets. The request for a handrail at the slipway has been referred to the Marine section for consideration.

22.71.01 Illegal Dumping

Cllr Martin Farren noted that there had been illegal dumping of 10 bags of rubbish on the Green Road between Cooley Moville and Gleneely. Cllr Farren thanked the litter management team for the work done on this and noted that he hoped that the person(s) responsible are identified and fined.

22.71.02 Irish Water

Cllr Nicholas Crossan enquired if there has been any further response from Irish Water in relation to the cast iron pipes. Matthew Byrne advised that there has been no response, but he would follow up on this.

22.71.03 Dog Fouling

Cllr Terry Crossan requested that a dog fouling bin is put in place at each end of the Muff greenway. Matthew Byrne advised he would discuss this matter with the Roads Section.

Cllr Martin Farren noted that there have been no dog poop scoop bags available from the Council for some time. Cllr Nicholas Crossan also noted this. Matthew Byrne advised that he follow up on this.

2. Social Housing through Turnkey Acquisition

Donegal County Council's turnkey acquisition process is continuing throughout the county. This competitive dialogue procurement process will result in a major capital investment in social housing, with the initial projects in the county now complete. This is a very effective mechanism enabling the Council to feed into the design of the proposal to ensure that the end product is suitable for the needs of social housing tenants.

The Council is currently liaising with the Department of Housing, Local Government and Heritage in respect of a project at Carndonagh as well as with the Developer in an effort to progress contractual negotiations.

Council officials are continuing to dialogue with Developers with regard to the additional valid proposal for Moville. Members will be fully informed of this proposal upon receipt of Irish Water requirements and final departmental approval.

3. Lands / Property for Social Housing Purposes

The Council is planning to develop further projects on existing landbank in various locations throughout the MD. Preliminary designs are underway for a number of these sites and are informed by the pertaining approved social housing need at local level.

In parallel with the construction and turnkey programmes outlined above, the Council is actively pursuing the acquisition of lands suitable for housing purposes, in towns and villages where there is currently not a social housing solution available / shortfall. In addition to the current expression of interest advertisement on the Councils' website for parcels of land, derelict sites / buildings with the potential to deliver social housing, the Council is also separately identifying parcels of land with social housing potential in areas of need.

A number of suitable land parcels have been identified in towns and villages across the Inishowen MD and engagement / negotiations are ongoing directly with multiple landowners / agents, to acquire these lands. In this regard the Council has currently 2 offers accepted (subject to contract) for land in Moville and Newtowncunningham.

Going forward, the land team will continue to identify further land parcels across the MD and work with the Council's local service team to assess their suitability for new social housing.

Shared Island

Donegal County Council were awarded funding for a series of new innovative projects under the Irish Government's Shared Island Local Authority Development Funding Scheme and will be working in partnership with Derry City and Strabane District Council and Fermanagh and Omagh District Council in the coming year. The Economic Development Unit will be leading out on three projects and are currently scoping requirements for feasibility assessment and governance structures, in preparation for procurement of consultants in early 2023.

- The North West Regulatory Tech Cluster project is a proposal to develop an all-island national institute in Regulatory Technology ('RegTech') in the North West. DCC will work with Derry City and Strabane District Council, Catalyst, ATU and other partners to develop campuses in both Letterkenny and Derry. A project manager for two Shared Island projects (Slí Cholmcille and RegTech) was appointed on 5th December 2022 to drive the process forward.
- Innovation Plaza to develop cross-border enterprise opportunities in sectors such as renewable energy, advanced manufacturing & engineering and agri-food.

 Regenerative Tourism involving engagement with the region's place, past and people, seeking to attract high-yield environmentally conscious visitors.

North West City Region

Donegal County Council continue to work in partnership with Derry City and Strabane District Council on a number of key projects for supporting and stimulating Inward Investment in the region.

- Inward Investment Strategy: both councils have worked with OCO Global to develop a three-year Investment strategy for the region. Follow up actions and potential funding options have been developed on this with pitch propositions currently being finalised in partnership with OCO Global, focusing on key investment sectors.

Upcoming Programmes:

Ukraine Enterprise Crisis Scheme

Enterprise Ireland is working with the Department of Enterprise, Trade and Employment to help Irish businesses manage and mitigate the economic impact of the current crisis in Ukraine.

The Ukraine Enterprise Crisis Scheme is a €200 million fund to assist viable but vulnerable firms in manufacturing and internationally traded services. It is aimed at businesses experiencing significant difficulty as a result of increased energy costs.

The Scheme offers two streams of support to manufacturing and Internationally Traded Services companies.

Stream 1 is a liquidity measure that will help viable manufacturing and Internationally Traded Services companies experiencing trading difficulties. The overall aid under this measure will not exceed €500,000 and will typically be provided on a co-funded basis. The minimum aid award is €20,000.

Enterprise Ireland, IDA Ireland, Údarás Na Gaeltachta and the Local Enterprise Office are the approved granting authorities for Stream 1.

Stream 2 will provide aid for additional costs due to exceptionally severe increases in natural gas and electricity prices experienced by energy-

intensive businesses. The aid will be in the form of direct grants and the overall aid per undertaking will not exceed 30% of the eligible costs up to a maximum of €2 million. The minimum aid award is €20,000. Applicants will be required to demonstrate measures undertaken or planned to improve energy efficiency.

For both Streams applicants must submit an energy efficiency plan, ratified by senior management of the company.

Companies should contact Enterprise Ireland (EI) via the website: www.enterprise-ireland.com/ECS. The EI Hub team will do some initial checks to make sure companies can avail of the scheme. If validated as eligible, the companies are emailed an Application pack and an EI Development Advisor or their equivalent in the LEO are notified.

Subject to the normal assessment criteria, the applications are then evaluated and decisioned by the relevant authority.

Currently the Streams have two different closing dates. **Stream 1 is open until the 1st December 2022,** though this will likely be extended into the New Year and **Stream 2 is open until 31st March 2023**.

To date, information packs for Stream 1 & 2 have been issued to one firm in Donegal. Information sessions will be taking place in the New Year to provide the opportunity for companies in Donegal to learn more about the scheme's qualifying criteria and how to apply.

Scale-X Blue Economy

Scale-X Blue Economy is an 11-week Accelerator Programme which is targeted at start up entrepreneurs with the potential for fast growth in the Blue Economy i.e. the Marine engineering, marine research, marine energy, value added fish processing sectors. The programme focuses on giving you a deep understanding of the metrics that can drive your success, the skills to build financial models that stand up to investor scrutiny, and industry engagement and mentorship that give you valuable insights to adapt your business model to create the perfect fit.

Who is eligible?

Any founder(s) with ambitions to grow their business globally.

- Any founder(s) with the potential for fast growth in the marine engineering, marine research, marine energy or value-added fish processing sectors
- A potential spin-out from an existing firm or third level institution
- A commitment to grow your business from Donegal, no matter where in the world you live right now.
- The programme is open to residents of County Donegal

Lean tools and techniques address competitiveness issues within their businesses by building the capability of their people to identify problems, improve operations and create a more innovative organisation. In a nutshell, Lean is about doing things quicker, better and saving costs. Lean strives to remove waste and to continually improve a company.

Ongoing Cluster Development Programmes:

Food Coast Donegal

The Food Coast Donegal is an initiative facilitated by the LEO to support, celebrate and grow the Donegal Food Sector.

- 40 certified members.
- Just under 200 network members.

Current activities:

- The Food Coast Strategy Review is close to completion and should be finalised early in the New Year.
- In the planning stage of taking a group of Donegal food producers to St Joseph's University in Philadelphia for a week to attend lectures and field trips. The visit is scheduled to take place in March 2023, to coincide with St Patrick's day, and 20 businesses are due to take part.

Creative Coast Donegal

Creative Coast Donegal's aim is to support the building of a strong creative and digital economy in Donegal with businesses that are robust, confident, financially viable, and collaboration-friendly, all impacting positively on the local economy in terms of job creation, as well as being pro-active and competitive on an international stage.

There are currently 204 members of the Creative Coast Donegal network. These members are creative business owners throughout Donegal from various sectors within the Creative industry.

The LEO Donegal and external consultants are in the final stages of developing a 3-year action plan for the creative industry in Donegal.

Throughout September & October, Creative Coast Donegal delivered 7 pilot Creative Network Meetings for the Design and Craft sectors in four locations throughout the county. These network meetings were created based on the feedback directly from the creatives themselves and informed by the Creative Coast Donegal Skills Audit Insight report. Around 80 people attended the in-person meetings, which provided an opportunity for the creatives to network with one another and learn from industry experts in Ireland. These experts delivered masterclasses on a range of different skills such as social media strategy, financial management, brand development, etc.

The meetings have now moved to an online format and we have seen greater numbers of people in attendance. Feedback from both the inperson and virtual events has been positive. Three more online meetings are happening during November/December, concluding the pilot stage of the creative network meetings. Friel Consulting will provide a report in early December that will include recommendations on how the network should proceed.

In November, Creative Coast Donegal hosted the 'Yarns' conference – a celebration of the strength and heritage of the Fashion & Textile industry of the Northwest region. In collaboration with Strabane City & Derry City Council, the event took place in Letterkenny and Derry on the 18th & 19th of November. Various high-profile speakers from within the creative industry in Ireland, including Sonya Lennon, Paula Hughes, Aisling Farinella, and Deirdre McQuillan, facilitated workshops, delivered 1:1 training, and presented keynote addresses, to increase ambition, build skills, and inspire the creative community in the northwest.

Yarns was very well received by all who attended and received widespread social media coverage. Creative Coast Donegal is currently collecting written feedback from each of the attendees which will inform the development of similar events in the future.

Donegal Engineering Cluster

The ambition of the **Donegal Engineering Cluster** is to expand, strengthen and enhance the existing engineering group in Donegal by,

- Facilitating inter-firm knowledge sharing and enhance learning.
- •Increasing market knowledge within the cluster.
- •Identifying new opportunities for the sector in the county through cooperation and collaboration among cluster partners.
- •Enhancing the skills and innovation capabilities of the engineering firms through training, peer learning and management development.
- •Enhancing the attractiveness of the sector as a potential source for future employment opportunities and business start-ups.
- Developing collaborative opportunities into meaningful outcomes and outputs for cluster members.
- Promoting the cluster as a centre of engineering excellence both nationally and internationally.

Maura Toner commenced as Donegal Engineering Cluster Executive in September, 2022, on a 3-year contract, and is currently engaging with engineers and other stakeholders to assess the opportunities for the sector and their current challenges.

Upcoming Activities:



Description/ Activity	Donegal County Council would like to remind Petrol Station owners/operators that they are obliged to ensure that their facility is so designed and operated in accordance with the Third Schedule of <u>Air Pollution Act 1987 - Petroleum Vapour Emissions Regulations</u> 1997 (S.I. No. 375 of 1997) and the <u>European Union (Stage II Petrol Vapour Recovery during Refuelling of Motor Vehicles at Service Stations) Regulations 2011</u> .
	The objective of these regulations is to reduce emissions of volatile organic compounds (VOC) into the atmosphere from vehicle re-fuelling activities at service stations, in order to reduce the adverse impact of VOC on human health and the environment.
	Under the 1997 regulations, all petrol service stations <u>must</u> have installed a Stage 1b Petrol Vapour Recovery system in place, (for accepting bulk petrol deliveries).
	The 2011 Regulations provide that new service stations which meet either of the following two criteria will be required to be equipped with Stage II Petrol Vapour Recovery (PVRII) systems to recover Volatile Organic Compounds (VOC) during refuelling of vehicles, (ie – new pump dispensers for filling a vehicle's petrol tank):
	 throughput >100m³ (or 100,000 litres) and situated under living or working quarters throughput >500m³ (or 500,000 litres)
	The Regulations also provide that existing service stations are required to install PVRII systems when undergoing their next major refurbishment after 1 January, 2012 if they meet either of the above two criteria.
	In addition, the Directive requires that service stations with a throughput >3,000m³ (or 3,000,000 litres) were required to install PVRII technology by 31st December, 2018 at the latest (or sooner if undergoing a major refurbishment before that date).
	To meet the requirements of the regulations, a Service Station owner/operator is obliged to appoint an approved assessor who will carry out tests on their petrol station and submit a report and fee to Donegal County Council. If the Council is satisfied with the report it will issue a certificate of compliance with the above acts. Certificates of compliance last a maximum of three years, and need renewal on expiry. A copy certificates of compliance must be kept available for inspection at the relevant service station

1.0 RURAL REGENERATION AND DEVELOPMENT FUND (RRDF)

- 1.1 EXISTING APPROVED CATEGORY 2 RRDF PROJECTS (2020)
- 1.1.1 **Back to Ballyshannon** A transformational project to re-energise, re-imagine and sustain the social, cultural, historical, physical and economic fabric of Ballyshannon's historic town centre.

Value: €247,500. (RRDF funding approved €185,625)

Update: The Team continues to work towards (i) completion of the acquisition interest in Ballyshannon Town Centre, and (ii) the publication of a planning scheme, so as to develop this project as a shovel ready capital project targeted for future Category 1 RRDF funding.

Members were provided with a detailed progress update on the draft project plans at workshop on 27th September 2022.

As agreed the Regeneration & Development Team then opened a period of public consultation on the draft plans for the project on Tuesday 25th October 2022 with a drop-in event in St Anne's Hall, Ballyshannon from 3-8pm. The event was very well attended on the night. Draft plans remained available for viewing at

www.donegalcoco.ie/services/planning/regenerationprojects with submissions to be made before 4:30pm on Tuesday 15th November 2022. A total of 105no. submissions were received and the Team is now examining the feedback and the necessary arrangements for further engagement. Arrangements will also be made for a further workshop with Members to update them on the feedback from the public consultation process.

1.1.2 Ramelton Historic Town Centre – A Restorative & Transformational Public Realm Scheme.

Value: €249,159 (RRDF funding approved €186,869)

Update: A Part 8 planning scheme for this project was published on Tuesday 1st February 2022 and a Chief Executives Report on the proposed development was brought before the Elected Members at a Plenary Meeting of the Council on Wednesday 6th April, 2022 and it was decided to proceed with the development as proposed.

Detailed design and a tender package is now being completed by the successful consultant BDP.

The Regeneration and Development Team completed the submission of a Category 1 capital funding application to the Rural Regeneration and Development Fund for the capital delivery of this project by the 12noon deadline on Friday 29th April, 2022. The submitted project had a total project value of €7,949,868.

On 10th November 2022 the Minister for Rural and Community Development, Heather Humphreys announced that €6.3m had been awarded under the Fourth Call for Category 1 Projects of the RRDF for the "Ramelton Re-Imagined" regeneration Project. This represents a full award of the RRDF funding sought. Work will now continue to complete the Detailed Design and preparation of a Tender Package for this project, together with arrangements for handover to the Capital Project Delivery Unit for onward delivery.

1.2.2 THIRD CALL FOR CATEGORY 2 PROJECTS UNDER THE RURAL REGENERATION & DEVELOPMENT FUND (RRDF)

On 6th January 2022 the Minister for Rural and Community Development, Heather Humphreys announced that €1.17m had been awarded under the Third Call for Category 2 Projects of the RRDF for the "Repowering Buncrana" regeneration Project.

Due diligence has been completed on this project and a formal letter of Offer together with an associated Funding Agreement was received on 10th May 2022. The Funding Agreement was subsequently accepted and formally returned to the Department on 18th May 2022. The project will now progress to procurement of the required consultancy services before commencement of the planning and statutory consents stages of this project enabled by the funding award. A successful public information event in respect of this project was held in the Inishowen Gateway Hotel, Buncrana on Monday 23rd May, 2022.

1.3 FOURTH CALL FOR CATEGORY 1 PROJECTS (SHOVEL READY) UNDER THE RURAL

REGENERATION & DEVELOPMENT FUND (RRDF)

On 17th December 2021 the Minister for Rural and Community Development, Heather Humphreys TD announced the fourth call for Category 1 applications to the €1 Billion Rural Regeneration and Development Fund (RRDF).

The closing date for the receipt of proposals was 12 noon on Friday 29th April 2022.

As described at Point 1.2.2. above the Ramelton Re-Imagined regeneration project, with a value of €7,949,868 was submitted under this call.

On 10th November 2022 the Minister for Rural and Community Development, Heather Humphreys announced that €6.3m had been awarded under the Fourth Call for Category 1 Projects of the RRDF for the "Ramelton Re-Imagined" regeneration Project. Work will now continue to complete the Detailed Design and preparation of a Tender Package for this

project, together with arrangements for handover to the Capital Project Delivery Unit for implementation on site.

1.4 REGENERATION STRATEGIES & PROJECT DEVELOPMENT WORK

The Regeneration & Development Team had undertaken with Members to progress Regeneration Strategies in a number of Tier 2 Strategic Towns as a part of our work programme. This work has been progressing through in house resources and capacities together with consultancy services. An update on this area of the work programme is provided hereinunder:

1.4.2 Ballybofey-Stranorlar Regeneration Strategy & Action Plan

The Ballybofey-Stranorlar Regeneration Strategy was endorsed by the Committee of BASICC, as project partners, on 7th February 2022 and subsequently endorsed by the Stranorlar-Lifford MD on 25th May 2022. The Strategy was launched 27th May 2022 and is available at Donegal County Council (donegalcoco.ie)

1.4.3 Ballyshannon Regeneration Strategy & Action Plan

The Ballyshannon Town Centre Regeneration Strategy & Action Plan was formally published, launched and circulated to Members on the 20th April 2022. The Strategy & Action Plan, and associated Town Centre Masterplan, is available to view/download online at www.donegalcoco.ie and at Council offices. The Strategy was commissioned and funded by Donegal County Council and its delivery was led by GM Design Associates with the support and input of the Council's Regeneration and Development Team.

1.4.4 An Clochán Liath (Dungloe) Regeneration Strategy & Action Plan

The An Clochán Liath (Dungloe) Regeneration Strategy & Action Plan was formally published, launched and circulated to Members in September 2022. The Strategy & Action Plan, and associated Town Centre Masterplan, is available to view/download online at www.donegalcoco.ie and at Council offices. The Strategy was commissioned and funded by Donegal County Council and its delivery was led by GM Design Associates with the support and input of the Council's Regeneration and Development Team.

1.6. Rathmullan RRDF Project Development work

A presentation on the Draft Design Report for this project was made to the Elected Members at a scheduled workshop on 2nd June 2022 in advance of an informal public consultation event which took place later the same day from 3pm to 8pm in the St. Vincent de Paul Centre, Rathmullan.

In accordance with the information note provided to Members, a formal Part 8 planning scheme for this project was published on Thursday 24th November 2022. The project plans and particulars are available for inspection at County House, Lifford; Letterkenny Public

Services Centre; Milford Public Services Centre and online at: www.donegalcoco.ie until Tuesday 3rd January 2022. Submissions or observations maybe made in writing on or before 4:30pm on Wednesday 18th January 2022.

The project is a partnership with Rathmullan The Way Forward CLG.

1.7. Milford Town Centre First Plan

In late 2021 the Department of Rural and Community Development sought nominations for towns to be considered as part of the 1st Phase of the Town Centre Masterplan Initiative. Minister Heather Humphries TD subsequently announced that Milford was successful in securing €100,000 under the call. The Regeneration & Development Team is now leading on the delivery of a Town Centre First Masterplan for the Town.

The tender to procure Architect Led Full Integrated Design Team, PSDP and Masterplanning Consultancy Services to prepare a Town Centre First Plan for Milford together with a statutory planning consent scheme for a selected priority project or projects which will emerge from the Town Centre First Plan, opened on eTenders on 28th October 2022 and closed on the 7th December 2022.

The tender assessment process is now underway and it is anticipated that the successful consultancy service(s) will be appointed, and the project will be formally launched at the beginning of January 2023 with a scheduled completion date of mid-2023.

2.0 URBAN REGENERATION AND DEVELOPMENT FUND (URDF)

2.1 Existing approved URDF project in Letterkenny (application submitted 2018; final approval to proceed received September 2019)

This first application secured €1.9m in URDF monies, match funded by €600,000 for three sub-projects, the detail and progress of which is set out below.

Note: Please refer to Capital Project Delivery Unit MD reporting for update as regards the public realm sub-project.

(i) Preparation of a Regeneration Strategy for Letterkenny Town Centre.

The Letterkenny 2040 Regeneration Strategy was officially launched on Monday 5th December 2022 in the Radisson Hotel, Letterkenny attended by circa 100 guests including Minister McConalogue. This concludes the project which now transitions into project specific development and implementation.

The launch was followed by a cross- directorate Letterkenny Public Information Event where the public were invited to drop into the Radisson Hotel any time between 2pm-8pm to hear about the regeneration programme and also about other Council activities and services in Letterkenny. Staff from Housing, NRDO, Roads Central, Economic

Development, Planning, Regeneration & Development, Community Development and Water, Environment & Emergency Services were in attendance throughout 2pm-8pm and available to talk to people about the various projects set out below. Circa 100 people attended the Public Information Event.

- Letterkenny 2040 Regeneration Strategy and programme.
- The Urban Adventure Park at the Bernard McGlinchey Town Park.
- 'The Eat Out' Outdoor Dining Project at An Grianán Theatre.
- Housing grants, Repair & Lease Scheme & Croí Cónaithe Fund.
- Letterkenny Active Travel Projects, the N56 Four Lane Road Project and the TEN-T Priority Route Improvement Project, Donegal.
- Business supports, Buy Donegal 2022, Donegal clothing range & Alpha/Beta Enterprise Centres Project.
- Waste management & recycling.
- The programme for the forthcoming publication of the Draft Letterkenny Plan and Local Transport Plan.

(ii) Acquisition of key town centre regeneration site.

The Donegal County Council (Letterkenny Strategic Urban Regeneration Site) CPO 2021 became operative on Tuesday 15th November 2022. Steps will be taken in January 2023 to serve Notices to Treat and then to Enter enabling Donegal County Council to take possession of the lands and enable the delivery of Phase 1 (Alpha/Beta) of the Strategic Urban Regeneration Site which was approved Part 8 planning consent at the Special Council meeting on 24th February 2022.

In addition, in collaboration with Housing, options are being explored as regards the business model for the residential component of the Concept Masterplan relating to the remainder of the strategic site (Phase 2). Further updates will be brought to the Letterkenny-Milford MD in this regard as this work develops.

2.2 Successful application to the Urban Regeneration & Development Fund (May 2020)

The Councils successful application to URDF Call 2, continues to progress through funding approval steps required under the Public Spending Code. This application entitled 'Letterkenny 2040 (Phase 1) 'Re-energise and Connect the Historic Town Centre' secured a provisional allocation of &13.6m match supported by match funding committed by the Council in the sum of &4.5m.

Specifically this new investment will help to advance five projects to varying stages of as follows:

- The further enhancement of the Cathedral Quarter
- The re-purposing of the Courthouse
- Strategic land assembly towards:
 - o Regeneration of Lower Main Street
 - o Advancement of a Regional Transport Hub

o Enhancement of 'LK Green Connect,' walking, cycling and parkland infrastructure.

In relation to requisite funding approval processes, a Preliminary Business Case (PBC) was submitted to DHLGH in March 2022 for review and approval. This was followed by submission of Detailed Project Brief and Procurement Strategy on 29th July 2022.

The current status of the project is that the Preliminary Business Case secured approval of DHLGH on 11th August 2022. This represents approval under Decision Gate 1 in the project life cycle and 'approval in principle to Donegal County Council to proceed to Design, Planning & Procurement Strategy.' It also secured approval for funding uplift to take account of estimated increases as a result of inflation leading to total project value of €19.3m.

As outlined, a **Detailed Project Brief and Procurement Strategy has already been submitted to DHLGH on 29th July 2022 and is therefore actively under review and consideration by DHLGH.** A meeting with DHLGH officials took place on 5th December 2022 which confirmed that that review and consideration is ongoing.

Approval of Detailed Project Brief and Procurement Strategy will lead to approval to proceed to tendering inclusive of satisfactory completion of the Final Business Case and thereafter each project will advance at varying paces dependent on nature, scale and complexity.



Alongside the above activity, a number of steps are being taken to develop each subproject further. The table below sets out this activity. In terms of next steps for 2023, priority will be placed on advancement of acquisition interests.

2.3 Future URDF call for applications

Although there is no confirmed date available for a 3rd call for URDF applications, a communication from DHLGH is anticipated before year end 2022/as early as Q1 2023. It is understood that the focus will be on reducing vacancy and supporting residential development.

2.4 'The Eat Out' Outdoor Dining Infrastructure Project, Letterkenny

A Chief Executives Report in relation to the consultation process on the 'Eat Out,' Letterkenny was considered at the Plenary Council meeting on 28th November 2022 at which time Donegal County Council decided to approve the proposed development in accordance with plans and particulars published 15th September 2022.

This project will now hand over to Community Development. The Regeneration & Development Team continue to work with the Community Development section to explore options to progress the next stage of Detailed Design to deliver the project on site.

2.5 Other

The Regeneration and Development Team continue to engage in other regeneration related work areas and support other sections of Donegal County Council as required and across a number of other activities.
