**NOTICE OF INTENTION TO INCLUDE PROVISION TO PRESERVE **WEST SIDE OF BALLYHIERNAN BEACH** PUBLIC RIGHT OF WAY IN THE COUNTY DONEGAL DEVELOPMENT PLAN 2024-2030**

**TAKE NOTICE** that:

1. Donegal County Council being the Planning Authority for the County of Donegal proposes in accordance with Section 14 of the Planning and Development Act 2000 (As Amended), to include in the County Donegal Development Plan 2024-2030, a provision to preserve the **West Side of Ballyhiernan Beach** Public Right of Way identified in the attached Map, which Map forms part of this Notice.
2. Only landowners and occupiers of lands over which the route of the public right of way has been identified can make written submissions or observations to the Planning Authority regarding the proposal **by 17<sup>th</sup> November, 2023** and such submissions or observations shall be taken into consideration by the Planning Authority.
