TEMPORARY CLOSING OF ROADS**

L-1522-1/2 Trentagh Road

Notice is hereby given that Donegal County Council intends to make an Order to have the following road closed to traffic on the dates indicated to facilitate Watermain Upgrade Works

27th May 2024 - 18th October 2024

Route to be closed:

The Trentagh Road L-1522-1 / 2 will be closed to traffic between the 27th May and 18th October 2024 for watermains upgrade works between Drumcavanny Crossroads and Trentagh Presbyterian Church. The works will be carried out in phases and the following diversions will be in place:

Alternative Route:

Phase 1, 2 & 3 Drumcavanny Crossroads to Trentagh Presbyterian Church - 27th May - 18th October 2024

All large vehicles and HGV's are diverted Kilmacrenan to Churchill and Churchill to Kilmacrenan, via N56-73, 74, 75, 76, 77, 78, 79, 80 & 81, R250 Neil T Blaney Road, R250 Paddy Harte Road, R250 Pearse Road, R250-2,3, 4 & 5, R251-1, 2, 3 & 4.

Phase 1 & Phase 2 – Drumcavanny Crossroads – Trentagh Crossroads - Monday 27th May – Friday 6th September 2024

Local Diversion will be in place for local traffic only travelling:

Templedouglass to Kilmacrenan via L-61422-0 Ballybolauder, L-6162-1 Sockar to Rathdonnell, L-1512-4 / 3 Rathdonnell to Trentagh Crossroads.

Kilmacrenan to Templedouglass via L-1512-3 / 4 Trentagh Crossroads to Rathdonnell, L-6162-1 Rathdonnell to Sockar, L-6142-1 Sockar to Drumcavanny Crossroads.

Phase 3 – Trentagh Crossroads – Trentagh Presbyterian Church - Monday 9th September - 18th October 2024

Local Diversion will be in place for local traffic only travelling:

Trentagh to Kilmacrenan via L-1512-3/4/5 Trentagh Crossroads via Rathdonnell to Claremans Crossroads, L-6052-2/1 Claremans Crossroads to Legnahoor Crossroads, L-6012-1/2 Legnahoor via Kennaghan onto N56.

Kilmacrenan to Trentagh via L-6052-1 Dromore Crossroads to Legnahoor Crossroads, L-6052-1/2 Legnahoor Crossroads to Claremans Crossroads, L-1512-5/4/3 Claremans Crossroads via Rathdonnell to Trentagh Cross Roads.

Persons wishing to object to the closure should submit objections in writing to the Roads & Transportation Section, Donegal County Council, County House, Lifford before **4.30pm Tuesday 30th April 2024.**

In the event of objections being made to the granting of proposed road closures, the Council reserves the right to make the details of the objections available to the licence applicant where it considers it necessary in order to fully consider the validity of any of the objections received.
