

SECTION 57 DECLARATION Application Form

PLANNING AND DEVELOPMENT ACT, 2000 (as amended)

The above Act provides that any works which would affect the character of a protected structure, or a proposed protected structure will require planning permission, even where those works would normally be exempted under Section 4(1) (h) of the 2000 Act.

As an owner or occupier of a protected structure you are entitled under the above Act to make a written request to the Planning Authority to issue a declaration as to the type of works which it considers would or would not materially affect the character of the structure or of any element (as set out in Section 57(3) of the Planning and Development Act 2000 (as amended)) of that structure.

- 1. **Site Location Map** Application shall be accompanied by 1 copy of site location map to the scale of 1:1000 clearly identifying the structure and boundaries to which the application refers (subject structure to be outlined in red, overall land holding to be outlined in blue).
- 2. This application may be accompanied by additional drawings, plans, photos etc. which might facilitate the issuing of the declaration. See example documents below.
 - **Site layout plan** (Site or layout plans shall be drawn to a scale (which shall be indicated thereon) of not less than 1:500 or such other scale as may be agreed with the planning authority prior to the submission of the application, the site boundary shall be clearly delineated in red).
 - **Elevations** (if applicable) (plans, elevations and sections drawn to a scale of not less than **1:200**).
 - **Other details** (e.g. landowner consent (if applicable), photographs as appropriate).
