PROPOSED BYE-LAWS

Donegal County Council in exercise of its powers under Section 6 of the Casual Trading Act, 1995 hereby makes the following Bye-Laws for the purposes of designating Casual Trading Areas in Killybegs and containing other incidental and ancillary provisions.

Definitions

á,

1. (a) In these Bye-Laws, the following definitions shall apply:-

"The General Bye-Laws" mean the Donegal County Council (Casual Trading) Bye-Laws 2003 (or the Donegal County Council (Casual Trading) General Bye-Laws 2004 – this should be inserted instead if the 2004 General Bye-Laws are made before these Killybegs Bye-Laws).

"(The) Map1" means the map annexed to these Bye-Laws bearing reference "Casual Trading Area for Killybegs - 2004 (Map1)".

"(The) Map2" means the map annexed to these Bye-Laws bearing reference "Casual Trading Area for Killybegs – 2004 (Map2)".

(b) Other words, terms and expressions defined in the Act and the General Bye-Laws will have the same meaning in these Bye-Laws.

2 Designation of Land as Casual Trading Area

- (a) The Council hereby designates the following land in its functional area as places where casual trading may be carried on:
 - (i) That part of the Shore Road Car Park, Shore Road Killybegs which land is more particularly described and delineated on map1 and thereon coloured yellow and
 - (ii) That part of the roadside along the Shore Road, Killybegs in front of lands owned by the Department of the Marine, known as the Harbour Centre which land is more particularly described and delineated on map 2 and thereon coloured red.
- (b) (i) The casual trading area designated at paragraph (a(i)) of this Bye-Law incorporates twenty (20) individual trading spaces each measuring 5m. long x 2.5m. wide as shown on the enlargement section of map 1 and
 - (ii) The casual trading area designated at paragraph (a(ii)) of this Bye-Law incorporates one (1) individual trading space measuring 5m. long x 2.5m wide as shown on the enlargement section of map 2.

	Each of the said trading spaces constitutes the maximum area that may be occupied by the holder of the licence granted for that space during trading hours.
	Casual Trading licences granted by the Council in accordance with Section 4 (1) (a) (ii) of the Act in respect of the Casual Trading Area designated at paragraph 2(a(i) of these Bye-Laws and more particularly described and delineated on map1 will be limited to Thursdays, Fridays and Saturdays (or one or more of those days) between the hours of 9.00 a.m. to 6.00 p.m. and
* (b)	Casual Trading licences granted by the Council in accordance with Section 4 (1) (a) (ii) of the Act in respect of the Casual Trading Area designated at paragraph 2(a(ii) of these Bye-Laws and more particularly described and delineated on map 2 will be limited to Mondays to Saturdays (or one or more of those days) between the hours of 9.00 a.m. to 6.00 p.m
5 R	estrictions on trading in the casual trading area as identified in map 2
	A person engaged in casual trading in the casual trading area identified in map 2:
	(i) Shall only engage in casual trading fronting onto the public footpath
	(ii) Shall only trade in the goods specified in the Licence, which shall be limited to raw (fresh) fish.
	These Bye-Laws shall be known as the Donegal County Council (Killybegs Designated Casual Trading Areas) Bye-Laws, 2004 and shall come into operation on the _13th day of ,FEBRUARY 2004.
